BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. Minnesota Statutes 2016, section 121A.15, subdivision 3, is amended to read: 1.5 Subd. 3. Exemptions from immunizations.
