1.1 A bill for an act

relating to health; establishing a pilot project for genetic marker testing.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. GENETIC MARKER TESTING PILOT PROGRAM.

Subdivision 1. Establishment. The commissioner of management and budget in collaboration with the commissioner of health shall establish a genetic marker testing pilot program. The commissioner of management and budget shall enlist volunteers from the state employees group insurance plan (SEGIP) to participate in the program. Minnesota Management and Budget shall oversee the administrative aspects of the program. The program is intended to refine the understanding of disease onset and progression, treatment response, and health outcomes through more precise measurement of genetic factors that contribute to health and disease.

Subd. 2. **Program design.** (a) Between 2,500 and 5,000 participants shall be selected from enrollees in the Blue Cross Blue Shield Advantage plan pool under SEGIP. One-third of the participants shall be randomly selected. The program shall be conducted over a four-year period. All participation in the program is voluntary.

(b) The commissioner of management and budget shall partner with Mayo Clinic Biobank to collect and store biospecimens from all program participants. Mayo Clinic Biobank shall utilize its established privacy, security, and systems protocols and protections for this pilot program. Mayo Clinic shall partner with the University of Minnesota to develop and oversee the scientific study details, testing components, and selection of participants. Mayo Clinic
