A bill for an act relating to human services; establishing a mobile food shelf grant program; appropriating money. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: Section 1. MOBILE FOOD SHELF GRANTS. Subdivision 1. Grant amount. Hunger Solutions shall award grants on a priority basis under subdivision 3. A grant to sustain an existing mobile program shall not exceed \$25,000. A grant to create a new mobile program shall not exceed \$75,000. Subd. 2. Application contents. An applicant for a grant under this section must provide the following information to Hunger Solutions: (1) the location of the project; (2) a description of the mobile program, including the program's size and scope; (3) evidence regarding the unserved or underserved nature of the community in which the project is to be located; (4) evidence of community support for the project; (5) the total cost of the project;
