1.8	Subdivision 1. Definitions. (a) For purposes of this section, the following terms
1.9	have the meanings given, unless the context clearly requires otherwise.
1.10	(b) "Federal poverty guidelines" means the federal poverty guidelines published by
1.11	the United States Department of Health and Human Services most recently before the day
1.12	on which each grant is awarded under this section.
1.13	(c) "Internal Revenue Code" means the Internal Revenue Code of 1986, as amended.
1.14	(d) "Medical provider" means a physician, licensed under Minnesota Statutes,
1.15	chapter 147, or a primary care provider as defined in Minnesota Statutes, section 148.171,
1.16	subdivision 17a.
1.17	(e) "Qualified modifications or improvements" means modifications or improvements
1.18	to accommodate a qualified person that are made to a homeowner's principal residence, as
1.19	defined in section 121 of the Internal Revenue Code. The residence must be located in
1.20	Minnesota. A qualified modification or improvement must:
1.21	(1) consist of one or more of the following:
1.22	(i) no-step exterior entrances;
1.23	(ii) exterior or interior ramps;

2.29	Subd. 2. Grants; eligibility. The commissioner of the Minnesota Housing Finance				
2.30	Agency shall provide grants to homeowners for qualified modifications and improvements				
2.31	to accommodate qualified persons. The grants shall be available to homeowners				
2.32	whose annual income is less than 450 percent of the federal poverty guidelines. The				
2.33	homeowner must provide documentation from a medical provider that modifications and				
2.34	improvements are necessary to accommodate the qualified person.
