## A bill for an act 1.1 relating to taxation; lawful gambling taxes; modifying the calculation of the 1.2 combined net receipts tax; amending Minnesota Statutes 2016, section 297E.02, 13 subdivision 6. 1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.5 Section 1. Minnesota Statutes 2016, section 297E.02, subdivision 6, is amended to read: 1.6 Subd. 6. Combined net receipts tax. (a) In addition to the taxes imposed under 1.7 subdivision 1, a tax is imposed on the combined net receipts of the organization. As used 1.8 in this section, "combined net receipts" is the sum of the organization's gross receipts from 1.9 lawful gambling less gross receipts directly derived from the conduct of paper bingo, raffles, 1.10 and paddlewheels, as defined in section 297E.01, subdivision 8, and less the net prizes 1.11 actually paid, other than prizes actually paid for paper bingo, raffles, and paddlewheels, and 1.12 less the amounts actually expended for lawful purpose contributions under section 349.12, 1.13 subdivision 25, paragraph (a), clauses (1) to (7) and (9) to (26), for the fiscal year.
