1.7	Subd. 4. Licensure requirements. An applicant for licensure under this section
1.8	shall submit to the commissioner on a form provided by the commissioner:
1.9	(1) proof that the applicant is over the age of 18;
1.10	(2) the type of license the applicant is applying for;
1.11	(3) all fees required under section 146B.10;
1.12	(4) proof of completing a minimum of 200 hours of supervised experience within
1.13	the each area for which the applicant is seeking a license, and must include an affidavit
1.14	from the supervising licensed technician;
1.15	(5) proof of having satisfactorily completed coursework within the year preceding
1.16	application and approved by the commissioner on bloodborne pathogens, the prevention
