HUMAN SERVICES FINANCING REFORM TASK FORCE. 1.5 Subdivision 1. Establishment; purpose. There is established the Human Services 1.6 Financing Reform Task Force for the Department of Human Services. The purpose of the 1.7 task force is to: 1.8 (1) analyze total human services funding by the state and counties since 2000; and 1.9 (2) make recommendations to the commissioner of human services and the legislature 1.10 on options for creating a financing framework for state and county support, health, and 1.11 social services programs that promotes transparency, equitable resource allocation that takes 1.12 into consideration relative tax capacity, and a sustainable system of services focused on 1.13 positive outcomes for Minnesota residents. 1.14 1.15 Subd. 2. **Members.** (a) The task force must consist of: (1) two members of the house of representatives, one appointed by the speaker of the 1.16 1.17 house and one appointed by the minority leader; (2) two members of the senate, one appointed by the majority leader and one appointed 1 18 by the minority leader; 1.19

(3) the commissioner of human services, or the commissioner's designee;

(4) the commissioner of revenue, or the commissioner's designee

3.4	Subd. 6. Report and recommendations. The task force shall report to the chairs and
3.5	ranking minority members of the house of representatives and senate committees with
3.6	jurisdiction over human services policy and finance by July 1, 2018, with recommendations
3.7	to reform human services financing.
3.8	Subd. 7. Expiration. The task force expires December 31, 2018, unless extended by the
3.9	legislature.
3.10	EFFECTIVE DATE. This section is effective the day following final enactment.
