(2) "Advertising" or "advertisement" does not include any of the following: 3.1 (i) any printing or writing used on buildings, uniforms, or badges, where the purpose of 3.2 the writing is for identification; or 3.3 (ii) any printing or writing in a memorandum or other communication used in the ordinary 3.4 course of business where the sole purpose of the writing is other than soliciting business 3.5 for veterans benefits appeal services. 3.6 (c) "Veterans benefits appeal services" means services that a veteran might reasonably 3.7 require in order to appeal a denial of federal or state veterans benefits, including but not 3.8 limited to denials of disability, limited income, home loan, insurance, education and training, 3.9 burial and memorial, and dependent and survivor benefits. 3.10 (d) "Veterans benefits services" means services that a veteran or a family member of a 3.11 veteran might reasonably use in order to obtain federal, state, or county veterans benefits. 3.12 (e) "Written disclosure statement" means the written disclosure statement developed by 3.13 the commissioner of veterans affairs pursuant to section 196.05, subdivision 1. 3.14 Subd. 2. A person advertising veterans benefits 3.15 appeal services must conspicuously disclose in the advertisement, in similar type size or 3.16 voice-over, that veterans benefits appeal services are also offered at no cost by county 3.17 veterans service officers under sections 197.603 and 197.604. 3.18 3.19 Subd. 3. Veterans benefits services disclosure requirements. A person who provides veterans benefits services in exchange for compensation shall provide a written disclosure 3.20 statement to each client or prospective client. Before a person enters into an agreement to 3.21 provide veterans benefits services or accepts money or any other thing of value for the 3.22 provision of veterans benefits services, the person must obtain the signature of the client 3.23 on a written disclosure statement containing an attestation by the client that the client has 3.24 read and understands the written disclosure statement. 3.25 Subd. 4. Violations; penalties. A person who fails to comply with this section is subject 3.26 to a civil penalty not to exceed \$1,000 for each violation. Civil penalties shall be assessed 3.27 by the district court in an action initiated by the attorney general. For the purposes of 3.28 computing the amount of each civil penalty, each day of a continuing violation constitutes 3.29 a separate violation. Additionally, the attorney general may accept a civil penalty as 3.30 determined by the attorney general in settlement of an investigation of a violation of this 3.31 section regardless of whether an action has been filed under this section.
