- 1.7 Subdivision 1. **Definitions.** (a) For the purposes of this section, the following terms

1.9 (b) "Child" means a person under 12 years of age.

1.10 (c) "Children's product" means a product primarily designed or intended by a

1.11 manufacturer to be used by or for a child, including any article used as a component of such

a product, but excluding a food, beverage, dietary supplement, pharmaceutical product

- 1.13 or biologic, children's toys that are subject to the most recent version of the American
- 1.14 <u>Society for Testing and Materials F963, Standard Consumer Safety Specification for Toy</u>
- 1.15 Safety, a medical device as defined in the Federal Food, Drug, and Cosmetic Act, United
