1.3 state-aid systems, motor vehicle registration and license plates, record retention,
1.4 motor vehicle dealers, pupil transportation, bicycles, motor vehicle weight and
1.5 equipment, disability parking, drivers' licenses and senior identification cards,
1.6 federal law conformity, agency organization, commercial vehicle regulations,
1.7 railroads, land conveyance, transit and transit planning, operations, and

1.27 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.28 Section 1. Minnesota Statutes 2012, section 160.21, subdivision 6, is amended to read:

1.29 Subd. 6. **Uncompleted subdivisions.** (a) A road authority, including a statutory or
1.30 home rule charter city, may remove snow from unopened or private roads in uncompleted
1.31 subdivisions containing five or more lots, upon adoption of an annual resolution finding
1.32 that the subdivision developer, due to general insolvency or pending foreclosure, is unable
1.33 to maintain the roads and that public safety may be jeopardized if the access of school

2.1 buses, public works vehicles, or authorized emergency vehicles, as defined in section
 2.2 169.011, subdivision 3, is obstructed. Snow removal activities are limited to streets
 2.3 reasonably necessary for access by these buses or vehicles.

2.4 (b) Snow removal under this subdivision does not constitute:

2.5 (1) acceptance of the road from the developer by the road authority for public use;

2.6 (2) the opening of the road to public use; nor

2.7 (3) a use, repair, or maintenance of the road sufficient for the purposes of dedication
 2.8 of roads under section 160.05.

2.9 (c) The road authority may impose a reasonable and proportionate charge on all
 2.10 properties within the subdivision for services provided under this subdivision. These
 2.11 charges, if unpaid, may constitute a lien upon the properties within the subdivision and
 2.12 may be collected as a special assessment as provided by section 429.101 or by charter.

2.13 (d) Where a road has been maintained pursuant to this subdivision, the road authority
 2.14 with jurisdiction over the road, and its officers and employees, are exempt from liability
 2.15 for any tort claim for injury to person or property arising from plowing, maintaining,
 2.16 or otherwise working on the road and from traveling on the road and related to its
 2.17 maintenance or condition. This paragraph does not apply to a claim for injury that is
 2.18 affirmatively caused by a negligent act of the road authority or its officers and employees.

2.19 (e) This subdivision expires May 2, ~~2013~~ 2014.

2.20 **EFFECTIVE DATE.** This section is effective retroactively from May 1, 2013.

2.28 Sec. 3. Minnesota Statutes 2012, section 160.80, subdivision 1a, is amended to read:

2.29 Subd. 1a. **Eligibility criteria for business panels.** (a) To be eligible for a business
 2.30 panel on a logo sign panel, a business establishment must:

2.31 (1) be open for business;

2.32 (2) have a sign on site that both identifies the business and is visible to motorists;

2.33 (3) be open to everyone, regardless of race, religion, color, age, sex, national origin,
 2.34 creed, marital status, sexual orientation, or disability; and

3.4 (b) Gas businesses must provide vehicle services including fuel gas or alternative

3.7 (c) Food businesses must serve at least two meals a day during normal mealtimes
3.8 of breakfast, lunch, and dinner; provide a continuous, staffed food service operation at
3.9 ~~least ten hours a day, seven days a~~ six days per week except holidays as defined in section
3.10 645.44, subdivision 5, and except as provided for seasonal food service businesses;
3.11 provide seating capacity for at least 20 people; provide restroom facilities; provide public
3.12 access to a telephone; and possess any required state or local licensing or approval.

3.13 Seasonal food service businesses must provide a continuous, staffed food service operation

3.20 accommodations for each campsite, provide sanitary facilities and drinking water, and
3.21 possess any required state or local licensing or approval.

3.22 (f) 24-hour pharmacy businesses must be continuously operated 24 hours per day,
3.23 seven days per week, and must have a state-licensed pharmacist present and on duty at
3.24 all times.

3.25 (g) Attractions businesses must have regional significance with the primary purpose
3.26 of providing amusement, historical, cultural, or leisure activities to the public; provide
3.27 restroom facilities and drinking water; possess any required state or local licensing
3.28 approval; and provide adequate bus and vehicle parking accommodations for normal
3.29 attendance.

3.30 ~~(g) (h)~~ Seasonal businesses must indicate to motorists when they are open for business
3.31 by ~~either~~ putting the full months of operation directly on the business panel ~~or by having a~~
3.32 ~~"closed" plaque applied to the business panel when the business is closed for the season.~~

3.33 ~~(h) (i)~~ The maximum distance that an eligible business in ~~Anoka, Carver, Dakota,~~
3.34 ~~Hennepin, Ramsey, Scott, or Washington County~~ an urban area can be located from the
3.35 interchange is: for gas, food, lodging, attraction, and 24-hour pharmacy businesses, ~~one~~

 4.2 ~~pharmacies, three miles; and for camping businesses, ten miles.~~

4.3 ~~(i)~~ (j) The maximum distance that an eligible business in ~~any other county~~ a rural

 4.6 from the interchange shall not exceed three miles in either direction.

4.9 ~~(k)~~ If there is insufficient space on a logo sign panel to display all eligible businesses
 4.10 for a specific type of service, the businesses closest to the interchange have priority over
 4.11 businesses farther away from the interchange.

 4.13 received by the franchise from a fully eligible business, a substantially eligible business
 4.14 may be allowed the space.

4.16 Subd. 2. **Franchises.** The commissioner may, by public negotiation or bid, grant
 4.17 one or more franchises to qualified persons to erect and maintain, on the right-of-way of
 4.18 interstate and controlled-access trunk highways, signs informing the motoring public of
 4.19 gas, food, lodging, camping facilities, attractions, and 24-hour pharmacies. A franchisee
 4.20 shall furnish, install, maintain, and replace signs for the benefit of advertisers who provide
 4.21 gas, food, lodging, camping facilities, attractions, and 24-hour pharmacies for the general
 4.22 public, and lease advertising space on the signs to operators of these facilities.

5.17 Subd. 8. **Special account.** Fees collected by the commissioner under this section
5.18 must be deposited in the state treasury and credited to a special account. Money in the
5.19 account is appropriated to the commissioner to construct, operate, repair, and maintain: (1)
5.20 the parking facilities and the high-occupancy vehicle, (2) managed lanes on I-394, and (3)
5.21 related multimodal and technology improvements that serve users of the parking facilities.

9.7 (a) For a Vietnam veteran who served after July 1, 1961, and before July 1, 1978,
 9.8 in the active military service in a branch of the armed forces of the United States or a
 9.9 nation or society allied with the United States the special plates must bear the inscription
 9.10 "VIETNAM VET." and the letters "V" and "V" with the first letter directly above the
 9.11 second letter and both letters just preceding the first numeral of the special plate number.

 9.13 attack on Pearl Harbor on December 7, 1941, the special plates must bear the inscription
 9.14 "PEARL HARBOR SURVIVOR." and the letters "P" and "H" with the first letter directly
 9.15 above the second letter and both letters just preceding the first numeral of the special
 9.16 plate number.

9.17 (c) For a veteran who served during World War I or World War II, the plates must
 9.18 bear the inscription "WORLD WAR VET." and:

9.19 (1) for a World War I veteran, the characters "W" and "I" with the first character
 9.20 directly above the second character and both characters just preceding the first numeral
 9.21 of the special plate number; or

9.22 (2) for a World War II veteran, the characters "W" and "I" with the first character
 9.23 directly above the second character and both characters just preceding the first numeral of
 9.24 the special plate number.

9.25 (d) For a veteran who served during the Korean Conflict, the special plates must
 9.26 bear the inscription "KOREAN VET." and the letters "K" and "V" with the first letter
 9.27 directly above the second letter and both letters just preceding the first numeral of the
 9.28 special plate number.

9.29 (e) For a combat wounded veteran who is a recipient of the Purple Heart medal, the
 9.30 plates must bear the inscription "COMBAT WOUNDED VET" and have a facsimile or an
 9.31 emblem of the official Purple Heart medal and the letters "C" over "W" with the first letter
 9.32 directly over the second letter just preceding the first numeral of the special plate number.

9.33 A member of the United States armed forces who is serving actively in the military

168.094 ONE-WAY TRIP PERMIT.

Subdivision 1. **Application, fee, requirements.** Whenever a person seeks to operate a motor vehicle or tow a manufactured home owned by a nonresident upon the highways of this state solely for the purpose of transporting it from a point outside the state to another point outside the state, and such vehicle is not otherwise exempt from registration and taxation as provided by law, such owner shall not be required to register the vehicle and pay the tax but in lieu thereof shall apply to the registrar for a one-way trip permit and pay a fee of \$10. Unless such act of transportation also requires approval by the commissioner of transportation as provided in section 169.86, such person may be permitted to proceed with such vehicle into the state, not to exceed 35 miles, to the nearest city wherein a deputy registrar is located before securing such permit. The application for permit shall be in such form and contain such information as the registrar may determine. Any motor vehicle operated under such permit shall carry no load. As used in this section, "person" includes a natural person, firm, copartnership, association, or corporation.

Subd. 2. **Proceeds to highway user fund.** Fees collected pursuant to subdivision 1 shall be paid into the state treasury and credited to the highway user tax distribution fund.

174.24 PUBLIC TRANSIT PARTICIPATION PROGRAM.

Subd. 5. **Method of payment, operating assistance.** Payments for operating assistance under this section from state sources of funds must be made in the following manner:

(a) For payments made from the general fund:

- (1) 50 percent of the total contract amount in or before the first month of operation;
- (2) 40 percent of the total contract amount in or before the seventh month of operation;
- (3) 9 percent of the total contract amount in or before the 12th month of operation; and
- (4) 1 percent of the total contract amount after the final audit.

(b) For payments made from the greater Minnesota transit account:

- (1) 50 percent of the total contract amount in or before the seventh month of operation; and
- (2) 50 percent of the total contract amount in or before the 11th month of operation.
