1.16	resources for public waters. Restoration or replacement orders may be recorded or filed in
1.17	the office of the county recorder or registrar of titles, as appropriate, in the county where
1.18	the real property is located by the commissioner of natural resources, conservation officers,
1.19	or peace officers as a deed restriction on the property that runs with the land and is binding
1.20	on the owners, successors, and assigns until the conditions of the order are met or the order
