1.5	Section 1. FEDERAL FUNDS; APPROPRIATION.
1.6	Subdivision 1. Suspension of statutory appropriation. The appropriation in Minnesota
1.7	Statutes, section 4.07, subdivision 3, does not apply to \$ of federal funds for COVID-19
1.8	from the Elementary and Secondary School Emergency Relief Fund's state educational
1.9	agency reserve received by the state of Minnesota between December 26, 2020, and June
1.10	30, 2023, for which an appropriation in this section is an eligible expenditure. Federal
1.11	funding to which this section applies must not be used for any other purpose.
1.12	Subd. 2. Appropriation. \$ in fiscal year 2021 is appropriated from the federal fund
1.13	to the commissioner of education to support school districts that have provided in-person
1.14	instruction during the 2020-2021 school year as of December 31, 2020. The commissioner
1.15	must allocate the appropriation in this subdivision to each eligible school district in an
1.16	amount equal to the total appropriation multiplied by the ratio of an eligible school district's
1.17	fiscal year 2021 average daily membership divided by the total fiscal year 2021 average
1.18	daily membership of all eligible school districts. The commissioner must use the estimated
1.19	average daily membership from the November 2020 forecast for the funding allocation
1.20	under this subdivision. This appropriation is available until September 30, 2023. This is a
1.21	onetime appropriation.
1.22	Subd. 3. Use. A school district must use funding received under subdivision 2 for costs
