8.25	inactive status if the following conditions are met:
8.26	(1) the association makes a written request for inactive status;
8.27	(2) the association has filed all periodic reports required by this chapter and
8.28	has received no contributions into its political fund and made no expenditures or
8.29	disbursements, including disbursements for electioneering communications, through its
8.30	political fund since the last date included on the association's most recent report; and
8.31	(3) the association has satisfied all obligations to the state for late filing fees and civil
8.32	penalties imposed by the board or the board has waived this requirement.
8.33	Subd. 2. Effect of voluntary inactive status. After an association has complied

 9.17 within 14 days of the date that it has accepted contributions or made expenditures,

 9.20 inactive status. If, after meeting this threshold, the association does not notify the board

may, if not prohibited by other law, contribute its general treasury money to an
independent expenditure or ballot question political committee or fund, including its
own independent expenditure or ballot question political committee or fund, without
complying with subdivision 13.

(b) Before the day when the recipient committee or fund's next report must be 10.6 filed with the board under section 10A.20, subdivision 2 or 5, an association that 10.7 has contributed more than \$5,000 in aggregate to independent expenditure political 10.8 committees or funds during the calendar year or has contributed more than \$5,000 in 10.9 aggregate to ballot question political committees or funds during the calendar year must 10.10 provide in writing to the recipient's treasurer a statement that includes the name, address, 10.11 and amount attributable to each person that paid the association dues or fees, or made 10.12 donations to the association that, in total, aggregate more than \$5,000 of the contribution 10.13 from the association to the independent expenditure or ballot question political committee 10.14 or fund. The statement must also include the total amount of the contribution attributable 10.15 to persons not subject to itemization under this section. The statement must be certified as 10.16 true by an officer of the donor association. 10.17

(c) To determine the amount of membership dues or fees, or donations made by a
 person to an association and attributable to the association's contribution to the independent
 expenditure or ballot question political committee or fund, the donor association must:

10.21 (1) apply a pro rata calculation to all unrestricted dues, fees, and contributions
10.22 received by the donor association in the calendar year; or

(2) as provided in paragraph (d), identify the specific individuals or associations
whose dues, fees, or contributions are included in the contribution to the independent
expenditure political committee or fund.

(d) Dues, fees, or contributions from an individual or association must be identified
in a contribution to an independent expenditure political committee or fund under
paragraph (c), clause (2), if:

10.29 (1) the individual or association has specifically authorized the donor association to
