1.1 A bill for an act

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. APPROPRIATIONS; BRIDGES RENTAL ASSISTANCE.

\$1,000,000 in fiscal year 2020 and \$1,000,000 in fiscal year 2021 are appropriated from the general fund to the commissioner of the Housing Finance Agency for the rental housing assistance program for persons with a mental illness or families with an adult member with a mental illness under Minnesota Statutes, section 462A.2097. This appropriation is added to the base.
