- 1.13 Section 1. Minnesota Statutes 2022, section 13.43, subdivision 6, is amended to read:
- 1.14 Subd. 6. **Access by labor organizations.** (a) Personnel data ~~may~~ must be disseminated
- 1.15 to labor organizations to the extent that the responsible authority determines that the
- 1.16 dissemination is necessary to conduct elections, notify employees of fair share fee
- 1.17 assessments, investigate and process grievances, and implement the provisions of chapters
- 1.18 179 and 179A. Personnel data shall be disseminated to labor organizations and to the Bureau
- 1.19 of Mediation Services to the extent the dissemination is ordered or authorized by the
- 1.20 commissioner of the Bureau of Mediation Services. Employee Social Security numbers are
- 1.21 not necessary to implement the provisions of chapters 179 and 179A.
- 1.22 (b) Personnel data described under section 179A.07, subdivision 8, must be disseminated
- 1.23 to an exclusive representative under the terms of that subdivision.
- 1.24 (c) An employer who disseminates personnel data to a labor organization pursuant to
- 1.25 this subdivision shall not be subject to liability under section 13.08. Nothing in this paragraph
- 1.26 shall impair or limit any remedies available under section 325E.61.

2.1 (d) The home addresses, nonemployer issued phone numbers and email addresses, dates
2.2 of birth, and emails or other communications between exclusive representatives and their
2.3 members, prospective members, and nonmembers are private data on individuals.

2.4 Sec. 2. **[16A.1335] EMPLOYEE SALARIES AND BENEFITS IN EVENT OF STATE**
2.5 **GOVERNMENT SHUTDOWN.**

2.6 Subdivision 1. **Definition.** As used in this section, "government shutdown" means that,
2.7 as of July 1 of an odd-numbered year, legislation appropriating money for the general
2.8 operations of (1) an executive agency, (2) an office or department of the legislature, including
2.9 each house of the legislature and the Legislative Coordinating Commission, or (3) a judicial
2.10 branch agency or department, including a court, has not been enacted for the biennium
2.11 beginning July 1 of that year.

2.12 Subd. 2. **Payment required.** Notwithstanding section 16A.17, subdivision 8, state
2.13 employees must be provided payment for lost salary and benefits resulting from their absence
2.14 from work during a government shutdown. An employee is eligible for a payment under
2.15 this section only upon the employee's return to work.

2.16 Subd. 3. **Appropriation; limitation.** (a) In the event of a government shutdown, the
2.17 amount necessary to pay the salary and benefits of employees of any impacted agency,
2.18 office, or department is appropriated beginning on that July 1 to that agency, office, or
2.19 department. The appropriation is made from the fund or funds from which an appropriation
2.20 was made in the previous fiscal year for salary and benefits paid to each affected employee.

2.21 (b) Amounts appropriated under this subdivision may not exceed the amount or amounts
2.22 appropriated for general operations of the affected agency, office, or department in the
2.23 previous fiscal year.

2.24 Subd. 4. **Certification of amount for employees in the legislative and judicial**
2.25 **branches.** By June 25 of an odd-numbered year, if a government shutdown appears
2.26 imminent, the director of the Legislative Coordinating Commission, the chief clerk of the
2.27 house of representatives, the secretary of the senate, and the chief clerk of the supreme court
2.28 must each certify to the commissioner of management and budget the amount needed for
2.29 salaries and benefits for each fiscal year of the next biennium, and the commissioner of
2.30 management and budget shall make the certified amount available on July 1 of that year,
2.31 or on another schedule that permits payment of all salary and benefit obligations required
2.32 by this section in a timely manner.

3.1 Subd. 5. **Subsequent appropriations.** A subsequent appropriation to the agency, office,
 3.2 or department for regular operations for a biennium in which this section has been applied
 3.3 may only supersede and replace the appropriation provided by subdivision 3 by express
 3.4 reference to this section.

3.5 Sec. 3. Minnesota Statutes 2022, section 120A.414, subdivision 2, is amended to read:

3.6 Subd. 2. **Plan.** A school board, including the board of a charter school, may adopt an
 3.7 e-learning day plan after ~~consulting~~ meeting and negotiating with the exclusive representative
 3.8 of the teachers. ~~A~~ If a charter school's teachers are not represented by an exclusive
 3.9 representative, the charter school may adopt an e-learning day plan after consulting with
 3.10 its teachers. The plan must include accommodations for students without Internet access at
 3.11 home and for digital device access for families without the technology or an insufficient
 3.12 amount of technology for the number of children in the household. A school's e-learning
 3.13 day plan must provide accessible options for students with disabilities under chapter 125A.

3.15 Subd. 5. **Limitations on license.** (a) A Tier 1 license is limited to the content matter
 3.16 indicated on the application for the initial Tier 1 license under subdivision 1, clause (2), and
 3.17 limited to the district or charter school that requested the initial Tier 1 license.

3.18 (b) A Tier 1 license does not bring an individual within the definition of a teacher for
 3.19 purposes of section 122A.40, subdivision 1, or 122A.41, subdivision 1, clause (a).

3.20 ~~(c) A Tier 1 license does not bring an individual within the definition of a teacher under~~
 3.21 ~~section 179A.03, subdivision 18.~~

3.22 Sec. 5. Minnesota Statutes 2022, section 122A.26, subdivision 2, is amended to read:

3.23 Subd. 2. **Exceptions.** (a) A person who teaches in a community education program
 3.24 ~~which~~ that qualifies for aid pursuant to section 124D.52 shall continue to meet licensure
 3.25 requirements as a teacher. A person who teaches in an early childhood and family education
 3.26 program ~~which~~ that is offered through a community education program and which qualifies
 3.27 for community education aid pursuant to section 124D.20 or early childhood and family
 3.28 education aid pursuant to section 124D.135 shall continue to meet licensure requirements
 3.29 as a teacher. A person who teaches in a community education course ~~which~~ that is offered
 3.30 for credit for graduation to persons under 18 years of age shall continue to meet licensure

4.10 Subd. 5. **Probationary period.** (a) The first three consecutive years of a teacher's first
 4.11 teaching experience in Minnesota in a single district is deemed to be a probationary period
 4.12 of employment, and, the probationary period in each district in which the teacher is thereafter
 4.13 employed shall be one year. The school board must adopt a plan for written evaluation of
 4.14 teachers during the probationary period that is consistent with subdivision 8. Evaluation
 4.15 must occur at least three times periodically throughout each school year for a teacher
 4.16 performing services during that school year; the first evaluation must occur within the first
 4.17 90 days of teaching service. Days devoted to parent-teacher conferences, teachers' workshops,
 4.18 and other staff development opportunities and days on which a teacher is absent from school
 4.19 must not be included in determining the number of school days on which a teacher performs
 4.20 services. Except as otherwise provided in paragraph (b), during the probationary period any
 4.21 annual contract with any teacher may or may not be renewed as the school board shall see
 4.22 fit. However, the board must give any such teacher whose contract it declines to renew for
 4.23 the following school year written notice to that effect before July 1. If the teacher requests
 4.24 reasons for any nonrenewal of a teaching contract, the board must give the teacher its reason
 4.25 in writing, including a statement that appropriate supervision was furnished describing the
 4.26 nature and the extent of such supervision furnished the teacher during the employment by
 4.27 the board, within ten days after receiving such request. The school board may, after a hearing
 4.28 held upon due notice, discharge a teacher during the probationary period for cause, effective
 4.29 immediately, under section 122A.44.

4.30 (b) A board must discharge a probationary teacher, effective immediately, upon receipt
 4.31 of notice under section 122A.20, subdivision 1, paragraph (b), that the teacher's license has
 4.32 been revoked due to a conviction for child abuse or sexual abuse.

4.33 (c) A probationary teacher whose first three years of consecutive employment are
 4.34 interrupted for active military service and who promptly resumes teaching consistent with

5.1 federal reemployment timelines for uniformed service personnel under United States Code,
 5.2 title 38, section 4312(e), is considered to have a consecutive teaching experience for purposes
 5.3 of paragraph (a).

5.4 (d) A probationary teacher whose first three years of consecutive employment are
 5.5 interrupted for maternity, paternity, or medical leave and who resumes teaching within 12
 5.6 months of when the leave began is considered to have a consecutive teaching experience
 5.7 for purposes of paragraph (a) if the probationary teacher completes a combined total of
 5.8 three years of teaching service immediately before and after the leave.

5.9 (e) A probationary teacher must complete at least ~~120~~ 90 days of teaching service each
 5.10 year during the probationary period. Days devoted to parent-teacher conferences, teachers'
 5.11 workshops, and other staff development opportunities and days on which a teacher is absent
 5.12 from school do not count as days of teaching service under this paragraph.

5.14 Subd. 2. **Probationary period; discharge or demotion.** (a) ~~All teachers in the public~~

6.7 of paragraph (a).

6.8 (c) A probationary teacher whose first three years of consecutive employment are

6.10 months of when the leave began is considered to have a consecutive teaching experience
6.11 for purposes of paragraph (a) if the probationary teacher completes a combined total of
6.12 three years of teaching service immediately before and after the leave.

6.13 (d) A probationary teacher must complete at least ~~120~~ 90 days of teaching service each
6.14 year during the probationary period. Days devoted to parent-teacher conferences, teachers'

6.18 Subd. 14. **Public employee or employee.** (a) "Public employee" or "employee" means
6.19 any person appointed or employed by a public employer except:

6.20 (1) elected public officials;

6.21 (2) election officers;

6.22 (3) commissioned or enlisted personnel of the Minnesota National Guard;

6.23 (4) emergency employees who are employed for emergency work caused by natural
6.24 disaster;

6.25 (5) part-time employees whose service does not exceed the lesser of 14 hours per week
6.26 or 35 percent of the normal work week in the employee's appropriate unit;

6.27 (6) employees whose positions are basically temporary or seasonal in character and: (i)
6.28 are not for more than 67 working days in any calendar year; ~~or~~ (ii) are not working for a
6.29 Minnesota school district or charter school; or (iii) are not for more than 100 working days
6.30 in any calendar year and the employees are under the age of 22, are full-time students
6.31 enrolled in a nonprofit or public educational institution prior to being hired by the employer,

7.6 (8) employees of charitable hospitals as defined by section 179.35, subdivision 3, except
 7.7 that employees of charitable hospitals as defined by section 179.35, subdivision 3, are public
 7.8 employees for purposes of sections 179A.051, 179A.052, and 179A.13;

7.9 (9) full-time undergraduate students employed by the school which they attend under a
 7.10 work-study program or in connection with the receipt of financial aid, irrespective of number
 7.11 of hours of service per week;

7.12 (10) an individual who is employed for less than 300 hours in a fiscal year as an instructor
 7.13 in an adult vocational education program;

7.14 ~~(11) an individual hired by the Board of Trustees of the Minnesota State Colleges and~~
 7.15 ~~Universities to teach one course for three or fewer credits for one semester in a year;~~

7.16 ~~(12)~~ (11) with respect to court employees:

7.17 (i) personal secretaries to judges;

7.18 (ii) law clerks;

7.19 (iii) managerial employees;

7.24 (b) The following individuals are public employees regardless of the exclusions of

 7.27 State Colleges and Universities except at the university established in the Twin Cities
 7.28 metropolitan area under section 136F.10 or for community services or community education
 7.29 instruction offered on a noncredit basis: (i) to replace an absent teacher or faculty member
 7.30 who is a public employee, where the replacement employee is employed more than 30
 7.31 working days as a replacement for that teacher or faculty member; or (ii) to take a teaching

8.14 Subd. 18. **Teacher.** "Teacher" means any public employee other than a superintendent
8.15 or assistant superintendent, principal, assistant principal, or a supervisory or confidential
8.16 employee, employed by a school district:

8.17 (1) in a position for which the person must be licensed by the Professional Educator
8.18 Licensing and Standards Board or the commissioner of education; ~~or~~

8.19 (2) in a position as a physical therapist, occupational therapist, art therapist, music
8.20 therapist, or audiologist; or

8.21 (3) in a position creating and delivering instruction to children in a prekindergarten or

8.28 Subd. 19. **Terms and conditions of employment.** "Terms and conditions of employment"
8.29 means the hours of employment, the compensation therefor including fringe benefits except
8.30 retirement contributions or benefits other than employer payment of, or contributions to,
8.31 premiums for group insurance coverage of retired employees or severance pay, staffing

9.1 ratios, and the employer's personnel policies affecting the working conditions of the
 9.2 employees. In the case of professional employees the term does not mean educational
 9.3 policies of a school district. "Terms and conditions of employment" is subject to section
 9.4 179A.07. In the case of school employees, "terms and conditions of employment" includes

 9.8 employees have the right to request and be allowed ~~dues checkoff~~ payroll deduction for the
 9.9 exclusive representative. ~~In the absence of an exclusive representative, public employees~~
 9.10 ~~have the right to request and be allowed dues checkoff for the organization of their choice,~~
 9.11 and the political fund associated with the exclusive representative and registered pursuant
 9.12 to section 10A.12. A public employer must rely on a certification from any exclusive
 9.13 representative requesting remittance of a deduction that the organization has and will maintain
 9.14 an authorization, signed by the public employee from whose salary or wages the deduction
 9.15 is to be made, which may include an electronic signature by the public employee as defined
 9.16 in section 325L.02, paragraph (h). An exclusive representative making such certification
 9.17 must not be required to provide the public employer a copy of the authorization unless a
 9.18 dispute arises about the existence or terms of the authorization. The exclusive representative
 9.19 must indemnify the public employer for any successful claims made by the employee for
 9.20 unauthorized deductions in reliance on the certification.

9.21 (b) A dues deduction authorization remains in effect until the employer receives notice
 9.22 from the exclusive representative that a public employee has changed or canceled their
 9.23 authorization in writing in accordance with the terms of the original authorizing document,
 9.24 and a public employer must rely on information from the exclusive representative receiving
 9.25 remittance of the deduction regarding whether the deductions have been properly changed
 9.26 or canceled. The exclusive representative must indemnify the public employer for any
 9.27 successful claims made by the employee for unauthorized deductions made in reliance on
 9.28 such information.

9.29 (c) Deduction authorization under this section is independent from the public employee's
 9.30 membership status in the organization to which payment is remitted and is effective regardless
 9.31 of whether a collective bargaining agreement authorizes the deduction.

9.32 (d) Employers must commence deductions within 30 days of notice of authorization
 9.33 from the exclusive representative and must remit the deductions to the exclusive
 9.34 representative within 30 days of the deduction. The failure of an employer to comply with

10.1 the provisions of this paragraph shall be an unfair labor practice under section 179A.13, the
 10.2 relief for which shall be reimbursement by the employer of deductions that should have
 10.3 been made or remitted based on a valid authorization given by the employee or employees.

10.4 (e) In the absence of an exclusive representative, public employees have the right to
 10.5 request and be allowed payroll deduction for the organization of their choice.

10.6 (f) Any dispute under this subdivision must be resolved through an unfair labor practice
 10.7 proceeding under section 179A.13.

10.9 Subdivision 1. **Inherent managerial policy.** A public employer is not required to meet
 10.10 and negotiate on matters of inherent managerial policy. Matters of inherent managerial
 10.11 policy include, but are not limited to, such areas of discretion or policy as the functions and
 10.12 programs of the employer, its overall budget, utilization of technology, the organizational
 10.13 structure, selection of personnel, and direction ~~and the number~~ of personnel. No public
 10.14 employer shall sign an agreement which limits its right to select persons to serve as
 10.15 supervisory employees or state managers under section 43A.18, subdivision 3, or requires
 10.16 the use of seniority in their selection.

 10.29 by the exclusive representative: name; job title; worksite location, including location within
 10.30 a facility when appropriate; home address; work telephone number; home and personal cell
 10.31 phone numbers on file with the public employer; date of hire; and work email address and
 10.32 personal email address on file with the public employer.

11.1 (b) Every 120 calendar days beginning on January 1, 2024, a public employer must
 11.2 provide an exclusive representative in an Excel file or similar format agreed to by the
 11.3 exclusive representative the following information for all bargaining unit employees: name;
 11.4 job title; worksite location, including location within a facility when appropriate; home
 11.5 address; work telephone number; home and personal cell phone numbers on file with the
 11.6 public employer; date of hire; and work email address and personal email address on file
 11.7 with the public employer.

11.8 (c) A public employer must notify an exclusive representative within ten calendar days
 11.9 of the separation of employment or transfer out of the bargaining unit of a bargaining unit
 11.10 employee.
