A bill for an act relating to motor vehicles; establishing Minnesota Professional Golfers' Association Foundation special license plates; appropriating money; proposing coding for new law in Minnesota Statutes, chapter 168. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: Section 1. [168.1299] MINNESOTA PROFESSIONAL GOLFERS' ASSOCIATION FOUNDATION PLATES. Subdivision 1. Issuance and design. Notwithstanding section 168.1293, the commissioner shall issue special Minnesota Section Professional Golfers' Association (PGA) Foundation plates or a single motorcycle plate to an applicant who: (1) is a registered owner of a passenger automobile, one-ton pickup truck, motorcycle, or recreational vehicle; (2) pays a fee of \$10 for each set of plates; (3) contributes a minimum of \$30 annually to the Minnesota Section PGA Foundation account; and (4) complies with this chapter and rules governing registration of motor vehicles and licensing of drivers. Subd. 2. Design. After consultation with the Minnesota Section PGA, the commissioner shall design the special plate. The final design of the special plate is subject to the approval of the commissioner, and shall include the Minnesota Section PGA's official logo. Subd. 3. Plates transfer. On payment of a transfer fee of \$5, plates issued under this section may be transferred to another passenger automobile, one-ton pickup truck,

2.3	Subd. 4. Fees. Fees collected under subdivision 1, clause (2), and subdivision 3 are
2.4	credited to the vehicle services operating account in the special revenue fund.
2.5	Subd. 5. Contributions. Contributions collected under subdivision 1, clause (3),
2.6	are credited first to the commissioner of public safety for the cost of administering the
2.7	Minnesota Section PGA Foundation account, which is established in the special revenue
2.8	fund. After the commissioner's administration costs are paid each year, remaining
2.9	contributions are credited to the Minnesota Section PGA Foundation account. Money in
2.10	the account is appropriated to the commissioner of public safety for distribution to the
2.11	Minnesota Section PGA Foundation, to be used to promote the game of golf through
2.12	programs and to provide financial assistance to help further the education of worthy
2.13	members of the Minnesota Section PGA Junior Golf Program and PGA member facilities.
2.14	EFFECTIVE DATE. This section is effective January 1, 2014, for special
2.15	Minnesota Section PGA Foundation plates issued on or after that date.
