1.5	Section 1. CIVIL UNREST IMMEDIATE RELIEF PROGRAM.
1.6	Subdivision 1. Definitions. (a) For the purposes of this section, the following terms have

1.8	(b) "Commissioner" means the commissioner of employment and economic development.
