[126C.90] COMPREHENSIVE SUPPORT FOR SCHOOLS IN NEED. 1.7 Subdivision 1. Qualifying site. An elementary school site identified as in need of 1.8 comprehensive support under Minnesota's plan implementing the Every Student Succeeds 1.9 Act must meet the requirements of this section to be eligible for additional state aid according 1.10 to this section. A site remains qualified under this section for seven years. 1.11 Subd. 2. Site-based revenue. The Department of Education must develop a site-based 1.12 revenue model for each school district with an elementary school identified as a qualifying 1.13 site under subdivision 1. A school district must report data in the form and manner required 1.14 by the commissioner. The department may allocate expenditures that are not site specific 1.15 to each site on a proportionate basis. 1.16 Subd. 3. Site-based revenue allocated to school sites. A school district must allocate 1.17 all additional aid received under this section to the site identified as a qualifying school site 1.18 in need. 1.19 Subd. 4. Special education cross subsidy aid. A qualifying school site's special education 1.20 additional cross subsidy aid equals the difference between the site's special education revenue 1.21

for the previous year and the site's qualifying special education expenses for that year.

Subd. 5. English learner cross subsidy aid. A qualifying school site's additional English 2.1 learner cross subsidy aid equals the difference between the site's English learner aid for the 2.2 2.3 previous year and its English learner revenue for that year. Subd. 6. Full-service community school coordinator. Each qualifying school site's 2.4 2.5 full-service community school coordinator aid equals \$150,000 per year. Subd. 7. School social worker aid. (a) Each qualifying school site is eligible for school 2.6 social worker aid. The aid equals the statewide average salary for school social workers for 2.7 the second previous year. Each qualifying school site must receive school social worker aid 2.8 for at least one social worker. 2.9 (b) For each additional 250 pupils served by the school site, the school social worker 2.10 aid must be proportionately increased. 2.11 (c) Aid for school social workers must be spent only on school social workers. 2.12 Subd. 8. School counselor aid. (a) Each qualifying school site is eligible for school 2.13 counselor aid. The aid equals the statewide average salary for licensed school counselors 2.14 for the second previous year. Each qualifying school site must receive school counselor aid 2.15 for at least one school counselor. 2.16 (b) For each additional 250 pupils served by the school site, the school counselor aid 2.17 must be proportionately increased. 2.18 (c) Aid for school counselors must be spent only on licensed school counselors. 2.19 Subd. 9. School library media specialist aid. (a) Each qualifying school site is eligible 2.20 for school library media specialist aid. The aid equals the statewide average salary for 2.21 licensed school library media specialists for the second previous year. Each qualifying 2.22 school site must receive school library media specialist aid for one school library media 2.23 specialist. 2.24 (b) Aid for school library media specialists must be spent only on licensed school library 2.25 media specialists. 2.26 Subd. 10. School book aid. (a) The school library media specialist at each school site 2.27 must work with classroom teachers to develop a collection of at least 20 books for each 2.28 student to take home during the school year and to keep at home for the duration of the 2.29 student's enrollment at the school. 2.30 (b) A school site's school book aid equals \$400 times the number of students served by 2.31 the school site. 2.32

Subd. 11. School nurse aid. (a) Each qualifying school site is eligible for school nurse 3.1 aid. Paraprofessional aid. (a) Each qualifying school site is eligible for aid for 3.6 an additional classroom paraprofessional. School site responsibilities. (a) Each qualifying school site receiving aid 3.23 3.24 under this section must meet the requirements of this subdivision.
