1.7	Subd. 2c. Schedules of rates for individuals, estates, and trusts. (a) The income taxes
1.8	imposed by this chapter upon married individuals filing joint returns and surviving spouses
1.9	as defined in section 2(a) of the Internal Revenue Code must be computed by applying to
1.10	their taxable net income the following schedule of rates:
1.11	(1) On the first <u>\$38,770</u> <u>\$43,950</u> , <u>5.35</u> <u>4.85</u> percent;
1.12	(2) On all over \$38,770 \$43,950, but not over \$154,020 \$174,610, 6.8 6.3 percent;
1.13	(3) On all over <u>\$154,020</u> <u>\$174,610</u> , but not over <u>\$269,010</u> <u>\$304,970</u> , <u>7.85</u> <u>7.35</u> percent;

1.15	Married individuals filing separate returns, estates, and trusts must compute their income

- 3.1 (ii) the subtractions under sections 290.0132, subdivisions 2, 9, 10, 14, 15, 17, 18, 27,
 3.2 and 31, and 290.0137, paragraph (c).
- (f) If an individual who is not a Minnesota resident for the entire year is a qualifying
 owner of a qualifying entity that elects to pay tax as provided in section 289A.08, subdivision
 7a, paragraph (b), the individual must compute the individual's Minnesota income tax as
 provided in paragraph (e), and also must include, to the extent attributed to the electing
 qualifying entity:
- 3.8 (1) in paragraph (e), clause (1), item (i), and paragraph (e), clause (2), item (i), the
 3.9 addition under section 290.0131, subdivision 5; and

3.12 EFFECTIVE DATE. This section is effective for taxable years beginning after December
 3.13 <u>31, 2022.</u>

3.14 Sec. 2. Minnesota Statutes 2022, section 290.06, subdivision 2d, is amended to read:

3.15 Subd. 2d. Inflation adjustment of brackets. The commissioner shall annually adjust the minimum and maximum dollar amounts for each rate bracket for which a tax is imposed 3.16 in subdivision 2c as provided in section 270C.22. The statutory year is taxable year 2019 3.17 2023. The rate applicable to any rate bracket must not be changed. The dollar amounts 3.18 setting forth the tax shall be adjusted to reflect the changes in the rate brackets. The rate 3.19 brackets as adjusted must be rounded to the nearest \$10 amount. If the rate bracket ends in 3.20 \$5, it must be rounded up to the nearest \$10 amount. The commissioner shall determine the 3.21 rate bracket for married filing separate returns after this adjustment is done. The rate bracket 3.22 for married filing separate must be one-half of the rate bracket for married filing joint. 3.23

3.24 EFFECTIVE DATE. This section is effective for taxable years beginning after December 3.25 <u>31, 2022.</u>
