1.7	Subdivision 1. <b>Definitions.</b> (a) For the purposes of this section, the following terms
1.8	have the meanings given them.
1.9	(b) "Commissioner" means the commissioner of commerce.
1.10	(c) "Smart phone" means a cellular phone or other mobile device built on a mobile
1.11	operating system and possessing advanced computing capability. Features a smart phone
1.12	may possess include, but are not limited to, built-in applications, Internet access, digital
1.13	voice service, text messaging, e-mail, and Web browsing.
1.14	(d) "Subscriber identification module" or "SIM card" means a card or other similar
1.15	media that is inserted into a smart phone and used to store data.
1.16	(e) "Wireless telecommunications equipment manufacturer" means any entity that
1.17	manufactures wireless telecommunications devices, including smart phones.
1.18	(f) "Wireless telecommunications service provider" has the meaning given in section
1.19	237.01, subdivision 6, and includes a provider of mobile wireless telecommunications
1.20	service.
1.21	Subd. 2. "Kill switch" required. (a) Any smart phone sold or purchased in
1.22	Minnesota must be equipped with functionality that can render the device completely
1.23	inoperable in the event of theft or loss.
1.24	(b) In order to comply with paragraph (a), any "kill switch" functionality must:
