1.12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.13 ARTICLE 1

1.14 PROPERTY MANAGEMENT

1.15 Section 1. 325E.68 PROPERTY MANAGEMENT.

1.16 Subdivision 1. Definitions. (a) The definitions in this subdivision apply to this section.

1.17 (b) "Firm" means a corporation, partnership, association, or individual firm.

1.18 (c) "Owner" means a person who has any legal or equitable interest in the real property.

1.19 An owner of a common interest community, as defined in chapter 515B, means the unit

1.20 owners' association organized under section 515B.3-101.

1.21 (d) "Person" means an individual, firm, partnership, limited liability company,

1.22 corporation, or association.

1.23 (e) "Property manager" or "property management company" means a person who engages

1.24 in the business of managing real property that is owned by another person.

2.1 Subd. 2. **Interest of property management company in certain firms.** No property  
2.2 manager or property management company having an interest directly or indirectly in a  
2.3 construction firm, salvage firm, or appraisal firm may hire the directly or indirectly owned  
2.4 construction firm, salvage firm, or appraisal firm to perform work on a managed property  
2.5 unless the interest has been disclosed in writing to the owner or owners at least three days  
2.6 prior to the execution of a contract for the work.

2.7 Subd. 3. **Prohibited practices.** No property manager or property management company  
2.8 shall request or accept money, rebates, or anything of value from a construction firm, salvage  
2.9 firm, or appraisal firm as:

2.10 (1) an inducement to refer business or clients to the firm;

2.11 (2) a condition for awarding a contract to the firm;

2.12 (3) part of a fee specified in a contract; or

2.13 (4) fee splitting for services rendered, unless the other person is also a licensed contractor.

2.14 Subd. 4. **Automatic renewal.** A contract between a person and a property manager or  
2.15 property management company having a term exceeding one year must not contain an  
2.16 automatic renewal provision that requires the association to give notice of nonrenewal more  
2.17 than 30 days prior to the contract's anniversary date. The person may terminate a contract  
2.18 with a property manager or property management company for any reason upon 60 days'  
2.19 notice if the contract violates this subdivision.

2.20 Subd. 5. **Certain compensation prohibited.** A property manager or property management  
2.21 company must not be compensated in whole or in part based on the amount of fines collected  
2.22 by the property manager or property management company on behalf of the person and  
2.23 must not collect from the person or owner any fee in connection with its collection of a fine  
2.24 imposed by the association.

2.25 Subd. 6. **Remedies.** If a property manager or property management company violates  
2.26 this section, an owner may bring an action against the property manager or property  
2.27 management company in a court of competent jurisdiction for damages sustained by the  
2.28 owner as a consequence of the property manager's or property management company's  
2.29 violation, together with the actual costs of the action, including reasonable attorney fees.  
2.30 The remedies in this section are in addition to any other remedies permitted by law.

3.1 **ARTICLE 2**

3.2 **COMMON INTEREST COMMUNITIES**

3.3 Section 1. Minnesota Statutes 2024, section 515B.1-102, is amended to read:

3.4 **515B.1-102 APPLICABILITY.**

3.5 (a) Except as provided in this section, this chapter, and not chapters 515 and 515A,  
3.6 applies to all common interest communities created within this state on and after June 1,  
3.7 1994.

3.8 (b) The applicability of this chapter to common interest communities created prior to  
3.9 June 1, 1994, shall be as follows:

3.10 (1) This chapter shall apply to condominiums created under chapter 515A with respect  
3.11 to events and circumstances occurring on and after June 1, 1994; provided (i) that this  
3.12 chapter shall not invalidate the declarations, bylaws or condominium plats of those  
3.13 condominiums, and (ii) that chapter 515A, and not this chapter, shall govern all rights and  
3.14 obligations of a declarant of a condominium created under chapter 515A, and the rights and  
3.15 claims of unit owners against that declarant.

3.16 (2) The following sections in this chapter apply to condominiums created under chapter  
3.17 515: 515B.1-104 (Variation by Agreement); 515B.1-105 (Separate Titles and Taxation);  
3.18 515B.1-106 (Applicability of Local Requirements); 515B.1-107 (Eminent Domain);  
3.19 515B.1-108 (This Chapter Prevails; Supplemental Law); 515B.1-109 (Construction Against  
3.20 Implicit Repeal); 515B.1-112 (Unconscionable Agreement or Term of Contract); 515B.1-113  
3.21 (Obligation of Good Faith); 515B.1-114 (Remedies to be Liberally Administered);  
3.22 515B.1-115 (Notice); 515B.1-116 (Recording); 515B.2-103 (Construction and Validity of  
3.23 Declaration and Bylaws); 515B.2-104 (Description of Units); 515B.2-108(d) (Allocation  
3.24 of Interests); 515B.2-109(f) (Common Elements and Limited Common Elements);  
3.25 515B.2-112 (Subdivision, Combination, or Conversion of Units); 515B.2-113 (Alteration  
3.26 of Units); 515B.2-114 (Relocation of Boundaries Between Adjoining Units); 515B.2-115  
3.27 (Minor Variations in Boundaries); 515B.2-118 (Amendment of Declaration); 515B.2-119  
3.28 (Termination of Common Interest Community); 515B.3-102 (Powers of Unit Owners'  
3.29 Association); 515B.3-103(a), (b), and (g) (Board of Directors, Officers, and Declarant  
3.30 Control); 515B.3-107 (Upkeep of Common Interest Community); 515B.3-108 (Meetings);  
3.31 515B.3-109 (Quorums); 515B.3-110 (Voting; Proxies); 515B.3-111 (Tort and Contract  
3.32 Liability); 515B.3-112 (Conveyance of, or Creation of Security Interests in, Common  
3.33 Elements); 515B.3-113 (Insurance); 515B.3-114 (Replacement Reserves); 515B.3-115(c),  
3.34 (e), (f), (g), (h), and (i) (Assessments for Common Expenses); 515B.3-116 (Lien for

4.1 Assessments); 515B.3-117 (Other Liens); 515B.3-118 (Association Records); 515B.3-119  
 4.2 (Association as Trustee); 515B.3-121 (Accounting Controls); 515B.4-107 (Resale of Units);  
 4.3 515B.4-108 (Purchaser's Right to Cancel Resale); and 515B.4-116 (Rights of Action;  
 4.4 Attorney's Fees). Section 515B.1-103 (Definitions) shall apply to the extent necessary in  
 4.5 construing any of the sections referenced in this section. Sections 515B.1-105, 515B.1-106,  
 4.6 515B.1-107, 515B.1-116, 515B.2-103, 515B.2-104, 515B.2-118, 515B.3-102, 515B.3-110,  
 4.7 515B.3-111, 515B.3-113, 515B.3-116, 515B.3-117, 515B.3-118, 515B.3-121, 515B.4-107,  
 4.8 515B.4-108, and 515B.4-116 apply only with respect to events and circumstances occurring  
 4.9 on and after June 1, 1994. All other sections referenced in this section apply only with  
 4.10 respect to events and circumstances occurring after July 31, 1999. A section referenced in  
 4.11 this section does not invalidate the declarations, bylaws or condominium plats of  
 4.12 condominiums created before August 1, 1999. But all sections referenced in this section  
 4.13 prevail over the declarations, bylaws, CIC plats, rules and regulations under them, of  
 4.14 condominiums created before August 1, 1999, except to the extent that this chapter defers  
 4.15 to the declarations, bylaws, CIC plats, or rules and regulations issued under them.

4.16 (3) This chapter shall not apply to cooperatives and planned communities created prior  
 4.17 to June 1, 1994, or to planned communities that were created on or after June 1, 1994, and  
 4.18 before August 1, 2006, and that consist of more than two but fewer than 13 units; except  
 4.19 by election pursuant to subsection (d), and except that the following sections apply to all  
 4.20 planned communities, townhome associations, and cooperatives regardless of when created,  
 4.21 unless they are exempt under subsection (e): sections 515B.1-116, subsections (a), (c), (d),  
 4.22 and (e); 515B.3-102, subsections (a), paragraphs (1), (3), (11), and (12), (c), and (g);  
 4.23 515B.3-103, subsections (a), (e), paragraph (4), (g), and (h); 515B.3-107, subsections (a),  
 4.24 (d), (e), (f), and (g); 515B.3-115, subsections (e), paragraphs (4) and (5), (g), and (k);  
 4.25 515.3-1151, subsections (e), paragraphs (4) and (5), (g), and (k); 515.3-116, subsections  
 4.26 (a) and (h); 515.3-122; 515B.4-107; and 515B.4-108, apply to all planned communities  
 4.27 and cooperatives regardless of when they are created, unless they are exempt under subsection  
 4.28 (e).

4.29 (c) This chapter shall not invalidate any amendment to the declaration, bylaws or  
 4.30 condominium plat of any condominium created under chapter 515 or 515A if the amendment  
 4.31 was recorded before June 1, 1994. Any amendment recorded on or after June 1, 1994, shall  
 4.32 be adopted in conformity with the procedures and requirements specified by those instruments  
 4.33 and by this chapter. If the amendment grants to any person any rights, powers or privileges  
 4.34 permitted by this chapter, all correlative obligations, liabilities and restrictions contained  
 4.35 in this chapter shall also apply to that person.

5.1 (d) Any condominium created under chapter 515, any planned community or cooperative  
5.2 which would be exempt from this chapter under subsection (e), or any planned community  
5.3 or cooperative created prior to June 1, 1994, or any planned community that was created  
5.4 on or after June 1, 1994, and prior to August 1, 2006, and that consists of more than two  
5.5 but fewer than 13 units, may elect to be subject to this chapter, as follows:

5.6 (1) The election shall be accomplished by recording a declaration or amended declaration,  
5.7 and a new or amended CIC plat where required, and by approving bylaws or amended  
5.8 bylaws, which conform to the requirements of this chapter, and which, in the case of  
5.9 amendments, are adopted in conformity with the procedures and requirements specified by  
5.10 the existing declaration and bylaws of the common interest community, and by any applicable  
5.11 statutes.

5.12 (2) In a condominium, the preexisting condominium plat shall be the CIC plat and an  
5.13 amended CIC plat shall be required only if the amended declaration or bylaws contain  
5.14 provisions inconsistent with the preexisting condominium plat. The condominium's CIC  
5.15 number shall be the apartment ownership number or condominium number originally  
5.16 assigned to it by the recording officer. In a cooperative in which the unit owners' interests  
5.17 are characterized as real estate, a CIC plat shall be required. In a planned community, the  
5.18 preexisting plat or registered land survey recorded pursuant to chapter 505, 508, or 508A,  
5.19 or the part of the plat or registered land survey upon which the common interest community  
5.20 is located, shall be the CIC plat.

5.21 (3) The amendment shall comply with section 515B.2-118(a)(3) and (c); except that the  
5.22 unanimous consent of the unit owners shall not be required for (i) a clarification of the unit  
5.23 boundary description if the clarified boundary description is substantially consistent with  
5.24 the preexisting CIC plat, or (ii) changes from common elements to limited common elements  
5.25 that occur by operation of section 515B.2-109(c) and (d).

5.26 (4) Except as permitted by paragraph (3), no declarant, affiliate of declarant, association,  
5.27 master association nor unit owner may acquire, increase, waive, reduce or revoke any  
5.28 previously existing warranty rights or causes of action that one of said persons has against  
5.29 any other of said persons by reason of exercising the right of election under this subsection.

5.30 (5) A common interest community which elects to be subject to this chapter may, as a  
5.31 part of the election process, change its form of ownership by complying with section  
5.32 515B.2-123.

5.33 (e) Except as otherwise provided in this subsection, this chapter shall not apply, except  
5.34 by election pursuant to subsection (d), to the following:

6.1 (1) a planned community which consists of two units, which utilizes a CIC plat complying  
6.2 with section 515B.2-110(d)(1) and (2), or section 515B.2-1101(d)(1) and (2), which is not  
6.3 subject to any rights to subdivide or convert units or to add additional real estate, and which  
6.4 is not subject to a master association;

6.5 (2) a common interest community that consists solely of platted lots or other separate  
6.6 parcels of real estate designed or utilized for detached single family dwellings or agricultural  
6.7 purposes, with or without common property, where no association or master association  
6.8 has an obligation to maintain any building containing a dwelling or any agricultural building  
6.9 located or to be located on such platted lots or parcels; except that section 515B.4-101(e)  
6.10 shall apply to the sale of such platted lots or parcels of real estate if the common interest  
6.11 community is or will be subject to a master declaration;

6.12 (3) a cooperative where, at the time of creation of the cooperative, the unit owners'  
6.13 interests in the dwellings as described in the declaration consist solely of proprietary leases  
6.14 having an unexpired term of fewer than 20 years, including renewal options;

6.15 (4) planned communities utilizing a CIC plat complying with section 515B.2-110(d)(1)  
6.16 and (2), or section 515B.2-1101(d)(1) and (2), and cooperatives, which are limited by the  
6.17 declaration to nonresidential uses; or

6.18 (5) real estate subject only to an instrument or instruments filed primarily for the purpose  
6.19 of creating or modifying rights with respect to access, utilities, parking, ditches, drainage,  
6.20 or irrigation.

6.21 (f) Section 515B.4-101(e) applies to any platted lot or other parcel of real estate that is  
6.22 subject to a master declaration and is not subject to or is exempt from this chapter.

6.23 (g) Section 515B.1-106 and section 515B.2-118, subsections (a)(5), (a)(7), and (d), shall  
6.24 apply to all common interest communities.

6.25 (h) Sections 515B.1-103(33a), 515B.2-110, 515B.3-105, 515B.3-115, 515B.4-102, and  
6.26 515B.4-115 apply only to common interest communities created before August 1, 2010.  
6.27 Sections 515B.1-103(33b), 515B.2-1101, 515B.3-1051, 515B.3-1151, 515B.4-1021, and  
6.28 515B.4-1151 apply only to common interest communities created on or after August 1,  
6.29 2010.

6.30 (i) Section 515B.3-114 applies to common interest communities only for the association's  
6.31 fiscal years commencing before January 1, 2012. Section 515B.3-1141 applies to common  
6.32 interest communities only for the association's fiscal years commencing on or after January  
6.33 1, 2012.

7.1 (j) Section 515B.3-104 applies only to transfers of special declarant rights that are  
 7.2 effective before August 1, 2010. Section 515B.3-1041, subsections (a) through (i), apply  
 7.3 only to transfers of special declarant rights that are effective on or after August 1, 2010.  
 7.4 Section 515B.3-1041, subsections (j) and (k), apply only to special declarant rights reserved  
 7.5 in a declaration that is first recorded on or after August 1, 2010.

7.6 **EFFECTIVE DATE.** This section is effective January 1, 2026.

7.7 Sec. 2. Minnesota Statutes 2024, section 515B.2-103, is amended to read:

7.8 **515B.2-103 CONSTRUCTION AND VALIDITY OF DECLARATION AND**  
 7.9 **BYLAWS.**

7.10 (a) All provisions of the declaration and bylaws are severable.

7.11 (b) The rule against perpetuities may not be applied to defeat any provision of the  
 7.12 declaration or this chapter, or any instrument executed pursuant to the declaration or this  
 7.13 chapter.

7.14 (c) In the event of a conflict between the provisions of the declaration and the bylaws,  
 7.15 the declaration prevails except to the extent that the declaration is inconsistent with this  
 7.16 chapter. In the event of a conflict between the provisions of the declaration or the bylaws  
 7.17 and this chapter, this chapter prevails.

7.18 (d) The declaration and bylaws must comply with sections 500.215, 500.216, and 500.217.

7.19 **EFFECTIVE DATE.** This section is effective January 1, 2026.

7.20 Sec. 3. Minnesota Statutes 2024, section 515B.2-119, is amended to read:

7.21 **515B.2-119 TERMINATION OF COMMON INTEREST COMMUNITY.**

7.22 (a) Except as otherwise provided in this chapter, a common interest community may be  
 7.23 terminated as follows:

7.24 (1) if the common interest community does not own any common elements, the common  
 7.25 interest community may be terminated only by agreement of unit owners of units to which  
 7.26 at least 60 percent of the votes in the association are allocated; or

7.27 (2) if the common interest community owns common elements, the common interest  
 7.28 community may be terminated only by agreement of unit owners of units to which at least  
 7.29 80 percent of the votes in the association are allocated, and 80 percent of the first mortgagees  
 7.30 of units (each mortgagee having one vote per unit financed), or any larger percentage the

8.1 ~~declaration specifies.~~ The declaration may specify a smaller percentage ~~only~~ if all of the  
8.2 units are single-family homes or if all of the units are restricted to nonresidential use.

8.3 (b) An agreement to terminate shall be evidenced by a written agreement, executed in  
8.4 the same manner as a deed by the number of unit owners ~~and first mortgagees of units~~  
8.5 required by subsection (a). The agreement shall specify a date after which the agreement  
8.6 shall be void unless recorded before that date. The agreement shall also specify a date by  
8.7 which the termination of the common interest community and the winding up of its affairs  
8.8 must be accomplished. A certificate of termination executed by the association evidencing  
8.9 the termination shall be recorded on or before the termination date, or the agreement to  
8.10 terminate shall be revoked. The agreement to terminate, or a memorandum thereof, and the  
8.11 certificate of termination shall be recorded in every county in which a portion of the common  
8.12 interest community is situated and is effective only upon recording.

8.13 (c) In the case of a condominium or planned community containing only units having  
8.14 upper and lower boundaries, a termination agreement may provide that all of the common  
8.15 elements and units of the common interest community must be sold following termination.  
8.16 If, pursuant to the agreement, any real estate in the common interest community is to be  
8.17 sold following termination, the termination agreement shall set forth the minimum terms  
8.18 of sale acceptable to the association.

8.19 (d) In the case of a condominium or planned community containing any units not having  
8.20 upper and lower boundaries, a termination agreement may provide for sale of the common  
8.21 elements, but it may not require that the units be sold following termination, unless ~~the~~  
8.22 ~~original declaration provided otherwise or~~ all unit owners whose units are to be sold consent  
8.23 to the sale.

8.24 (e) The association, on behalf of the unit owners, shall have authority to contract for the  
8.25 sale of real estate in a common interest community pursuant to this section, subject to the  
8.26 required approval. The agreement to terminate shall be deemed to grant to the association  
8.27 a power of attorney coupled with an interest to effect the conveyance of the real estate on  
8.28 behalf of the holders of all interests in the units, including without limitation the power to  
8.29 execute all instruments of conveyance and related instruments. Until the sale has been  
8.30 completed, all instruments in connection with the sale have been executed and the sale  
8.31 proceeds distributed, the association shall continue in existence with all powers it had before  
8.32 termination.

8.33 (1) The instrument conveying or creating the interest in the common interest community  
8.34 shall include as exhibits (i) an affidavit of the secretary of the association certifying that the



9.1 approval required by this section has been obtained and (ii) a schedule of the names of all  
9.2 unit owners in the common interest community as of the date of the approval.

9.3 (2) Proceeds of the sale shall be distributed to unit owners and secured parties as their  
9.4 interests may appear, in accordance with subsections (h), (i), (j), and (k).

9.5 (3) Unless otherwise specified in the agreement of termination, until the association has  
9.6 conveyed title to the real estate, each unit owner and the unit owner's successors in interest  
9.7 have an exclusive right to occupancy of the portion of the real estate that formerly constituted  
9.8 the unit. During the period of that occupancy, each unit owner and the unit owner's successors  
9.9 in interest remain liable for all assessments and other obligations imposed on unit owners  
9.10 by this chapter, the declaration or the bylaws.

9.11 (f) The legal description of the real estate constituting the common interest community  
9.12 shall, upon the date of recording of the certificate of termination referred to in subsection  
9.13 (b), be as follows:

9.14 (1) In a planned community utilizing a CIC plat complying with section 515B.2-110(d)(1)  
9.15 and (2), the lot and block description contained in the CIC plat, and any amendments thereto,  
9.16 subject to any subsequent conveyance or taking of a fee interest in any part of the property.

9.17 (2) In a condominium or cooperative, or a planned community utilizing a CIC plat  
9.18 complying with section 515B.2-110(c), the underlying legal description of the real estate  
9.19 as set forth in the declaration creating the common interest community, and any amendments  
9.20 thereto, subject to any subsequent conveyance or taking of a fee interest in any part of the  
9.21 property.

9.22 (3) The legal description referred to in this subsection shall apply upon the recording of  
9.23 the certificate of termination. The recording officer for each county in which the common  
9.24 interest community is located shall index the property located in that county in its records  
9.25 under the legal description required by this subsection from and after the date of recording  
9.26 of the certificate of termination. In the case of registered property, the registrar of titles shall  
9.27 cancel the existing certificates of title with respect to the property and issue one or more  
9.28 certificates of title for the property utilizing the legal description required by this subsection.

9.29 (g) In a condominium or planned community, if the agreement to terminate provides  
9.30 that the real estate constituting the common interest community is not to be sold following  
9.31 termination, title to the common elements and, in a common interest community containing  
9.32 only units having upper and lower boundaries described in the declaration, title to all the  
9.33 real estate in the common interest community, vests in the unit owners upon termination as  
9.34 tenants in common in proportion to their respective interest as provided in subsection (k),

10.1 and liens on the units shift accordingly. While the tenancy in common exists, each unit  
10.2 owner and the unit owner's successors in interest have an exclusive right to occupancy of  
10.3 the portion of the real estate that formerly constituted the unit.

10.4 (h) The proceeds of any sale of real estate pursuant to subsection (e), together with the  
10.5 assets of the association, shall be held by the association as trustee for unit owners, secured  
10.6 parties and other holders of liens on the units as their interests may appear. Before distributing  
10.7 any proceeds, the association shall have authority to deduct from the proceeds of sale due  
10.8 with respect to the unit (i) unpaid assessments levied by the association with respect to the  
10.9 unit, (ii) unpaid real estate taxes or special assessments due with respect to the unit, and  
10.10 (iii) the share of expenses of sale and winding up of the association's affairs with respect to  
10.11 the unit.

10.12 (i) Following termination of a condominium or planned community, creditors of the  
10.13 association holding liens on the units perfected before termination may enforce those liens  
10.14 in the same manner as any lienholder, in order of priority based upon their times of perfection.  
10.15 All other creditors of the association are to be treated as if they had perfected liens on the  
10.16 units immediately before termination.

10.17 (j) In a cooperative, the declaration may provide that all creditors of the association have  
10.18 priority over any interests of unit owners and creditors of unit owners. In that event, following  
10.19 termination, creditors of the association holding liens on the cooperative which were perfected  
10.20 before termination may enforce their liens in the same manner as any lienholder, in order  
10.21 of priority based upon their times of perfection. All other creditors of the association shall  
10.22 be treated as if they had perfected a lien against the cooperative immediately before  
10.23 termination. Unless the declaration provides that all creditors of the association have that  
10.24 priority:

10.25 (1) the lien of each creditor of the association which was perfected against the association  
10.26 before termination becomes, upon termination, a lien against each unit owner's interest in  
10.27 the unit as of the date the lien was perfected;

10.28 (2) any other creditor of the association is to be treated upon termination as if the creditor  
10.29 had perfected a lien against each unit owner's interest immediately before termination;

10.30 (3) the amount of the lien of an association's creditor described in paragraphs (1) and  
10.31 (2) against each of the unit owners' interest shall be proportionate to the ratio which each  
10.32 unit's common expense liability bears to the common expense liability of all of the units;

11.2 continues as a lien against that unit owner's interest in the unit as of the date the lien was

11.4 (5) the assets of the association shall be distributed to all unit owners and all lienholders  
11.5 as their interests may appear in the order described in this section. Creditors of the association  
11.6 are not entitled to payment from any unit owner in excess of the amount of the creditor's

11.8 (k) The respective interest of unit owners referred to in subsections (e), (f), (g), (h) and

 53.29 must submit the matter to mediation before a mutually agreeable neutral third party. For  
 53.30 the purposes of this section, mediation has the meaning given under the General Rules of  
 53.31 Practice, rule 114.02 (7). If the parties are not able to agree on a neutral third-party mediator  
 53.32 from the roster maintained by the Minnesota Supreme Court, the parties may petition the  
 53.33 district court in the jurisdiction in which the common interest community is located to

54.1 appoint a mediator. The applicable statute of limitations and statute of repose for an action  
 54.2 based on breach of a warranty imposed by this section, or any other action in contract, tort,  
 54.3 or other law for any injury to real or personal property or bodily injury or wrongful death  
 54.4 arising out of the alleged construction defect, is tolled from the date that any party makes  
 54.5 a written demand for mediation under this section until the latest of the following:

54.6 (1) five business days after mediation is completed; or

54.7 (2) 180 days.

54.8 Notwithstanding the foregoing, mediation shall not be required prior to commencement  
 54.9 of a construction defect claim if the parties have completed home warranty dispute resolution  
 54.10 under section 327A.051.

54.11 (d) The remedies provided for under this chapter are not exclusive and do not abrogate  
 54.12 any remedies under other statutes or the common law, notwithstanding whether those  
 54.13 remedies are referred to in this chapter.

54.14 (e) An association may not retaliate against a unit owner for asserting any right the unit  
 54.15 owner has under this chapter or other law. For purposes of this subsection, "asserting any  
 54.16 rights" includes but is not limited to filing an action in district court to enforce a right or  
 54.17 remedy provided by this chapter, other law, or the declaration, bylaws, rules, or regulations  
 54.18 of the association; or by filing a complaint with local authorities regarding a violation of a  
 54.19 health, safety, housing, or building code or ordinance. An association may not decrease  
 54.20 services or impose a fine or other penalty or charge legal fees to a unit owner, nor may the  
 54.21 association make the resumption of services or removal of the fine, penalty, or legal fees  
 54.22 contingent on a unit owner withdrawing an action in district court or complaint with local  
 54.23 authorities.

54.24 **EFFECTIVE DATE.** This section is effective January 1, 2026.

### 54.26 **LOCAL GOVERNMENT PREEMPTION**

54.27 Section 1. Minnesota Statutes 2024, section 394.25, is amended by adding a subdivision  
 54.28 to read:

54.29 **Subd. 11. Homeowners associations.** (a) A county must not condition approval of a  
 54.30 residential building permit or conditional use permit; residential subdivision development  
 54.31 or residential planned unit development; or any other permit related to residential  
 54.32 development on the:

55.1 (1) creation of a homeowners association;

55.2 (2) inclusion of any service, feature, or common property necessitating a homeowners  
55.3 association;

55.4 (3) inclusion of any terms in a homeowners association declaration, bylaws, articles of  
55.5 incorporation, or any other governing document that is not required under state law; or

55.6 (4) adoption or revocation of, or amendment to, a rule or regulation governing the  
55.7 homeowners association or its members.

55.8 (b) A county must not take any action that requires a residential property to be part of  
55.9 a homeowners association or provide an incentive for such membership. A county must not  
55.10 require or incentivize a homeowners association to adopt, revoke, or amend a term in any  
55.11 governing document or a rule or regulation not required under state law.

55.13 (a) A municipality, joint planning board, or public corporation must not condition  
55.14 approval of a residential building permit or conditional use permit; residential subdivision

55.16 residential development on the:

55.17 (1) creation of a homeowners association;

55.18 (2) inclusion of any service, feature, or common property necessitating a homeowners  
55.19 association;

55.20 (3) inclusion of any terms in a homeowners association declaration, bylaws, articles of  
55.21 incorporation, or any other governing document that is not required under state law; or

55.22 (4) adoption or revocation of, or amendment to, a rule or regulation governing the  
55.23 homeowners association or its members.

55.24 (b) A municipality, joint planning board, public corporation, or the Metropolitan Council  
55.25 must not take any action that requires a residential property to be part of a homeowners  
55.26 association or provide an incentive for such membership. A municipality, joint planning  
55.27 board, public corporation, or the Metropolitan Council must not require or incentivize a  
55.28 homeowners association to adopt, revoke, or amend a term in any governing document or  
55.29 a rule or regulation not required under state law.
