BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. COVID-19 FOOD RELIEF GRANT PROGRAM; APPROPRIATION.

Subdivision 1. **Appropriation.** (a) \$10,000,000 in fiscal year 2021 is appropriated from the general fund to the commissioner of human services for purposes of the COVID-19 food relief grant program to provide economic support to Minnesota-owned and operated restaurants, catering companies, and food establishments that employ the equivalent of 50 or fewer full-time employees while also providing hunger relief to Minnesotans impacted by COVID-19, including people experiencing food insecurity.

- (b) The commissioner may use up to \$1,000,000 of this appropriation to administer this grant.
- (c) Notwithstanding any other law or rule to the contrary, the commissioner may allocate funds to: (1) nonprofit community organizations to provide technical assistance to grantees to purchase prepared meals from restaurants, catering companies, and food establishments to provide prepared meals under this section; and (2) programs, providers, and organizations providing or seeking to provide meals through a single fiscal agent chosen by the commissioner.
- 1.20 (d) This is a onetime appropriation.
- Subd. 2. Eligible grantees. Eligible grantees are nonprofit community organizations 1.21 that can demonstrate a need for prepared meals and an ability to provide prepared meals 1.22

Subd. 6. Nonstate funds. If a grant recipient receives funds from a nonstate source other than a local unit of government or a tribe for activities listed in subdivision 3, the grant recipient must notify the commissioner of the amount received from the nonstate source. If the commissioner determines that the total amount that the grant recipient received under this section and from the nonstate source exceeds the grant recipient's costs for the activities under subdivision 3, the grant recipient must pay the commissioner the amount that exceeds the costs, up to the amount of funding provided under this section. All money paid by grant recipients to the commissioner under this section must be deposited in the general fund. Subd. 7. Expiration. This section expires March 31, 2021.
