1.2 relating to health and human services; adding advanced practice registered nurses

1.3 and physician assistants to certain statutes; amending Minnesota Statutes 2016,

1.10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.11 Section 1. Minnesota Statutes 2016, section 62Q.56, subdivision 1a, is amended to read:

1.12 Subd. 1a. **Change in health care provider; termination not for cause.** (a) If the contract

1.13 termination was not for cause and the contract was terminated by the health plan company,

1.14 the health plan company must provide the terminated provider and all enrollees being treated

1.15 by that provider with notification of the enrollees' rights to continuity of care with the

1.16 terminated provider.

1.17 (b) The health plan company must provide, upon request, authorization to receive services

1.18 that are otherwise covered under the terms of the health plan through the enrollee's current

1.19 provider:

1.20 (1) for up to 120 days if the enrollee is engaged in a current course of treatment for one

1.21 or more of the following conditions:

1.22 (i) an acute condition;

1.23 (ii) a life-threatening mental or physical illness;

1.24 (iii) pregnancy beyond the first trimester of pregnancy;

2.1 (iv) a physical or mental disability defined as an inability to engage in one or more major
 2.2 life activities, provided that the disability has lasted or can be expected to last for at least
 2.3 one year, or can be expected to result in death; or

2.4 (v) a disabling or chronic condition that is in an acute phase; or

2.5 (2) for the rest of the enrollee's life if a physician, advanced practice registered nurse,
 2.6 or physician assistant certifies that the enrollee has an expected lifetime of 180 days or less.

2.7 For all requests for authorization to receive services under this paragraph, the health plan
 2.8 company must grant the request unless the enrollee does not meet the criteria provided in
 2.9 this paragraph.

2.10 (c) The health plan company shall prepare a written plan that provides a process for
 2.11 coverage determinations regarding continuity of care of up to 120 days for enrollees who
 2.12 request continuity of care with their former provider, if the enrollee:

2.13 (1) is receiving culturally appropriate services and the health plan company does not
 2.14 have a provider in its preferred provider network with special expertise in the delivery of
 2.15 those culturally appropriate services within the time and distance requirements of section
 2.16 62D.124, subdivision 1; or

2.17 (2) does not speak English and the health plan company does not have a provider in its
 2.18 preferred provider network who can communicate with the enrollee, either directly or through
 2.19 an interpreter, within the time and distance requirements of section 62D.124, subdivision
 2.20 1.

2.21 The written plan must explain the criteria that will be used to determine whether a need for
 2.22 continuity of care exists and how it will be provided.

2.23 Sec. 2. Minnesota Statutes 2016, section 144.213, subdivision 1, is amended to read:

2.24 Subdivision 1. **Creation; state registrar; Office of Vital Records.** The commissioner
 2.25 shall establish an Office of Vital Records under the supervision of the state registrar. The
 2.26 commissioner shall promulgate rules for the collection, filing, and registering of vital records
 2.27 information by the state registrar, physicians, advanced practice registered nurses, physician
 2.28 assistants, morticians, and others. Except as otherwise provided in sections 144.211 to
 2.29 144.227, rules previously promulgated by the commissioner relating to the collection, filing
 2.30 and registering of vital records shall remain in effect until repealed, modified or superseded
 2.31 by a rule promulgated by the commissioner.

3.1 Sec. 3. Minnesota Statutes 2016, section 144.441, subdivision 3, is amended to read:

3.2 Subd. 3. **Screening of students.** As determined by the commissioner under subdivision
3.3 2, no person may enroll or remain enrolled in any school which the commissioner has
3.4 designated under subdivision 2 until the person has submitted to the administrator or other
3.5 person having general control and supervision of the school, one of the following statements:

3.6 (1) a statement from a physician, advanced practice registered nurse, physician assistant,
3.7 or public clinic stating that the person has had a negative Mantoux test reaction within the
3.8 past year, provided that the person has no symptoms suggestive of tuberculosis or evidence
3.9 of a new exposure to active tuberculosis;

3.10 (2) a statement from a physician, advanced practice registered nurse, physician assistant,
3.11 or public clinic stating that a person who has a positive Mantoux test reaction has had a
3.12 negative chest roentgenogram (X-ray) for tuberculosis within the past year, provided that
3.13 the person has no symptoms suggestive of tuberculosis or evidence of a new exposure to
3.14 active tuberculosis;

3.15 (3) a statement from a physician, advanced practice registered nurse, physician assistant,
3.16 or public health clinic stating that the person (i) has a history of adequately treated active
3.17 tuberculosis; (ii) is currently receiving tuberculosis preventive therapy; (iii) is currently
3.18 undergoing therapy for active tuberculosis and the person's presence in a school building
3.19 will not endanger the health of other people; or (iv) has completed a course of tuberculosis
3.20 preventive therapy or was intolerant to preventive therapy, provided the person has no
3.21 symptoms suggestive of tuberculosis or evidence of a new exposure to active tuberculosis;
3.22 or

3.23 (4) a notarized statement signed by the minor child's parent or guardian or by the
3.24 emancipated person stating that the person has not submitted the proof of tuberculosis
3.25 screening as required by this subdivision because of the conscientiously held beliefs of the
3.26 parent or guardian of the minor child or of the emancipated person. This statement must be
3.27 forwarded to the commissioner.

3.28 Sec. 4. Minnesota Statutes 2016, section 145.7131, is amended to read:

3.29 **145.7131 EXCEPTION TO EYEGGLASS PRESCRIPTION EXPIRATION.**

3.30 Notwithstanding any practice to the contrary, in an emergency situation or in the case
3.31 of lost glasses, an optometrist or physician, advanced practice registered nurse, or physician
3.32 assistant may authorize a new pair of prescription eyeglasses using the prescription from
3.33 the old lenses or the last prescription available.

4.1 Sec. 5. Minnesota Statutes 2016, section 145.867, subdivision 2, is amended to read:

4.2 Subd. 2. **Identification card for individuals needing a special diet.** The commissioner
4.3 of health shall make special diet identification cards available to physicians, advanced
4.4 practice registered nurses, physician assistants, and ~~to~~ persons with diabetes and other
4.5 conditions requiring special diets. The identification card must contain spaces for: (1) the
4.6 person's name, address, and signature; (2) the physician's, advanced practice registered
4.7 nurse's, or physician assistant's name, phone number, and signature; (3) a description of the
4.8 person's medical condition; and (4) an expiration date. The card must also contain the
4.9 following provision, in identical or substantially similar language: "The owner of this card
4.10 is exempted by the commissioner of health from prohibitions on bringing outside food and
4.11 drink into a public facility." Persons with medical conditions requiring a special diet may
4.12 ask their physician, advanced practice registered nurse, or physician assistant to fill out and
4.13 sign the card. The physician, advanced practice registered nurse, or physician assistant shall
4.14 fill out and sign the card if, in the physician's, advanced practice registered nurse's, or
4.15 physician assistant's medical judgment, the person has a medical condition that requires a
4.16 special diet. Persons with diabetes shall be automatically assumed by physicians, advanced
4.17 practice registered nurses, and physician assistants to require special diets. Special diet
4.18 identification cards shall be valid for five years. Persons with a medical condition requiring
4.19 a special diet may request a new card from their physician, advanced practice registered
4.20 nurse, or physician assistant up to six months before the expiration date.

4.21 Sec. 6. Minnesota Statutes 2016, section 252A.21, subdivision 2, is amended to read:

4.22 Subd. 2. **Rules.** The commissioner shall adopt rules to implement this chapter. The rules
4.23 must include standards for performance of guardianship or conservatorship duties including,
4.24 but not limited to: twice a year visits with the ward; a requirement that the duties of
4.25 guardianship or conservatorship and case management not be performed by the same person;
4.26 specific standards for action on "do not resuscitate" orders; as recommended by a physician,
4.27 an advanced practice registered nurse, or a physician assistant; sterilization requests; and
4.28 the use of psychotropic medication and aversive procedures.

4.29 Sec. 7. Minnesota Statutes 2016, section 256.9365, subdivision 2, is amended to read:

4.30 Subd. 2. **Eligibility requirements.** To be eligible for the program, an applicant must
4.31 satisfy the following requirements:

4.32 (1) the applicant must provide a physician's, advanced practice registered nurse's, or
4.33 physician assistant's statement verifying that the applicant is infected with HIV and is, or

5.1 within three months is likely to become, too ill to work in the applicant's current employment
5.2 because of HIV-related disease;

5.3 (2) the applicant's monthly gross family income must not exceed 300 percent of the
5.4 federal poverty guidelines, after deducting medical expenses and insurance premiums;

5.5 (3) the applicant must not own assets with a combined value of more than \$25,000; and

5.6 (4) if applying for payment of group plan premiums, the applicant must be covered by
5.7 an employer's or former employer's group insurance plan.

5.8 Sec. 8. Minnesota Statutes 2016, section 256B.056, subdivision 2, is amended to read:

5.9 Subd. 2. **Homestead exclusion for persons residing in a long-term care facility.** The
5.10 homestead shall be excluded for the first six calendar months of a person's stay in a long-term
5.11 care facility and shall continue to be excluded for as long as the recipient can be reasonably
5.12 expected to return to the homestead. For purposes of this subdivision, "reasonably expected
5.13 to return to the homestead" means the recipient's attending physician, advanced practice
5.14 registered nurse, or physician assistant has certified that the expectation is reasonable, and
5.15 the recipient can show that the cost of care upon returning home will be met through medical
5.16 assistance or other sources. The homestead shall continue to be excluded for persons residing
5.17 in a long-term care facility if it is used as a primary residence by one of the following
5.18 individuals:

5.19 (1) the spouse;

5.20 (2) a child under age 21;

5.21 (3) a child of any age who is blind or permanently and totally disabled as defined in the
5.22 Supplemental Security Income program;

5.23 (4) a sibling who has equity interest in the home and who resided in the home for at least
5.24 one year immediately before the date of the person's admission to the facility; or

5.25 (5) a child of any age or a grandchild of any age who resided in the home for at least
5.26 two years immediately before the date of the person's admission to the facility, and who
5.27 provided care to the person that permitted the person to reside at home rather than in an
5.28 institution.

5.29 Sec. 9. Minnesota Statutes 2016, section 256B.057, subdivision 9, is amended to read:

5.30 Subd. 9. **Employed persons with disabilities.** (a) Medical assistance may be paid for
5.31 a person who is employed and who:

6.1 (1) but for excess earnings or assets, meets the definition of disabled under the
6.2 Supplemental Security Income program;

6.3 (2) meets the asset limits in paragraph (d); and

6.4 (3) pays a premium and other obligations under paragraph (e).

6.5 (b) For purposes of eligibility, there is a \$65 earned income disregard. To be eligible
6.6 for medical assistance under this subdivision, a person must have more than \$65 of earned
6.7 income. Earned income must have Medicare, Social Security, and applicable state and
6.8 federal taxes withheld. The person must document earned income tax withholding. Any
6.9 spousal income or assets shall be disregarded for purposes of eligibility and premium
6.10 determinations.

6.11 (c) After the month of enrollment, a person enrolled in medical assistance under this
6.12 subdivision who:

6.13 (1) is temporarily unable to work and without receipt of earned income due to a medical
6.14 condition, as verified by a physician, advanced practice registered nurse, or physician
6.15 assistant; or

6.16 (2) loses employment for reasons not attributable to the enrollee, and is without receipt
6.17 of earned income may retain eligibility for up to four consecutive months after the month
6.18 of job loss. To receive a four-month extension, enrollees must verify the medical condition
6.19 or provide notification of job loss. All other eligibility requirements must be met and the
6.20 enrollee must pay all calculated premium costs for continued eligibility.

6.21 (d) For purposes of determining eligibility under this subdivision, a person's assets must
6.22 not exceed \$20,000, excluding:

6.23 (1) all assets excluded under section 256B.056;

6.24 (2) retirement accounts, including individual accounts, 401(k) plans, 403(b) plans, Keogh
6.25 plans, and pension plans;

6.26 (3) medical expense accounts set up through the person's employer; and

6.27 (4) spousal assets, including spouse's share of jointly held assets.

6.28 (e) All enrollees must pay a premium to be eligible for medical assistance under this
6.29 subdivision, except as provided under clause (5).

6.30 (1) An enrollee must pay the greater of a \$35 premium or the premium calculated based
6.31 on the person's gross earned and unearned income and the applicable family size using a
6.32 sliding fee scale established by the commissioner, which begins at one percent of income

7.1 at 100 percent of the federal poverty guidelines and increases to 7.5 percent of income for
7.2 those with incomes at or above 300 percent of the federal poverty guidelines.

7.3 (2) Annual adjustments in the premium schedule based upon changes in the federal
7.4 poverty guidelines shall be effective for premiums due in July of each year.

7.5 (3) All enrollees who receive unearned income must pay one-half of one percent of
7.6 unearned income in addition to the premium amount, except as provided under clause (5).

7.7 (4) Increases in benefits under title II of the Social Security Act shall not be counted as
7.8 income for purposes of this subdivision until July 1 of each year.

7.9 (5) Effective July 1, 2009, American Indians are exempt from paying premiums as
7.10 required by section 5006 of the American Recovery and Reinvestment Act of 2009, Public
7.11 Law 111-5. For purposes of this clause, an American Indian is any person who meets the
7.12 definition of Indian according to Code of Federal Regulations, title 42, section 447.50.

7.13 (f) A person's eligibility and premium shall be determined by the local county agency.
7.14 Premiums must be paid to the commissioner. All premiums are dedicated to the
7.15 commissioner.

7.16 (g) Any required premium shall be determined at application and redetermined at the
7.17 enrollee's six-month income review or when a change in income or household size is reported.
7.18 Enrollees must report any change in income or household size within ten days of when the
7.19 change occurs. A decreased premium resulting from a reported change in income or
7.20 household size shall be effective the first day of the next available billing month after the
7.21 change is reported. Except for changes occurring from annual cost-of-living increases, a
7.22 change resulting in an increased premium shall not affect the premium amount until the
7.23 next six-month review.

7.24 (h) Premium payment is due upon notification from the commissioner of the premium
7.25 amount required. Premiums may be paid in installments at the discretion of the commissioner.

7.26 (i) Nonpayment of the premium shall result in denial or termination of medical assistance
7.27 unless the person demonstrates good cause for nonpayment. Good cause exists if the
7.28 requirements specified in Minnesota Rules, part 9506.0040, subpart 7, items B to D, are
7.29 met. Except when an installment agreement is accepted by the commissioner, all persons
7.30 disenrolled for nonpayment of a premium must pay any past due premiums as well as current
7.31 premiums due prior to being reenrolled. Nonpayment shall include payment with a returned,
7.32 refused, or dishonored instrument. The commissioner may require a guaranteed form of
7.33 payment as the only means to replace a returned, refused, or dishonored instrument.

8.1 (j) For enrollees whose income does not exceed 200 percent of the federal poverty
8.2 guidelines and who are also enrolled in Medicare, the commissioner shall reimburse the
8.3 enrollee for Medicare part B premiums under section 256B.0625, subdivision 15, paragraph
8.4 (a).

8.5 Sec. 10. Minnesota Statutes 2016, section 256B.0575, subdivision 1, is amended to read:

8.6 Subdivision 1. **Income deductions.** When an institutionalized person is determined
8.7 eligible for medical assistance, the income that exceeds the deductions in paragraphs (a)
8.8 and (b) must be applied to the cost of institutional care.

8.9 (a) The following amounts must be deducted from the institutionalized person's income
8.10 in the following order:

8.11 (1) the personal needs allowance under section 256B.35 or, for a veteran who does not
8.12 have a spouse or child, or a surviving spouse of a veteran having no child, the amount of
8.13 an improved pension received from the veteran's administration not exceeding \$90 per
8.14 month;

8.15 (2) the personal allowance for disabled individuals under section 256B.36;

8.16 (3) if the institutionalized person has a legally appointed guardian or conservator, five
8.17 percent of the recipient's gross monthly income up to \$100 as reimbursement for guardianship
8.18 or conservatorship services;

8.19 (4) a monthly income allowance determined under section 256B.058, subdivision 2, but
8.20 only to the extent income of the institutionalized spouse is made available to the community
8.21 spouse;

8.22 (5) a monthly allowance for children under age 18 which, together with the net income
8.23 of the children, would provide income equal to the medical assistance standard for families
8.24 and children according to section 256B.056, subdivision 4, for a family size that includes
8.25 only the minor children. This deduction applies only if the children do not live with the
8.26 community spouse and only to the extent that the deduction is not included in the personal
8.27 needs allowance under section 256B.35, subdivision 1, as child support garnished under a
8.28 court order;

8.29 (6) a monthly family allowance for other family members, equal to one-third of the
8.30 difference between 122 percent of the federal poverty guidelines and the monthly income
8.31 for that family member;

9.1 (7) reparations payments made by the Federal Republic of Germany and reparations
9.2 payments made by the Netherlands for victims of Nazi persecution between 1940 and 1945;

9.3 (8) all other exclusions from income for institutionalized persons as mandated by federal
9.4 law; and

9.5 (9) amounts for reasonable expenses, as specified in subdivision 2, incurred for necessary
9.6 medical or remedial care for the institutionalized person that are recognized under state law,
9.7 not medical assistance covered expenses, and not subject to payment by a third party.

9.8 For purposes of clause (6), "other family member" means a person who resides with the
9.9 community spouse and who is a minor or dependent child, dependent parent, or dependent
9.10 sibling of either spouse. "Dependent" means a person who could be claimed as a dependent
9.11 for federal income tax purposes under the Internal Revenue Code.

9.12 (b) Income shall be allocated to an institutionalized person for a period of up to three
9.13 calendar months, in an amount equal to the medical assistance standard for a family size of
9.14 one if:

9.15 (1) a physician, advanced practice registered nurse, or physician assistant certifies that
9.16 the person is expected to reside in the long-term care facility for three calendar months or
9.17 less;

9.18 (2) if the person has expenses of maintaining a residence in the community; and

9.19 (3) if one of the following circumstances apply:

9.20 (i) the person was not living together with a spouse or a family member as defined in
9.21 paragraph (a) when the person entered a long-term care facility; or

9.22 (ii) the person and the person's spouse become institutionalized on the same date, in
9.23 which case the allocation shall be applied to the income of one of the spouses.

9.24 For purposes of this paragraph, a person is determined to be residing in a licensed nursing
9.25 home, regional treatment center, or medical institution if the person is expected to remain
9.26 for a period of one full calendar month or more.

9.27 Sec. 11. Minnesota Statutes 2016, section 256B.0625, subdivision 2, is amended to read:

9.28 Subd. 2. **Skilled and intermediate nursing care.** (a) Medical assistance covers skilled
9.29 nursing home services and services of intermediate care facilities, including training and
9.30 habilitation services, as defined in section 252.41, subdivision 3, for persons with
9.31 developmental disabilities who are residing in intermediate care facilities for persons with
9.32 developmental disabilities. Medical assistance must not be used to pay the costs of nursing

10.1 care provided to a patient in a swing bed as defined in section 144.562, unless (1) the facility
10.2 in which the swing bed is located is eligible as a sole community provider, as defined in
10.3 Code of Federal Regulations, title 42, section 412.92, or the facility is a public hospital
10.4 owned by a governmental entity with 15 or fewer licensed acute care beds; (2) the Centers
10.5 for Medicare and Medicaid Services approves the necessary state plan amendments; (3) the
10.6 patient was screened as provided by law; (4) the patient no longer requires acute care
10.7 services; and (5) no nursing home beds are available within 25 miles of the facility. The
10.8 commissioner shall exempt a facility from compliance with the sole community provider
10.9 requirement in clause (1) if, as of January 1, 2004, the facility had an agreement with the
10.10 commissioner to provide medical assistance swing bed services.

10.11 (b) Medical assistance also covers up to ten days of nursing care provided to a patient
10.12 in a swing bed if: (1) the patient's physician, advanced practice registered nurse, or physician
10.13 assistant certifies that the patient has a terminal illness or condition that is likely to result
10.14 in death within 30 days and that moving the patient would not be in the best interests of the
10.15 patient and patient's family; (2) no open nursing home beds are available within 25 miles
10.16 of the facility; and (3) no open beds are available in any Medicare hospice program within
10.17 50 miles of the facility. The daily medical assistance payment for nursing care for the patient
10.18 in the swing bed is the statewide average medical assistance skilled nursing care per diem
10.19 as computed annually by the commissioner on July 1 of each year.

10.20 Sec. 12. Minnesota Statutes 2016, section 256B.0653, subdivision 4, is amended to read:

10.21 Subd. 4. **Skilled nurse visit services.** (a) Skilled nurse visit services must be provided
10.22 by a registered nurse or a licensed practical nurse under the supervision of a registered nurse,
10.23 according to the written plan of care and accepted standards of medical and nursing practice
10.24 according to chapter 148. Skilled nurse visit services must be ordered by a physician,
10.25 advanced practice registered nurse, or physician assistant and documented in a plan of care
10.26 that is reviewed and approved by the ordering physician, advanced practice registered nurse,
10.27 or physician assistant at least once every 60 days. All skilled nurse visits must be medically
10.28 necessary and provided in the recipient's home residence except as allowed under section
10.29 256B.0625, subdivision 6a.

10.30 (b) Skilled nurse visits include face-to-face and telehomecare visits with a limit of up
10.31 to two visits per day per recipient. All visits must be based on assessed needs.

10.32 (c) Telehomecare skilled nurse visits are allowed when the recipient's health status can
10.33 be accurately measured and assessed without a need for a face-to-face, hands-on encounter.

11.1 All telehomecare skilled nurse visits must have authorization and are paid at the same
11.2 allowable rates as face-to-face skilled nurse visits.

11.3 (d) The provision of telehomecare must be made via live, two-way interactive audiovisual
11.4 technology and may be augmented by utilizing store-and-forward technologies. Individually
11.5 identifiable patient data obtained through real-time or store-and-forward technology must
11.6 be maintained as health records according to sections 144.291 to 144.298. If the video is
11.7 used for research, training, or other purposes unrelated to the care of the patient, the identity
11.8 of the patient must be concealed.

11.9 (e) Authorization for skilled nurse visits must be completed under section 256B.0652.
11.10 A total of nine face-to-face skilled nurse visits per calendar year do not require authorization.
11.11 All telehomecare skilled nurse visits require authorization.

11.12 Sec. 13. Minnesota Statutes 2016, section 256B.15, subdivision 1a, is amended to read:

11.13 Subd. 1a. **Estates subject to claims.** (a) If a person receives medical assistance hereunder,
11.14 on the person's death, if single, or on the death of the survivor of a married couple, either
11.15 or both of whom received medical assistance, or as otherwise provided for in this section,
11.16 the amount paid for medical assistance as limited under subdivision 2 for the person and
11.17 spouse shall be filed as a claim against the estate of the person or the estate of the surviving
11.18 spouse in the court having jurisdiction to probate the estate or to issue a decree of descent
11.19 according to sections 525.31 to 525.313.

11.20 (b) For the purposes of this section, the person's estate must consist of:

11.21 (1) the person's probate estate;

11.22 (2) all of the person's interests or proceeds of those interests in real property the person
11.23 owned as a life tenant or as a joint tenant with a right of survivorship at the time of the
11.24 person's death;

11.25 (3) all of the person's interests or proceeds of those interests in securities the person
11.26 owned in beneficiary form as provided under sections 524.6-301 to 524.6-311 at the time
11.27 of the person's death, to the extent the interests or proceeds of those interests become part
11.28 of the probate estate under section 524.6-307;

11.29 (4) all of the person's interests in joint accounts, multiple-party accounts, and pay-on-death
11.30 accounts, brokerage accounts, investment accounts, or the proceeds of those accounts, as
11.31 provided under sections 524.6-201 to 524.6-214 at the time of the person's death to the
11.32 extent the interests become part of the probate estate under section 524.6-207; and
