1.27 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.28 Section 1. Minnesota Statutes 2020, section 5B.06, is amended to read:

1.29 **5B.06 VOTING BY PROGRAM PARTICIPANT; ABSENTEE BALLOT.**

1.30 A program participant who is otherwise eligible to vote may register with the secretary

1.31 of state as a permanent absentee voter. Notwithstanding section 203B.04, subdivision 5,

1.32 the secretary of state is not required to send an absentee ballot application prior to each

2.1 election to a program participant registered as a permanent absentee voter under this section.
2.2 As soon as practicable before each election, the secretary of state shall determine the precinct
2.3 in which the residential address of ~~the~~ a program participant is located and. Upon making
2.4 a precinct determination, the secretary of state shall either (1) request from and receive from
2.5 the county auditor or other election official the ballot for that precinct and ~~shall forward~~
2.6 mail the absentee ballot to the program participant ~~with the other,~~ or (2) using the Minnesota
2.7 statewide voter registration system, prepare the program participant's ballot for that precinct
2.8 and mail the absentee ballot to the program participant. The secretary of state shall include
2.9 with each mailed absentee ballot all corresponding materials for absentee balloting as
2.10 required by Minnesota law. The program participant shall complete the ballot and return it
2.11 to the secretary of state, who shall review the ballot in the manner provided by section
2.12 203B.121, subdivision 2. If the ballot and ballot materials comply with the requirements of
2.13 that section, the ballot must be certified by the secretary of state as the ballot of a program
2.14 participant, and must be forwarded to the appropriate electoral jurisdiction for tabulation
2.15 along with all other ballots. The name and address of a program participant must not be
2.16 listed in the statewide voter registration system.

2.17 Sec. 2. Minnesota Statutes 2020, section 201.061, subdivision 3, is amended to read:

2.18 Subd. 3. **Election day registration.** (a) An individual who is eligible to vote may register
2.19 on election day by appearing in person at the polling place for the precinct in which the
2.20 individual maintains residence, by completing a registration application, making an oath in
2.21 the form prescribed by the secretary of state and providing proof of residence. An individual
2.22 may prove residence for purposes of registering by:

2.23 (1) presenting a driver's license or Minnesota identification card issued pursuant to
2.24 section 171.07;

2.25 (2) presenting any document approved by the secretary of state as proper identification;

2.26 (3) presenting one of the following:

2.27 (i) a current valid student identification card from a postsecondary educational institution
2.28 in Minnesota, if a list of students from that institution has been prepared under section
2.29 135A.17 and certified to the county auditor in the manner provided in rules of the secretary
2.30 of state; or

2.31 (ii) a current student fee statement that contains the student's valid address in the precinct
2.32 together with a picture identification card; or

3.1 (4) having a voter who is registered to vote in the precinct, or an employee employed
3.2 by and working in a residential facility in the precinct and vouching for a resident in the
3.3 facility, sign an oath in the presence of the election judge vouching that the voter or employee
3.4 personally knows that the individual is a resident of the precinct. A voter who has been
3.5 vouched for on election day may not sign a proof of residence oath vouching for any other
3.6 individual on that election day. A voter who is registered to vote in the precinct may sign
3.7 up to eight proof-of-residence oaths on any election day. This limitation does not apply to
3.8 an employee of a residential facility described in this clause. The secretary of state shall
3.9 provide a form for election judges to use in recording the number of individuals for whom
3.10 a voter signs proof-of-residence oaths on election day. The form must include space for the
3.11 maximum number of individuals for whom a voter may sign proof-of-residence oaths. For
3.12 each proof-of-residence oath, the form must include a statement that the individual: (i) is
3.13 registered to vote in the precinct or is an employee of a residential facility in the precinct,
3.14 (ii) personally knows that the voter is a resident of the precinct, and (iii) is making the
3.15 statement on oath. The form must include a space for the voter's printed name, signature,
3.16 telephone number, and address.

3.17 The oath required by this subdivision and Minnesota Rules, part 8200.9939, must be
3.18 attached to the voter registration application.

3.19 (b) The operator of a residential facility shall prepare a list of the names of its employees
3.20 currently working in the residential facility and the address of the residential facility. The
3.21 operator shall certify the list and provide it to the appropriate county auditor no less than
3.22 20 days before each election for use in election day registration.

3.23 (c) "Residential facility" means transitional housing as defined in section 256E.33,
3.24 subdivision 1; a supervised living facility licensed by the commissioner of health under
3.25 section 144.50, subdivision 6; a nursing home as defined in section 144A.01, subdivision
3.26 5; a residence registered with the commissioner of health as a housing with services
3.27 establishment as defined in section 144D.01, subdivision 4; a veterans home operated by
3.28 the board of directors of the Minnesota Veterans Homes under chapter 198; a residence
3.29 licensed by the commissioner of human services to provide a residential program as defined
3.30 in section 245A.02, subdivision 14; a residential facility for persons with a developmental
3.31 disability licensed by the commissioner of human services under section 252.28; setting
3.32 authorized to provide housing support as defined in section 256I.03, subdivision 3; a shelter
3.33 for battered women as defined in section 611A.37, subdivision 4; ~~or~~ a supervised publicly
3.34 or privately operated shelter or dwelling designed to provide temporary living
3.35 accommodations for the homeless; a facility where a provider operates a residential treatment

4.1 program as defined in section 245.462, subdivision 23; or a facility where a provider operates
4.2 an adult foster care program as defined in section 245A.02, subdivision 6c.

4.3 (d) For tribal band members, an individual may prove residence for purposes of
4.4 registering by:

4.5 (1) presenting an identification card issued by the tribal government of a tribe recognized
4.6 by the Bureau of Indian Affairs, United States Department of the Interior, that contains the
4.7 name, address, signature, and picture of the individual; or

4.8 (2) presenting an identification card issued by the tribal government of a tribe recognized
4.9 by the Bureau of Indian Affairs, United States Department of the Interior, that contains the
4.10 name, signature, and picture of the individual and also presenting one of the documents
4.11 listed in Minnesota Rules, part 8200.5100, subpart 2, item B.

4.12 (e) A county, school district, or municipality may require that an election judge
4.13 responsible for election day registration initial each completed registration application.

4.14 Sec. 3. Minnesota Statutes 2020, section 201.071, subdivision 1, is amended to read:

4.15 Subdivision 1. **Form.** Both paper and electronic voter registration applications must
4.16 contain the same information unless otherwise provided by law. A voter registration
4.17 application must contain spaces for the following required information: voter's first name,
4.18 middle name, and last name; voter's previous name, if any; voter's current address; voter's
4.19 previous address, if any; voter's date of birth; voter's municipality and county of residence;
4.20 voter's telephone number, if provided by the voter; date of registration; current and valid
4.21 Minnesota driver's license number or Minnesota state identification number, or if the voter
4.22 has no current and valid Minnesota driver's license or Minnesota state identification, the
4.23 last four digits of the voter's Social Security number; and voter's signature. The paper
4.24 registration application may include the voter's e-mail address, if provided by the voter. The
4.25 electronic voter registration application must include the voter's e-mail address. The
4.26 registration application may include the voter's interest in serving as an election judge, if
4.27 indicated by the voter. The application must also contain the following certification of voter
4.28 eligibility:

4.29 "I certify that I:

4.30 (1) will be at least 18 years old on election day;

4.31 (2) am a citizen of the United States;

5.1 (3) will have ~~resided~~ maintained residence in Minnesota for 20 days immediately
5.2 preceding election day;

5.3 (4) maintain residence at the address given on the registration form;

5.4 (5) am not under court-ordered guardianship in which the court order revokes my right
5.5 to vote;

5.6 (6) have not been found by a court to be legally incompetent to vote;

5.7 (7) have the right to vote because, if I have been convicted of a felony, my felony sentence
5.8 has expired (been completed) or I have been discharged from my sentence; and

5.9 (8) have read and understand the following statement: that giving false information is a
5.10 felony punishable by not more than five years imprisonment or a fine of not more than
5.11 \$10,000, or both."

5.12 The certification must include boxes for the voter to respond to the following questions:

5.13 "(1) Are you a citizen of the United States?" and

5.14 "(2) Will you be 18 years old on or before election day?"

5.15 And the instruction:

5.16 "If you checked 'no' to either of these questions, do not complete this form."

5.17 The form of the voter registration application and the certification of voter eligibility
5.18 must be as provided in this subdivision and approved by the secretary of state. Voter
5.19 registration forms authorized by the National Voter Registration Act must also be accepted
5.20 as valid. The federal postcard application form must also be accepted as valid if it is not
5.21 deficient and the voter is eligible to register in Minnesota.

5.22 An individual may use a voter registration application to apply to register to vote in
5.23 Minnesota or to change information on an existing registration.

5.24 Sec. 4. Minnesota Statutes 2020, section 201.071, subdivision 2, is amended to read:

5.25 Subd. 2. **Instructions.** (a) A registration application shall be accompanied by instructions
5.26 specifying the manner and method of registration, the qualifications for voting, the penalties
5.27 for false registration, and the availability of registration and voting assistance for elderly
5.28 and disabled individuals and residents of health care facilities and hospitals.

5.29 (b) The instructions must indicate that ~~if the voter does not have~~ must provide a valid
5.30 Minnesota driver's license or identification card number, or the last four digits of the voter's

6.1 Social Security number ~~must be provided, unless the voter does not have a Social Security~~
 6.2 ~~number, unless the voter has not been issued one of those numbers.~~

6.3 (c) If, prior to election day, a person requests the instructions in Braille, audio format,
 6.4 or in a version printed in 16-point bold type with 24-point leading, the county auditor shall
 6.5 provide them in the form requested. The secretary of state shall prepare Braille and audio
 6.6 copies and make them available.

6.7 Sec. 5. Minnesota Statutes 2020, section 201.071, subdivision 3, is amended to read:

6.8 Subd. 3. **Deficient registration.** ~~No~~ (a) A voter registration application is not deficient
 6.9 if it contains the voter's:

6.10 (1) name, address, and date of birth;

6.11 (2) current and valid Minnesota driver's license number ~~or~~, Minnesota state identification
 6.12 number, or ~~if the voter has no current and valid Minnesota driver's license or Minnesota~~
 6.13 ~~state identification number~~, the last four digits of the voter's Social Security number, ~~if the~~
 6.14 ~~voter has been issued a Social Security number;~~

6.15 (3) prior registration, if any; and

6.16 (4) signature.

6.17 (b) A voter registration application is not deficient due to any of the following:

6.18 (1) the absence of a zip code number ~~does not cause the registration to be deficient;~~

6.19 (2) failure to check a box on an application form that a voter has certified to be true ~~does~~
 6.20 ~~not cause the registration to be deficient;~~ or

6.21 (3) the absence of a number listed under paragraph (a), clause (2), if the voter has not
 6.22 been issued one of those numbers and the information can be verified in another government
 6.23 database associated with the applicant's name and date of birth, or the application was
 6.24 accepted before January 1, 2004.

6.25 ~~The election judges shall request an individual to correct a voter registration application~~
 6.26 ~~if it is deficient or illegible. No eligible voter may be prevented from voting unless the~~
 6.27 ~~voter's registration application is deficient or the voter is duly and successfully challenged~~
 6.28 ~~in accordance with section 201.195 or 204C.12.~~

6.29 (c) A voter registration application:

6.30 (1) accepted prior to August 1, 1983, is not deficient for lack of date of birth. The county
 6.31 or municipality may attempt to obtain the date of birth for a voter registration application

7.1 accepted prior to August 1, 1983, by a request to the voter at any time except at the polling
 7.2 place. Failure by the voter to comply with this request does not make the registration
 7.3 deficient; and

7.4 ~~A voter registration application accepted before January 1, 2004, is not deficient for lack
 7.5 of a valid Minnesota driver's license or state identification number or the last four digits of
 7.6 a Social Security number.~~

7.7 ~~A voter registration application submitted by a voter who does not have a Minnesota
 7.8 driver's license or state identification number, or a Social Security number, is not deficient
 7.9 for lack of any of these numbers.~~

7.10 ~~A voter registration application (2) submitted electronically through the website of the
 7.11 secretary of state prior to April 30, 2014, is not invalid as a result of its electronic submission.~~

7.12 (d) An election judge must request an individual to correct a voter registration application
 7.13 if it is deficient or illegible. An eligible voter must not be prevented from voting unless the
 7.14 voter's registration application is deficient or the voter's eligibility to vote is successfully
 7.15 challenged under section 201.195 or 204C.12.

7.16 Sec. 6. Minnesota Statutes 2020, section 201.071, subdivision 8, is amended to read:

7.17 Subd. 8. **School district assistance.** School districts shall assist county auditors in
 7.18 determining the school district in which a voter ~~resides~~ maintains residence.

7.19 Sec. 7. Minnesota Statutes 2020, section 201.091, subdivision 2, is amended to read:

7.20 Subd. 2. **Corrected list.** By February 15 of each year, the secretary of state shall prepare
 7.21 the master list for each county auditor. The records in the statewide registration system must
 7.22 be periodically corrected and updated by the county auditor. An updated master list for each
 7.23 precinct must be available for absentee voting at least 46 days before each election. A final
 7.24 corrected master list must be available ~~seven~~ 14 days before each election.

7.25 Sec. 8. Minnesota Statutes 2020, section 201.12, subdivision 2, is amended to read:

7.26 Subd. 2. **Moved within state.** If any nonforwardable mailing from an election official
 7.27 is returned as undeliverable but with a permanent forwarding address in this state, the county
 7.28 auditor may change the voter's status to "inactive" in the statewide registration system and
 7.29 shall transmit a copy of the mailing to the auditor of the county in which the new address
 7.30 is located. If an election is scheduled to occur in the precinct in which the voter ~~resides~~
 7.31 maintains residence in the next 47 days, the county auditor shall promptly update the voter's

8.1 address in the statewide voter registration system. If there is not an election scheduled, the
8.2 auditor may wait to update the voter's address until after the next list of address changes is
8.3 received from the secretary of state. Once updated, the county auditor shall mail to the voter
8.4 a notice stating the voter's name, address, precinct, and polling place, except that if the
8.5 voter's record is challenged due to a felony conviction, noncitizenship, name change,
8.6 incompetence, or a court's revocation of voting rights of individuals under guardianship,
8.7 the auditor must not mail the notice. The notice must advise the voter that the voter's voting
8.8 address has been changed and that the voter must notify the county auditor within 21 days
8.9 if the new address is not the voter's address of residence. The notice must state that it must
8.10 be returned if it is not deliverable to the voter at the named address.

8.11 Sec. 9. Minnesota Statutes 2020, section 201.121, subdivision 3, is amended to read:

8.12 Subd. 3. **Postelection sampling.** (a) Within ten days after an election, the county auditor
8.13 shall send the notice required by subdivision 2 to a random sampling of the individuals
8.14 registered on election day. The random sampling shall be determined in accordance with
8.15 the rules of the secretary of state. As soon as practicable after the election, the county auditor
8.16 shall mail the notice required by subdivision 2 to all other individuals registered on election
8.17 day. If a notice is returned as not deliverable, the county auditor shall attempt to determine
8.18 the reason for the return. A county auditor who does not receive or obtain satisfactory proof
8.19 of an individual's eligibility to vote shall immediately notify the county attorney of all of
8.20 the relevant information. ~~The~~ By February 15 of each odd-numbered year, the county auditor
8.21 must notify the secretary of state of the following information for the previous state general
8.22 election by each precinct:

8.23 (1) the total number of all notices that were returned as nondeliverable;

8.24 (2) the total number of nondeliverable notices that the county auditor was able to

8.26 (3) the total number of individuals for whom the county auditor does not receive or
8.27 obtain satisfactory proof of an individual's eligibility to vote.

8.28 (b) By March 1 of every odd-numbered year, the secretary of state shall report to the
8.29 chair and ranking minority members of the legislative committees with jurisdiction over
8.30 elections the following information for the previous state general election by each precinct
8.31 and each county:

8.32 (1) the total number of all notices that were returned as nondeliverable;

9.1 (2) the total number of nondeliverable notices that a county auditor was able to determine
9.2 the reason for the return along with the reason for each return; and

9.3 (3) the total number of individuals for whom the county auditor does not receive or
9.4 obtain satisfactory proof of an individual's eligibility to vote.

9.5 Sec. 10. Minnesota Statutes 2020, section 201.13, subdivision 3, is amended to read:

9.6 Subd. 3. **Use of change of address system.** (a) At least once each month the secretary
9.7 of state shall obtain a list of individuals registered to vote in this state who have filed with
9.8 the United States Postal Service a change of their permanent address. The secretary of state
9.9 may also periodically obtain a list of individuals with driver's licenses or state identification
9.10 cards to identify those who are registered to vote who have applied to the Department of
9.11 Public Safety for a replacement driver's license or state identification card with a different
9.12 address, and a list of individuals for whom the Department of Public Safety received
9.13 notification of a driver's license or state identification card cancellation due to a change of
9.14 residency out of state. However, the secretary of state shall not load data derived from these
9.15 lists into the statewide voter registration system within the 47 days before the state primary
9.16 or 47 days before a November general election.

9.17 (b) If the address is changed to another address in this state, the secretary of state shall
9.18 locate the precinct in which the voter ~~resides~~ maintains residence, if possible. If the secretary
9.19 of state is able to locate the precinct in which the voter ~~resides~~ maintains residence, the
9.20 secretary must transmit the information about the changed address by electronic means to
9.21 the county auditor of the county in which the new address is located. For addresses for
9.22 which the secretary of state is unable to determine the precinct, the secretary may forward
9.23 information to the appropriate county auditors for individual review. If the voter has not
9.24 voted or submitted a voter registration application since the address change, upon receipt
9.25 of the information, the county auditor shall update the voter's address in the statewide voter
9.26 registration system. The county auditor shall mail to the voter a notice stating the voter's
9.27 name, address, precinct, and polling place, unless the voter's record is challenged due to a
9.28 felony conviction, noncitizenship, name change, incompetence, or a court's revocation of
9.29 voting rights of individuals under guardianship, in which case the auditor must not mail the
9.30 notice. The notice must advise the voter that the voter's voting address has been changed
9.31 and that the voter must notify the county auditor within 21 days if the new address is not
9.32 the voter's address of residence. The notice must state that it must be returned if it is not
9.33 deliverable to the voter at the named address.

10.1 (c) If the change of permanent address is to an address outside this state, the secretary
10.2 of state shall notify by electronic means the auditor of the county where the voter formerly
10.3 ~~resided~~ maintained residence that the voter has moved to another state. If the voter has not
10.4 voted or submitted a voter registration application since the address change, the county
10.5 auditor shall promptly mail to the voter at the voter's new address a notice advising the voter
10.6 that the voter's status in the statewide voter registration system will be changed to "inactive"
10.7 unless the voter notifies the county auditor within 21 days that the voter is retaining the
10.8 former address as the voter's address of residence, except that if the voter's record is
10.9 challenged due to a felony conviction, noncitizenship, name change, incompetence, or a
10.10 court's revocation of voting rights of individuals under guardianship, the auditor must not
10.11 mail the notice. If the notice is not received by the deadline, the county auditor shall change
10.12 the voter's status to "inactive" in the statewide voter registration system.

10.13 (d) If, in order to maintain voter registration records, the secretary of state enters an
10.14 agreement to share information or data with an organization governed exclusively by a
10.15 group of states, the secretary must first determine that the data security protocols are sufficient
10.16 to safeguard the information or data shared. If required by such an agreement, the secretary
10.17 of state may share the following data from the statewide voter registration system and data
10.18 released to the secretary of state under section 171.12, subdivision 7a:

10.19 (1) name;

10.20 (2) date of birth;

10.21 (3) address;

10.22 (4) driver's license or state identification card number;

10.23 (5) the last four digits of an individual's Social Security number; and

10.24 (6) the date that an individual's record was last updated.

10.25 If the secretary of state enters into such an agreement, the secretary and county auditors
10.26 must process changes to voter records based upon that data in accordance with this section.
10.27 Except as otherwise provided in this subdivision, when data is shared with the secretary of
10.28 state by another state, the secretary of state must maintain the same data classification that
10.29 the data had while it was in the possession of the state providing the data.

10.30 Sec. 11. Minnesota Statutes 2020, section 201.1611, subdivision 1, is amended to read:

10.31 Subdivision 1. **Forms.** All postsecondary institutions that enroll students accepting state
10.32 or federal financial aid shall provide voter registration forms to each student as early as

11.1 possible in the fall quarter. All school districts shall make available voter registration
11.2 applications each May and September to all students registered as students of the school
11.3 district who will be eligible to vote at the next election after those months. A school district
11.4 has no obligation to provide voter registration applications to students who participate in a
11.5 postsecondary education option program or who otherwise ~~reside~~ maintain residence in the
11.6 district but do not attend a school operated by the district. A school district fulfills its
11.7 obligation to a student under this section if it provides a voter registration application to the
11.8 student one time. The forms must contain spaces for the information required in section
11.9 201.071, subdivision 1, and applicable rules of the secretary of state. The institutions and
11.10 school districts may request these forms from the secretary of state. Institutions shall consult
11.11 with their campus student government in determining the most effective means of distributing
11.12 the forms and in seeking to facilitate election day registration of students under section
11.13 201.061, subdivision 3. School districts must advise students that completion of the voter
11.14 registration application is not a school district requirement.

11.15 Sec. 12. Minnesota Statutes 2020, section 201.225, subdivision 2, is amended to read:

11.16 Subd. 2. **Technology requirements.** An electronic roster must:

11.17 (1) be able to be loaded with a data file that includes voter registration data in a file
11.18 format prescribed by the secretary of state;

11.19 (2) allow for data to be exported in a file format prescribed by the secretary of state;

11.20 (3) allow for data to be entered manually or by scanning a Minnesota driver's license or
11.21 identification card to locate a voter record or populate a voter registration application that
