1.5	Section 1. COUNTY RELIEF GRANTS TO LOCAL BUSINESSES;
1.6	APPROPRIATION.
1.7	(a) \$50,000,000 in fiscal year 2021 is appropriated from the general fund to the
1.8	commissioner of revenue for payments to counties for relief grants to local businesses. This
1.9	is a onetime appropriation.
1.10	(b) Each county shall be issued a payment in the amount of \$100,000 or a per capita
1.11	amount determined by reference to the population of each county according to the most
1.12	recently available 2019 population estimate from the state demographer as of December 1,
1.13	2020, whichever is greater.
1.14	(c) Each county may use the greater of \$6,250 or 2.5 percent of the amount received
1.15	under paragraph (b) for administrative costs incurred from making grants under this section.
1.16	A county may contract with a third party to administer the grant program on behalf of the
1.17	county.
1.18	(d) Counties shall use the funds to make grants to individual businesses, nonprofits, and
1.19	establishments operated by congressionally chartered veteran's organizations that, to the
1.20	extent it is feasible for the county to determine:
