BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. REPORT ON EMPLOYER-PROVIDED CHILD CARE. 1.4 (a) By December 15, 2017, the commissioner of employment and economic development, 1.5 in consultation with the commissioner of human services, shall report to the chairs and 1.6 ranking minority members of the committees of the house of representatives and senate 17 with jurisdiction over jobs, economic development, and human services on the most efficient 1.8 and effective incentives to encourage employers to provide child care for their employees. 1.9 1.10 (b) The report must include analysis of the following, and must examine if different approaches are more appropriate for greater Minnesota compared with the seven-county 1.11 1.12 metropolitan area: (1) existing incentives and employer-provided child care facilities in the United States, 1.13 including in Minnesota; 1.14 (2) effectiveness of various incentives in producing more employer-provided child care 1.15 for employees, including projected cost to the state and costs and benefits to the employer 1.16 and to employees; 1.17 (3) costs and benefits of providing incentives only for start-up or expansion of new 1.18 employer-provided child care facilities, compared with incentives for start-up, expansion, 1.19 and operation of new employer-provided child care facilities; and 1.20

2.16	onetime appropriation.
