Legacy Initiative. 1.3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. URBAN INDIGENOUS LEGACY INITIATIVE; APPROPRIATION. 1.5 Subdivision 1. Scope. \$136,361,500 in fiscal year 2024 is appropriated to the 1.6 commissioner of employment and economic development to make grants to 501(c)(3) 1.7 nonprofit organizations providing critical services to the Twin Cities Native American 1.8 1.9 community, as provided in this section. Unless otherwise specified, all appropriations in this section are onetime and are available until the project is completed or abandoned, subject 1.10 to Minnesota Statutes, section 16A.642. 1.11 Subd. 2. American Indian Community Development Center. \$6,500,000 is for a grant 1.12 to the American Indian Community Development Center (AICDC) for acquisition, predesign, 1.13 and design of a 21,825-square-foot Native American-specific inpatient opioid treatment 1.14 facility. The treatment facility and programming for the facility shall be developed in 1.15 collaboration with Tribal Nations and Legacy organizations. 1.16 Subd. 3. Oyate Ota Center. \$37,000,000 is for a grant to the Montessori American 1.17 Indian Child Care Center to acquire, predesign, design, construct, furnish, and equip the 1.18 Oyate Ota Center, an American Indian Community Center in the city of St. Paul. Benjamin Youth Lodge at 1212 Raymond 2.5 Avenue, St. Paul.
