1.6	Subdivision 1. Transfer. \$300,000 in fiscal year 2022 is transferred from the consumer
1.7	education account in the special revenue fund to the general fund.
1.8	Subd. 2. Appropriation. \$300,000 in fiscal year 2022 is appropriated from the general
1.9	fund to the commissioner of education to issue the grants in subdivision 3. This balance
1.10	does not cancel but is available in the second year.
