1.13	interrupt device includes a device commonly referred to as a fuel or ignition kill switch.

- 4.4 (4) with respect to the brakes, the master cylinder, vacuum assist booster, wheel cylinders,

4.10 (e)(1) A dealer's obligations under the express warranty remain in effect notwithstanding
4.11 the fact that the warranty period has expired, if the consumer promptly notified the dealer
4.12 of the malfunction, defect, or failure in the covered part within the specified warranty period
4.13 and, within a reasonable time after notification, brings the vehicle or arranges with the dealer
4.14 to have the vehicle brought to the dealer for inspection and repair.

- 4.15 (2) If a dealer does not have a repair facility, the dealer shall designate where the vehicle4.16 must be taken for inspection and repair.
- 4.17 (3) In the event the malfunction, defect, or failure in the covered part occurs at a location
 4.18 which makes it impossible or unreasonable to return the vehicle to the selling dealer, the
 4.19 consumer may have the repairs completed elsewhere with the consent of the selling dealer,
 4.20 which consent may not be unreasonably withheld.

4.21 (4) Notwithstanding the provisions of this paragraph, a consumer may have nonwarranty
4.22 maintenance and nonwarranty repairs performed other than by the selling dealer and without
4.23 the selling dealer's consent.

4.24 (f) Nothing in this section diminishes the obligations of a manufacturer under an express
4.25 warranty issued by the manufacturer. The express warranties created by this section do not
4.26 require a dealer to repair or replace a covered part if the repair or replacement is covered
4.27 by a manufacturer's new car warranty, or the manufacturer otherwise agrees to repair or
4.28 replace the part.

4.29 (g) The express warranties created by this section do not cover defects or repair problems
4.30 which result from collision, abuse, negligence, or lack of adequate maintenance following
4.31 sale to the consumer.

parts covered, must be fully, accurately, and conspicuously disclosed by the dealer on the
front of the Buyers Guide.

- 5.4 Sec. 5. Minnesota Statutes 2022, section 325F.662, subdivision 3, is amended to read:
- 5.5 Subd. 3. Exclusions. Notwithstanding the provisions of subdivision 2, a dealer is not
 5.6 required to provide an express warranty for a used motor vehicle:
- 5.7 (1) except for a used motor vehicle described in subdivision 2, paragraph (a), clause (3),
 5.8 sold for a total cash sale price of less than \$3,000, including the trade-in value of any vehicle
 5.9 traded in by the consumer, but excluding tax, license fees, registration fees, and finance
 5.10 charges;
- 5.11 (2) with an engine designed to use diesel fuel;
- 5.12 (3) with a gross weight, as defined in section 168.002, subdivision 13, in excess of 9,000
 5.13 pounds;
- 5.14 (4) that has been custom-built or modified for show or for racing;
- 5.15 (5) except for a used motor vehicle described in subdivision 2, paragraph (a), clause (3),
 5.16 that is eight years of age or older, as calculated from the first day in January of the designated
 5.17 model year of the vehicle;
- 5.18 (6) that has been produced by a manufacturer which has never manufactured more than
 5.19 10,000 motor vehicles in any one year;
- 5.20 (7) that has 75,000 miles or more at time of sale;

5.21 (8) (7) that has not been manufactured in compliance with applicable federal emission
5.22 standards in force at the time of manufacture as provided by the Clean Air Act, United
5.23 States Code, title 42, sections 7401 through 7642, and regulations adopted pursuant thereto,
5.24 and safety standards as provided by the National Traffic and Motor Safety Act, United
5.25 States Code, title 15, sections 1381 through 1431, and regulations adopted pursuant thereto;
