1.7	(a) The commissioner of human services shall:
1.8	(1) increase reimbursement rates, grants, or allocations by 3.09 percent for services
1.9	provided on or after July 1, 2017;
1.10 1.11	(2) increase reimbursement rates, grants, or allocations by 0.1 percent for services provided on or after July 1, 2018; and
1.12	(3) increase the reimbursement rates, grants, or allocations by an additional ten percent
