- 1.2 relating to barbers; repealing rule that precludes mobile barber shops; setting
- 1.3 registration and renewal fees for mobile barber shops; authorizing rulemaking;
- 1.4 amending Minnesota Statutes 2016, section 154.003; repealing Minnesota Rules,
- 1.5 part 2100.7000.
- 1.6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
- 1.7 Section 1. Minnesota Statutes 2016, section 154.003, is amended to read:
- 1.8 **154.003 FEES.**
- 1.9 (a) The fees collected, as required in this chapter, chapter 214, and the rules of the board,
- 1.10 shall be paid to the board. The board shall deposit the fees in the general fund in the state
- 1.11 treasury.
- 1.12 (b) The board shall charge the following fees:
- 1.13 (1) examination and certificate, registered barber, \$85;
- 1.14 (2) retake of written examination, \$10;
- 1.15 (3) examination and certificate, instructor, \$180;
- 1.16 (4) certificate, instructor, \$65;
- 1.17 (5) temporary teacher permit, \$80;
- 1.18 (6) temporary registered barber, military, \$85;
- 1.19 (7) temporary barber instructor, military, \$180;
- 1.20 (8) renewal of registration, registered barber, \$80;
- 1.21 (9) renewal of registration, instructor, \$80;

- 2.1 (10) renewal of temporary teacher permit, \$65;
- 2.2 (11) student permit, \$45;
- 2.3 (12) renewal of student permit, \$25;
- 2.4 (13) initial shop registration, \$85;
- 2.5 (14) initial school registration, \$1,030;
- 2.6 (15) renewal shop registration, \$85;
- 2.7 (16) renewal school registration, \$280;
- 2.8 (17) restoration of registered barber registration, \$95;
- 2.9 (18) restoration of shop registration, \$105;
- 2.10 (19) initial mobile barber shop registration, \$85;
- 2.11 (20) renewal mobile barber shop registration, \$85;
- 2.12 (21) change of ownership or location, \$55;
- 2.13 ~~(20)~~ (22) duplicate registration, \$40;
- 2.14 ~~(21)~~ (23) home study course, \$75;
- 2.15 ~~(22)~~ (24) letter of registration verification, \$25; and
- 2.16 ~~(23)~~ (25) reinspection, \$100.

2.17 Sec. 2. **RULEMAKING.**

2.18 The Board of Barber Examiners shall establish rules regulating mobile barber shops.

2.19 Sec. 3. **REPEALER.**

2.20 Minnesota Rules, part 2100.7000, is repealed.

2.21 **EFFECTIVE DATE.** This section is effective the day following final enactment.

Repealed Minnesota Rule: SF2097-0

2100.7000 PERMANENT LOCATION.

Each barber shop in the state of Minnesota must be permanently located at one address, due to the difficulty of implementation of inspection procedures.
