1.6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.7 Section 1. Minnesota Statutes 2022, section 124D.65, subdivision 5, is amended to read:

1.8 Subd. 5. **School district EL revenue.** (a) A district's English learner programs revenue

1.9 equals the sum of:

1.10 (1) the product of ~~(1) \$704 times~~ (2) (i) \$1,000 and (ii) the greater of 20 or the adjusted

1.11 average daily membership of eligible English learners enrolled in the district during the

1.12 current fiscal year;

1.13 (2) \$250 times the English learner pupil units under section 126C.05, subdivision 17;

1.14 and

1.15 (3) the district's English learner cross subsidy aid. A district's English learner cross

1.16 subsidy aid under paragraph (b) equals:

1.17 (i) 25 percent of the district's English learner cross subsidy for fiscal year 2024;

1.18 (ii) 50 percent of the district's English learner cross subsidy for fiscal year 2025;

1.19 (iii) 75 percent of the district's English learner cross subsidy for fiscal year 2026; and

1.20 (iv) 100 percent of the district's English learner cross subsidy for fiscal years 2027 and

1.21 later.

2.1 (b) A district's English learner cross subsidy aid equals the greater of zero or the difference
 2.2 between the district's expenditure for qualifying English learner services for the second
 2.3 previous year and the district's English learner revenue for the second previous year.

2.4 ~~(b)~~ (c) A pupil ceases to generate state English learner aid in the school year following
 2.5 the school year in which the pupil attains the state cutoff score on a commissioner-provided
 2.6 assessment that measures the pupil's emerging academic English.
