1.6	Subdivision 1. Definitions. (a) For purposes of this section, the terms defined in
1.7	this subdivision have the meanings given.
1.8	(b) "Automated drug distribution system" means a mechanical system that:
1.9	(1) dispenses prescription drugs; and
1.10	(2) maintains related transaction information as described in subdivision 6.
1.11	(c) "Health care facility" means a health care facility licensed under chapter 144
1.12	<u>or 144A.</u>
1.13	Subd. 2. Authorization. (a) A pharmacy may provide pharmacy services through
1.14	an automated drug distribution system located in a health care facility that is not at the
1.15	same location as the pharmacy.
1.16	(b) Access to and dispensing from an automated drug distribution system shall be
1.17	limited to pharmacy and nonpharmacy personnel who are designated in writing by the
1.18	pharmacist in charge and are authorized to procure drugs from the system in accordance

1.20	(c) Drugs may only be dispensed from an automated drug distribution system after
1.21	receipt of an original prescription drug order by a pharmacist.

2.2	distribution system may be filled with drugs stored in bulk at the health care facility. If

2.4	shall not be deemed a pharmacy, a wholesale drug distributor, or a drug manufacturer for

2.6	Subd. 3. Supervision. The automated drug distribution system is required to be
2.7	under continuous supervision of a pharmacist. To qualify as continuous supervision,
2.8	the pharmacist is not required to be physically present at the site of the automated drug
2.9	distribution system if the system is supervised by a pharmacist electronically.
2.10	Subd. 4. Storage. All drugs stored in relation to an automated drug distribution
2.11	system must be stored in compliance with this chapter and rules adopted by the board.
2.12	Subd. 5. Security. An automated drug distribution system must be secured or, if not
2.13	secure, kept in a locked medication room when not in actual use.
2.14	Subd. 6. Records. (a) At a minimum, an automated drug distribution system must

2.17	(2) the date and time of access;

2.21	(5) any additional information the pharmacist in charge deems necessary.
2.22	(b) These records shall be reviewed for discrepancies on a periodic basis. The
2.23	pharmacist in charge is responsible for the quality, accuracy, and timeliness of the review
2.24	and must ensure that appropriate actions are taken to deal with any discrepancies found.
2.25	(c) The automated drug distribution system must provide for maintenance of patient
2.26	confidentiality so that unauthorized individuals do not have access to patient data.
