- (b) Once registered, control of a candidate's principal campaign committee may not be transferred to another candidate. Assets of a principal campaign committee may only be transferred to another candidate's principal campaign committee to the extent expressly authorized by this chapter.
- 2.10 (b) (c) This subdivision does not apply to ballot question or independent expenditure political committees or funds, which are subject to subdivision 1a.
