Any individual may file a petition in the manner provided in this section for the

- 1.21 correction of any of the following errors, omissions, or wrongful acts which have occurred
- 1.22 or are about to occur:
- 1.23 (a) an error or omission in the placement or printing of the name or description of
- 1.24 any candidate or any question on any official ballot;
- 1.25 (b) any other error in preparing or printing any official ballot;
- 1.26 (c) failure of the chair or secretary of the proper committee of a major political party
- 1.27 to execute or file a certificate of nomination;

2.1 (d) any wrongful act, omission, or error of any election judge, municipal clerk,
2.2 county auditor, canvassing board or any of its members, the secretary of state, or any other
2.3 individual charged with any duty concerning an election.

The petition shall describe the error, omission, or wrongful act and the correction 2.4 sought by the petitioner. The petition shall be filed with any judge of the Supreme Court in 2.5 the case of an election for state or federal office or any judge of the district court in that 2.6 county in the case of an election for county, municipal, or school district office. The 2.7 petitioner shall serve a copy of the petition on the officer, board or individual charged with 2.8 the error, omission, or wrongful act, on all candidates for the office in the case of an election 2.9 for state, federal, county, municipal, or school district office, and on any other party as 2.10 required by the court. Upon receipt of the petition the court shall immediately set a time 2.11 for a hearing on the matter and order the officer, board or individual charged with the error, 2.12 omission or wrongful act to correct the error or wrongful act or perform the duty or show 2.13 cause for not doing so. The court shall issue its findings and a final order for appropriate 2.14 2.15 relief as soon as possible after the hearing. Failure to obey the order is contempt of court.

Unless specifically required by court rule, a pleading, motion, affidavit, or other 2.23 document filed with a court of the Minnesota judicial branch is not required to be 2.24 notarized. Signing a document filed with the court constitutes "verification upon oath or 2.25 affirmation" as defined in section 358.41, clause (3), without administration of an oath 2.26 under section 358.07, provided that the signature, as defined by court rules, is affixed 2.27 immediately below a declaration using substantially the following language: "I declare 2.28 under penalty of perjury that everything I have stated in this document is true and correct." 2.29 In addition to the signature, the date of signing and the county and state where the 2.30 document was signed shall be noted on the document. A person who signs knowing that 2.31 the document is false in any material respect is guilty of perjury under section 609.48, 2.32 even if the date, county, and state of signing are omitted from the document. 2.33

A copy of such record, or of any document which is made evidence by law and 5.34 is preserved in the office or place where the same was required or is permitted to be filed 5.35 or kept, or a copy of any authorized record of such document so preserved, when certified
