A bill for an act

relating to unemployment insurance; making federal conformity, policy, and other housekeeping changes; amending Minnesota Statutes 2010, sections 268.035, subdivision 12d; 268.042, subdivision 1; 268.044, subdivision 1; 268.046, subdivision 3; 268.047, subdivision 4; 268.051, subdivision 4; 268.069, subdivision 2; 268.085, subdivisions 5, 11, 15; 268.095, subdivision 6; 268.103, subdivision 1; 268.18, subdivisions 2, 2b, 4, 4a; 268.192, by adding a subdivision; 268.194, subdivision 1; Minnesota Statutes 2011 Supplement, sections 268.035, subdivision 20; 268.051, subdivision 5; 268.07, subdivision 2; 268.115, subdivision 1; 268.184, subdivisions 1, 1a; repealing Minnesota Rules, part 3315.0555, subparts 2, 3, 4.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

**ARTICLE 1**

**FEDERAL CONFORMITY**

Section 1. Minnesota Statutes 2010, section 268.047, subdivision 4, is amended to read:

Subd. 4. **Limitation on exceptions.** (a) Regardless of subdivisions 2 and 3, an exception under those subdivisions will be limited in accordance with according to section 268.101, subdivision 2, paragraph (b).

(b) Regardless of subdivision 2, clause (8), an exception under that clause does not apply if the overpaid unemployment benefits resulted because the employer or any employee, officer, or agent of the employer:

(1) failed to respond timely or adequately to a request for information under section 268.101, subdivision 1, paragraph (b); and

(2) has established a pattern of failing to respond timely or adequately to requests for information under section 268.101, subdivision 1, paragraph (b).

2.1 The employer must pay the trust fund the amount of the overpaid unemployment  
2.2 benefits that will be used in computing the future tax rate of taxpaying employers or  
2.3 charged to the reimbursable account of a nonprofit or government employer under  
2.4 subdivision 1. The procedure for required payment is under section 268.184, subdivision 1.

2.5 This paragraph is enacted to conform to the requirements of Public Law 112-40,  
2.6 section 252. A "pattern" for purposes of this paragraph is a prior failure to respond to the  
2.7 greater of two requests for information, or two percent of all requests for information in  
2.8 the most recent six months.

2.9 **EFFECTIVE DATE.** This section is effective for determinations issued on or  
2.10 after July 1, 2013.

2.11 Sec. 2. Minnesota Statutes 2010, section 268.18, subdivision 2, is amended to read:

2.12 Subd. 2. **Overpayment because of fraud.** (a) Any applicant who receives  
2.13 unemployment benefits by knowingly misrepresenting, misstating, or failing to disclose  
2.14 any material fact, or who makes a false statement or representation without a good faith  
2.15 belief as to the correctness of the statement or representation, has committed fraud. After  
2.16 the discovery of facts indicating fraud, the commissioner must make a determination  
2.17 that the applicant obtained unemployment benefits by fraud and that the applicant must  
2.18 promptly repay the unemployment benefits to the trust fund. In addition, the commissioner  
2.19 must assess a penalty equal to 40 percent of the amount fraudulently obtained. This  
2.20 penalty is in addition to penalties under section 268.182. The determination is effective  
2.21 the Sunday of the week that it was issued.

2.22 (b) Unless the applicant files an appeal within 20 calendar days after the sending  
2.23 of the determination of overpayment by fraud to the applicant by mail or electronic  
2.24 transmission, the determination is final. Proceedings on the appeal are conducted in  
2.25 accordance with section 268.105.

2.26 (c) If the applicant fails to repay the unemployment benefits, penalty, and interest  
2.27 assessed, the total due may be collected by the methods allowed under state and federal  
2.28 law. A determination of overpayment by fraud must state the methods of collection the  
2.29 commissioner may use to recover the overpayment. Money received in repayment of  
2.30 fraudulently obtained unemployment benefits, penalties, and interest is first applied to the  
2.31 unemployment benefits overpaid, then to the penalty amount due, then to any interest due.  
2.32 62.5 percent of the payments made toward the penalty are credited to the contingent  
2.33 account and 37.5 percent credited to the ~~administration account~~ trust fund.

2.34 (d) If an applicant has been overpaid unemployment benefits under the law of  
2.35 another state because of fraud and that state certifies that the applicant is liable to repay

3.1 the unemployment benefits and requests the commissioner to recover the overpayment,  
3.2 the commissioner may offset from future unemployment benefits otherwise payable the  
3.3 amount of overpayment.

3.4 (e) Regardless of the limitations in section 268.101, subdivision 2, paragraph  
3.5 (e), unemployment benefits paid for weeks more than four years before the date of a  
3.6 determination of overpayment by fraud issued under this subdivision are not considered  
3.7 overpaid unemployment benefits.

3.8 **EFFECTIVE DATE.** The amendments to paragraph (c) are effective for any  
3.9 money credited on or after July 1, 2013. The amendments to paragraph (e) are effective  
3.10 July 1, 2012.

3.11 Sec. 3. Minnesota Statutes 2011 Supplement, section 268.184, subdivision 1, is  
3.12 amended to read:

3.13 Subdivision 1. **Administrative penalties.** (a) The commissioner must penalize  
3.14 an employer if that employer or any employee, officer, or agent of that employer, is  
3.15 in collusion with any applicant for the purpose of assisting the applicant to receive  
3.16 unemployment benefits fraudulently. The penalty is \$500 or the amount of unemployment  
3.17 benefits determined to be overpaid, whichever is greater.

3.18 (b) The commissioner must penalize an employer if that employer or any employee,  
3.19 officer, or agent of that employer (1) made a false statement or representation knowing it  
3.20 to be false, (2) made a false statement or representation without a good faith belief as to  
3.21 correctness of the statement or representation, (3) knowingly failed to disclose a material  
3.22 fact, or (4) made an offer of employment to an applicant when, in fact, the employer had  
3.23 no employment available, ~~but only if the employer's action:~~

3.24 ~~(i) was taken to prevent or reduce the payment of unemployment benefits to any~~  
3.25 ~~applicant;~~

3.26 ~~(ii) was taken to reduce or avoid any payment required from an employer under~~  
3.27 ~~this chapter or section 116L.20; or~~

3.28 ~~(iii) caused an overpayment of unemployment benefits to an applicant.~~

3.29 The penalty is the greater of \$500, or 50 percent of the overpaid or reduced unemployment  
3.30 benefits or payment required, whichever is greater. following resulting from the  
3.31 employer's action:

3.32 (i) the amount of any overpaid unemployment benefits to an applicant;

3.33 (ii) the amount of unemployment benefits not paid to an applicant that would  
3.34 otherwise have been paid; or

4.1 (iii) the amount of any payment required from the employer under this chapter or  
4.2 section 116L.20 that was not paid.

4.3 (c) The commissioner must penalize an employer if that employer failed or refused  
4.4 to honor a subpoena issued under section 268.105, subdivision 4, or section 268.188. The  
4.5 penalty is \$500 and any costs of enforcing the subpoena, including attorney fees.

4.6 (d) Penalties under this subdivision and under section 268.047, subdivision 4,  
4.7 paragraph (b), are in addition to any other penalties and subject to the same collection  
4.8 procedures that apply to past due taxes. Penalties must be paid within 30 calendar days  
4.9 of ~~assessment~~ issuance of the determination of penalty and credited to the ~~contingent~~  
4.10 ~~account~~ trust fund.

4.11 (e) The determination of ~~the~~ penalty is final unless the employer files an appeal  
4.12 within 20 calendar days after the sending of the determination of ~~the~~ penalty to the  
4.13 employer by mail or electronic transmission. Proceedings on the appeal are conducted in  
4.14 accordance with section 268.105.

4.15 **EFFECTIVE DATE.** This section is effective July 1, 2012, except the amendments  
4.16 to paragraph (d) are effective for penalties imposed on or after July 1, 2013.

## 4.17 **ARTICLE 2**

### 4.18 **POLICY**

4.19 Section 1. Minnesota Statutes 2010, section 268.046, subdivision 3, is amended to read:

4.20 Subd. 3. **Penalties; application.** (a) Any person that violates the requirements  
4.21 of this section and any taxpaying employer that violates subdivision 1, paragraph (b),  
4.22 or any nonprofit or government employer that violates subdivision 2, paragraph (b), is  
4.23 subject to the penalties under section 268.184, subdivision 1a. Penalties are credited to  
4.24 the ~~administration account to be used to ensure integrity in the unemployment insurance~~  
4.25 ~~program~~ trust fund.

4.26 (b) Section 268.051, subdivision 4, does not apply to contracts under this section.  
4.27 This section does not limit or prevent the application of section 268.051, subdivision 4, to  
4.28 any other transactions or acquisitions involving the taxpaying employer. This section does  
4.29 not limit or prevent the application of section 268.051, subdivision 4a.

4.30 (c) An assignment of an account upon the execution of a contract under this section  
4.31 and a termination of a contract with the corresponding assignment of the account is not  
4.32 considered a separation from employment of any worker covered by the contract. Nothing  
4.33 under this subdivision causes the person to be liable for any amounts past due under this  
4.34 chapter from the taxpaying employer or the nonprofit or government employer.

5.1 (d) This section applies to, but is not limited to, persons registered under section  
5.2 79.255, but does not apply to persons that obtain an exemption from registration under  
5.3 section 79.255, subdivision 9.

5.4 **EFFECTIVE DATE.** This section is effective July 1, 2013.

5.5 Sec. 2. Minnesota Statutes 2010, section 268.051, subdivision 4, is amended to read:

5.6 Subd. 4. **Experience rating history transfer.** (a) The experience rating history of  
5.7 the predecessor employer is transferred to the successor employer when:

5.8 (1) a taxpaying employer acquires all of the organization, trade or business, or  
5.9 workforce of another taxpaying employer; and

5.10 (2) there is 25 percent or more common ownership or there is substantially common  
5.11 management or control between the predecessor and successor, ~~the experience rating~~  
5.12 ~~history of the predecessor employer is transferred to the successor employer.~~

5.13 (b) A portion of the experience rating history of the predecessor employer is  
5.14 transferred to the successor employer when:

5.15 (1) a taxpaying employer acquires a portion, but less than all, of the organization,  
5.16 trade or business, or workforce of another taxpaying employer; and

5.17 (2) there is 25 percent or more common ownership or there is substantially common  
5.18 management or control between the predecessor and successor, the successor employer  
5.19 acquires, as of the date of acquisition, the experience rating history attributable to the  
5.20 portion it acquired, and the predecessor employer retains the experience rating history  
5.21 attributable to the portion that it has retained. If the commissioner determines that  
5.22 sufficient information is not available to substantiate that a distinct severable portion  
5.23 was acquired and to assign the appropriate distinct severable portion of the experience  
5.24 rating history, the commissioner must assign the successor employer that percentage  
5.25 of the predecessor employer's experience rating history equal to that percentage of  
5.26 the employment positions it has obtained, and the predecessor employer retains that  
5.27 percentage of the experience rating history equal to the percentage of the employment  
5.28 positions it has retained.

5.29 (c) The term "common ownership" for purposes of this subdivision includes  
5.30 ownership by a spouse, parent, grandparent, child, grandchild, brother, sister, aunt, uncle,  
5.31 niece, nephew, or first cousin, by birth or by marriage.

5.32 (d) Each successor employer that is subject to paragraph (a) or (b) must notify the  
5.33 commissioner of the acquisition by electronic transmission, in a format prescribed by the  
5.34 commissioner, within 30 calendar days of the date of acquisition. Any successor employer  
5.35 that fails to notify the commissioner is subject to the penalties under section 268.184,

6.1 subdivision 1a, if the successor's assigned tax rate under subdivision 2 or 5 was lower than  
6.2 the predecessor's assigned tax rate at the time of the acquisition. Payments made toward  
6.3 the penalties are credited to the ~~administration account to be used to ensure integrity in the~~  
6.4 ~~unemployment insurance program~~ trust fund.

6.5 (e) If the successor employer under paragraphs (a) and (b) had an experience rating  
6.6 at the time of the acquisition, the transferred experience rating history of the predecessor  
6.7 is combined with the successor's experience rating history for purposes of recomputing  
6.8 a tax rate.

6.9 (f) If there has been a transfer of an experience rating history under paragraph (a) or  
6.10 (b), employment with a predecessor employer is not considered to have been terminated if  
6.11 similar employment is offered by the successor employer and accepted by the employee.

6.12 (g) The commissioner, upon notification of an employer, or upon the commissioner's  
6.13 own motion if the employer fails to provide the required notification, must determine if an  
6.14 employer is a successor within the meaning of this subdivision. The commissioner must,  
6.15 after determining the issue of succession or nonsuccession, recompute the tax rate under  
6.16 subdivision 6 of all employers affected. The commissioner must send the recomputed tax  
6.17 rate to all affected employers by mail or electronic transmission. Any affected employer  
6.18 may appeal the recomputed tax rate in accordance with the procedures in subdivision 6,  
6.19 paragraph (c).

6.20 (h) The "experience rating history" for purposes of this subdivision and subdivision  
6.21 4a means the amount of unemployment benefits paid and the taxable wages that are being  
6.22 used and would be used in computing the current and any future experience rating.

6.23 For purposes of this chapter, an "acquisition" means anything that results in the  
6.24 obtaining by the successor employer, in any way or manner, of the organization, trade or  
6.25 business, or workforce of the predecessor employer.

6.26 A "distinct severable portion" in paragraph (b) means a location or unit separately  
6.27 identifiable within the employer's wage detail report under section 268.044.

6.28 (i) Regardless of the ownership, management, or control requirements of paragraph  
6.29 (a), if there is an acquisition or merger of a publicly held corporation by or with another  
6.30 publicly held corporation the experience rating histories of the corporations are combined  
6.31 as of the date of acquisition or merger for the purpose of recomputing a tax rate.

6.32 **EFFECTIVE DATE.** This section is effective July 1, 2012, except that the  
6.33 amendments to paragraph (d) are effective July 1, 2013.

6.34 Sec. 3. Minnesota Statutes 2011 Supplement, section 268.051, subdivision 5, is  
6.35 amended to read:

7.1 Subd. 5. **Tax rate for new employers.** (a) Each new taxpaying employer that does  
7.2 not qualify for an experience rating under subdivision 3, except new employers in a high  
7.3 experience rating industry, must be assigned, for a calendar year, a tax rate the higher of  
7.4 (1) one percent, or (2) the tax rate computed, to the nearest 1/100 of a percent, by dividing  
7.5 the total amount of unemployment benefits paid all applicants during the 48 calendar  
7.6 months ending on June 30 of the prior calendar year by the total taxable wages of all  
7.7 taxpaying employers during the same period, plus the applicable base tax rate and any  
7.8 additional assessments under subdivision 2, paragraph (c).

7.9 (b) Each new taxpaying employer in a high experience rating industry that does not  
7.10 qualify for an experience rating under subdivision 3, must be assigned, for a calendar year,  
7.11 a tax rate the higher of (1) that assigned under paragraph (a), or (2) the tax rate, computed  
7.12 to the nearest 1/100 of a percent, by dividing the total amount of unemployment benefits  
7.13 paid to all applicants from high experience rating industry employers during the 48  
7.14 calendar months ending on June 30 of the prior calendar year by the total taxable wages  
7.15 of all high experience rating industry employers during the same period, to a maximum  
7.16 provided for under subdivision 3, paragraph (b), plus the applicable base tax rate and any  
7.17 additional assessments under subdivision 2, paragraph (c).

7.18 (c) An employer is considered to be in a high experience rating industry if:

7.19 (1) the employer is engaged in residential, commercial, or industrial construction,  
7.20 including general contractors;

7.21 (2) the employer is engaged in sand, gravel, or limestone mining;

7.22 (3) the employer is engaged in the manufacturing of concrete, concrete products,  
7.23 or asphalt; or

7.24 (4) the employer is engaged in road building, repair, or resurfacing, including bridge  
7.25 and tunnels and residential and commercial driveways and parking lots.

7.26 (d) Regardless of any law to the contrary, a taxpaying employer must be assigned a  
7.27 tax rate under this subdivision if:

7.28 (1) the employer registers for a tax account under section 268.042 and for each of  
7.29 the five calendar quarters after registering files a "no wages paid" report on wage detail  
7.30 under section 268.044; or

7.31 (2) the employer has filed 14 consecutive quarterly "no wages paid" reports on  
7.32 wage detail under section 268.044.

7.33 ~~(d)~~ (e) The commissioner must send to the new employer, by mail or electronic  
7.34 transmission, a determination of tax rate assigned. An employer may appeal the  
7.35 determination of a tax rate in accordance with the procedures in subdivision 6, paragraph  
7.36 (c).

8.1 EFFECTIVE DATE. This section is effective July 1, 2012.

8.2 Sec. 4. Minnesota Statutes 2010, section 268.085, subdivision 5, is amended to read:

8.3 Subd. 5. **Deductible earnings.** (a) If the applicant has earnings, including holiday  
8.4 pay, with respect to any week, from employment, covered employment, noncovered  
8.5 employment, self-employment, or volunteer work, equal to or in excess of the applicant's  
8.6 weekly unemployment benefit amount, the applicant is ineligible for unemployment  
8.7 benefits for that week.

8.8 (b) If the applicant has earnings, with respect to any week, that is less than  
8.9 the applicant's weekly unemployment benefit amount, from employment, covered  
8.10 employment, noncovered employment, self-employment, or volunteer work, ~~55~~50 percent  
8.11 of the earnings are deducted from the weekly unemployment benefit amount.

8.12 (c) No deduction is made from an applicant's weekly unemployment benefit amount  
8.13 for earnings from service in the National Guard or a United States military reserve unit or  
8.14 from direct service as a volunteer firefighter or volunteer ambulance service personnel.  
8.15 This exception to paragraphs (a) and (b) does not apply to on-call or standby pay provided  
8.16 to a volunteer firefighter or volunteer ambulance service personnel. No deduction is made  
8.17 for jury duty pay or for pay as an election judge.

8.18 (d) The applicant may report deductible earnings on continued requests for  
8.19 unemployment benefits at the next lower whole dollar amount.

8.20 (e) Deductible earnings does not include any money considered a deductible  
8.21 payment under subdivision 3, but includes all compensation considered wages under  
8.22 section 268.035, subdivision 29, and any other compensation considered earned income  
8.23 under state and federal law for income tax purposes.

8.24 EFFECTIVE DATE. This section is effective for deductions occurring on or after  
8.25 July 1, 2013.

8.26 Sec. 5. Minnesota Statutes 2010, section 268.18, subdivision 2b, is amended to read:

8.27 Subd. 2b. **Interest.** (a) On any unemployment benefits fraudulently obtained, and  
8.28 any penalty amounts assessed under subdivision 2, the commissioner must assess interest  
8.29 at the rate of 1-1/2 percent per month on any amount that remains unpaid beginning  
8.30 30 calendar days after the date of the determination of overpayment by fraud. A  
8.31 determination of overpayment by fraud must state that interest will be assessed.

8.32 (b) If the determination did not state that interest will be assessed, interest is assessed  
8.33 beginning 30 calendar days after notification, by mail or electronic transmission, to the  
8.34 applicant that interest is now assessed.



9.1 (c) Interest payments under this section are credited to the ~~administration account~~  
9.2 trust fund.

9.3 **EFFECTIVE DATE.** This section is effective for payments received on or after  
9.4 July 1, 2013.

9.5 Sec. 6. Minnesota Statutes 2010, section 268.18, subdivision 4, is amended to read:

9.6 Subd. 4. **Cancellation of overpayments.** (a) If unemployment benefits overpaid  
9.7 under subdivision 1 are not repaid or offset from subsequent unemployment benefits  
9.8 as provided for in subdivision 1 within six years after the date of the determination or  
9.9 decision holding the applicant overpaid, the commissioner must cancel the overpayment  
9.10 balance, and no administrative or legal proceedings may be used to enforce collection  
9.11 of those amounts.

9.12 (b) If unemployment benefits determined overpaid under subdivision 2 including  
9.13 penalties and interest are not repaid within ~~15~~ ten years after the date of the determination  
9.14 of overpayment by fraud, the commissioner must cancel the overpayment balance and  
9.15 any penalties and interest due, and no administrative or legal proceeding may be used to  
9.16 enforce collection of those amounts.

9.17 (c) The commissioner may cancel at any time any overpayment, including penalties  
9.18 and interest, that the commissioner determines is uncollectible because of death or  
9.19 bankruptcy.

9.20 **EFFECTIVE DATE.** This section is effective July 1, 2012, and applies retroactively  
9.21 to all existing overpayments.

9.22 Sec. 7. Minnesota Statutes 2010, section 268.192, is amended by adding a subdivision  
9.23 to read:

9.24 Subd. 1a. **Agreements not allowed.** An employer may not make an agreement that  
9.25 in exchange for the employer agreeing not to contest the payment of unemployment  
9.26 benefits, including agreeing not to provide information to the department, an employee  
9.27 will:

- 9.28 (1) quit the employment;  
9.29 (2) take a leave of absence;  
9.30 (3) leave the employment temporarily or permanently; or  
9.31 (4) withdraw a grievance or appeal of a termination.

9.32 An agreement that violates this subdivision has no effect under this chapter.

9.33 **EFFECTIVE DATE.** This section is effective July 1, 2012.

10.7 electromagnetic or similar capabilities, and, when permitted by the commissioner, a  
10.8 telephone communication online, by telephone, or by facsimile transmission.

10.9 Sec. 2. Minnesota Statutes 2011 Supplement, section 268.035, subdivision 20, is  
10.10 amended to read:

10.11 Subd. 20. **Noncovered employment.** "Noncovered employment" means:

10.12 (1) employment for the United States government or an instrumentality thereof,  
10.13 including military service;

10.14 (2) employment for a state, other than Minnesota, or a political subdivision or  
10.15 instrumentality thereof;

10.16 (3) employment for a foreign government;

10.17 (4) employment for an instrumentality wholly owned by a foreign government,  
10.18 if the employment is of a character similar to that performed in foreign countries by  
10.19 employees of the United States government or an instrumentality thereof and the United  
10.20 States Secretary of State has certified that the foreign government grants an equivalent  
10.21 exemption to similar employment performed in the foreign country by employees of the  
10.22 United States government and instrumentalities thereof;

10.23 (5) employment covered under United States Code, title 45, section 351, the  
10.24 Railroad Unemployment Insurance Act;

10.25 (6) employment covered by a reciprocal arrangement between the commissioner and

11.1 (8) employment of a duly ordained or licensed minister of a church in the exercise of

11.4 States Code, title 26, section 501(c)(3) of the federal Internal Revenue Code and exempt
