7.7 Subd. 11. **Amortization contributions.** (a) In addition to the exhibit indicating the level
7.8 normal cost, the actuarial valuation of the retirement plan must contain an exhibit for financial
7.9 reporting purposes indicating the additional annual contribution sufficient to amortize the
7.10 unfunded actuarial accrued liability and must contain an exhibit for contribution
7.11 determination purposes indicating the additional contribution sufficient to amortize the
7.12 unfunded actuarial accrued liability. For the retirement plans listed in subdivision 8, paragraph
7.13 (c), but excluding the legislators retirement plan, the additional contribution must be
7.14 calculated on a level percentage of covered payroll basis by the established date for full
7.15 funding in effect when the valuation is prepared, assuming annual payroll growth at the
7.16 applicable percentage rate set forth in subdivision 8, paragraph (d). For all other retirement
7.17 plans and for the legislators retirement plan, the additional annual contribution must be
7.18 calculated on a level annual dollar amount basis.

7.19 (b) For any retirement plan other than a retirement plan governed by paragraph (d), (e),
7.20 (f), (g), (h), (i), or (j), if there has not been a change in the actuarial assumptions used for
7.21 calculating the actuarial accrued liability of the fund, a change in the benefit plan governing
7.22 annuities and benefits payable from the fund, a change in the actuarial cost method used in
7.23 calculating the actuarial accrued liability of all or a portion of the fund, or a combination

7.30 benefit plan governing annuities and benefits payable from the fund, a change in the actuarial
7.31 cost method used in calculating the actuarial accrued liability of all or a portion of the fund,
7.32 or a combination of the three, and the change or changes, by itself or by themselves and
7.33 without inclusion of any other items of increase or decrease, produce a net increase in the

8.1 unfunded actuarial accrued liability in the fund, the established date for full funding must
8.2 be determined using the following procedure:

8.3 (i) the unfunded actuarial accrued liability of the fund must be determined in accordance
8.4 with the plan provisions governing annuities and retirement benefits and the actuarial
8.5 assumptions in effect before an applicable change;

8.6 (ii) the level annual dollar contribution or level percentage, whichever is applicable,
8.7 needed to amortize the unfunded actuarial accrued liability amount determined under item
8.8 (i) by the established date for full funding in effect before the change must be calculated
8.9 using the interest assumption specified in subdivision 8 in effect before the change;

8.10 (iii) the unfunded actuarial accrued liability of the fund must be determined in accordance
8.11 with any new plan provisions governing annuities and benefits payable from the fund and
8.12 any new actuarial assumptions and the remaining plan provisions governing annuities and
8.13 benefits payable from the fund and actuarial assumptions in effect before the change;

8.14 (iv) the level annual dollar contribution or level percentage, whichever is applicable,
8.15 needed to amortize the difference between the unfunded actuarial accrued liability amount
8.16 calculated under item (i) and the unfunded actuarial accrued liability amount calculated
8.17 under item (iii) over a period of 30 years from the end of the plan year in which the applicable
8.18 change is effective must be calculated using the applicable interest assumption specified in

 9.22 of valuation assets over the actuarial accrued liability, the valuation assets in excess of the
 9.23 actuarial accrued liability must be recognized as a reduction in the current contribution
 9.24 requirements by an amount equal to the amortization of the excess expressed as a level
 9.25 percentage of pay over a 30-year period beginning anew with each annual actuarial valuation
 9.26 of the plan.

9.27 **EFFECTIVE DATE.** This section is effective July 1, 2017.

10.25 Section 1. Minnesota Statutes 2016, section 3A.03, subdivision 2, is amended to read:

10.26 Subd. 2. **Refund.** (a) A former member who has made contributions under subdivision
 10.27 1 and who is no longer a member of the legislature is entitled to receive, upon written
 10.28 application to the executive director on a form prescribed by the executive director, a refund
 10.29 from the general fund of all contributions credited to the member's account with interest
 10.30 computed as provided in section 352.22, subdivision 2.

10.31 (b) The refund of contributions as provided in paragraph (a) terminates all rights of a
 10.32 former member of the legislature and the survivors of the former member under this chapter.

11.1 (c) If the former member of the legislature again becomes a member of the legislature
11.2 after having taken a refund as provided in paragraph (a), the member is a member of the
11.3 unclassified employees retirement program of the Minnesota State Retirement System.

11.4 (d) However, the member may reinstate the rights and credit for service previously
11.5 forfeited under this chapter if the member repays all refunds taken, plus interest at the ~~rate~~
11.6 ~~of 8.5 percent until June 30, 2015, and eight percent thereafter~~ applicable annual rate or
11.7 rates specified in section 356.59, subdivision 2, compounded annually₂ from the date on
11.8 which the refund was taken to the date on which the refund is repaid.

11.9 (e) No person may be required to apply for or to accept a refund.

11.10 **EFFECTIVE DATE.** This section is effective July 1, 2017.

11.11 Sec. 2. Minnesota Statutes 2016, section 352.01, subdivision 13a, is amended to read:

11.12 Subd. 13a. **Reduced salary during period of workers' compensation.** An employee
11.13 on leave of absence receiving temporary workers' compensation payments and a reduced
11.14 salary or no salary from the employer who is entitled to allowable service credit for the
11.15 period of absence, may make payment to the fund for the difference between salary received,
11.16 if any, and the salary the employee would normally receive if not on leave of absence during
11.17 the period. The employee shall pay an amount equal to the employee and employer
11.18 contribution rate under section 352.04, subdivisions 2 and 3, on the differential salary amount
11.19 for the period of the leave of absence.

11.20 The employing department, at its option, may pay the employer amount on behalf of its
11.21 employees. Payment made under this subdivision must include interest at the ~~rate of 8.5~~
11.22 ~~percent until June 30, 2015, and eight percent thereafter per year~~ applicable annual rate or
11.23 rates specified in section 356.59, subdivision 2, and must be completed within one year of
11.24 the return from leave of absence.

11.25 **EFFECTIVE DATE.** This section is effective July 1, 2017.

11.26 Sec. 3. Minnesota Statutes 2016, section 352.017, subdivision 2, is amended to read:

11.27 Subd. 2. **Purchase procedure.** (a) An employee covered by a plan specified in this
11.28 chapter may purchase credit for allowable service in that plan for a period specified in
11.29 subdivision 1 if the employee makes a payment as specified in paragraph (b) or (c), whichever
11.30 applies. The employing unit, at its option, may pay the employer portion of the amount
11.31 specified in paragraph (b) on behalf of its employees.

12.1 (b) If payment is received by the executive director within one year from the date the
 12.2 employee returned to work following the authorized leave, the payment amount is equal to
 12.3 the employee and employer contribution rates specified in law for the applicable plan at the
 12.4 end of the leave period multiplied by the employee's hourly rate of salary on the date of
 12.5 return from the leave of absence and by the days and months of the leave of absence for
 12.6 which the employee is eligible for allowable service credit. The payment must include

POSTRETIREMENT ADJUSTMENT.**

Subd. 8. **Calculation of postretirement adjustments; percentage based.** (a) For purposes of computing postretirement adjustments for eligible benefit recipients of the St. Paul Teachers Retirement Fund Association, the accrued liability funding ratio based on the actuarial value of assets of the plan as determined by the two most recent actuarial valuations prepared under sections 356.214 and 356.215 determines the postretirement increase, as follows:

Funding ratio	Postretirement increase
Less than 80 percent	1 percent
At least 80 percent but less than 90 percent	2 percent

(b) The amount determined under paragraph (a) is the full postretirement increase to be applied as a permanent increase to the regular payment of each eligible member on January 1 of the next calendar year. For any eligible member whose effective date of benefit commencement occurred after January 1 of the calendar year immediately before the postretirement increase is applied, the amount determined under paragraph (a) must be reduced by 50 percent.

(c) If the accrued liability funding ratio based on the actuarial value of assets is at least 90 percent in two consecutive actuarial valuations, subsequent postretirement increases must be paid as specified in subdivision 9.

(d) If, following a postretirement increase under paragraph (a), the accrued liability funding ratio, based on the actuarial value of assets, falls below 80 percent for two consecutive actuarial valuations, the applicable postretirement increase must be reduced to one percent until January 1 of the calendar year next following the date on which the requirements for an increase under paragraph (a) are again satisfied.

Subd. 9. **Calculation of postretirement adjustments.** (a) This subdivision applies if the requirements of subdivision 8, paragraph (c), have been satisfied.

(b) A percentage adjustment must be paid under this subdivision to eligible persons under subdivision 7.

(c) The amount of 2.5 percent is the full postretirement adjustment to be applied as a permanent increase to the regular payment of each eligible member on January 1 of the next calendar year. For any eligible member whose effective date of benefit commencement occurred after January 1 of the calendar year immediately before the postretirement adjustment is applied, the postretirement adjustment amount must be reduced by 50 percent.

(d) In the event the accrued liability funding ratio based on the actuarial value of assets falls below 90 percent for two consecutive actuarial valuations, the applicable postretirement increase must be determined under subdivision 8 until January 1 of the calendar year next following the date on which the requirements of subdivision 8, paragraph (c), are again satisfied.

356.415 POSTRETIREMENT ADJUSTMENTS; STATEWIDE RETIREMENT PLANS.

Subdivision 1. **Annual postretirement adjustments; generally.** (a) Except as otherwise provided in subdivision 1a, 1b, 1c, 1d, 1e, or 1f, retirement annuity, disability benefit, or survivor benefit recipients of a covered retirement plan are entitled to a postretirement adjustment annually on January 1, as follows:

(1) a postretirement increase of 2.5 percent must be applied each year, effective January 1, to the monthly annuity or benefit of each annuitant or benefit recipient who has been receiving an annuity or a benefit for at least 12 full months as of the June 30 of the calendar year immediately before the adjustment; and

(2) for each annuitant or benefit recipient who has been receiving an annuity or a benefit amount for at least one full month, but less than 12 full months as of the June 30 of the calendar year immediately before the adjustment, an annual postretirement increase of 1/12 of 2.5 percent for each month that the person has been receiving an annuity or benefit must be applied.

(b) An increase in annuity or benefit payments under this section must be made automatically unless written notice is filed by the annuitant or benefit recipient with the executive director of the covered retirement plan requesting that the increase not be made.
