1.11	(b) For aids payable in 2015 and thereafter, the formula aid for a city is equal to the
1.12	sum of (1) its formula aid in the previous year and (2) the product of (i) the difference
1.13	between its unmet need and its certified formula aid in the previous year under subdivision
1.14	9, and (ii) the aid gap percentage.
1.15	(c) For aids payable in 2015 and thereafter, if a city's certified aid from the previous
