1.8	Section 1. <u>LEGISLATIVE INTENT; SEXUAL HARASSMENT.</u>
1.9	(a) The legislature hereby declares its intent with regard to interpretation and application
1.10	of the law regarding sexual harassment as defined in the Minnesota Human Rights Act,
1.11	Minnesota Statutes, section 363A.03, subdivision 43:
1.12	(1) preventing and correcting sexual harassment is an important public policy of the
1.13	state;

2.1	(3) the legislature affirms that state law is not a general civility code. Courts should not
2.2	be called upon to consider legal remedies for every incidence of inappropriate, rude, or
2.3	offensive behavior in an employment, public accommodations, public services, education,
2.4	or housing environment; and
2.5	(4) the legislature affirms that the Minnesota Human Rights Act is not a strict liability
2.6	statute and individuals and entities who are not aware of sexual harassment, or who in good
2.7	faith take reasonable steps to prevent or promptly correct sexual harassment, should not be
2.8	held liable for sexual harassment committed by others.

2.13	Section 1. Minnesota Statutes 2018, section 363A.03, subdivision 43, is amended to read:
2.14	Subd. 43. Sexual harassment. (a) "Sexual harassment" includes unwelcome sexual
2.15	advances, requests for sexual favors, sexually motivated physical contact or other verbal or
2.16	physical conduct or communication of a sexual nature when:
2.17	(1) submission to that conduct or communication is made a term or condition, either
2.18	explicitly or implicitly, of obtaining employment, public accommodations or public services,
2.19	education, or housing;
2.20	(2) submission to or rejection of that conduct or communication by an individual is used
2.21	as a factor in decisions affecting that individual's employment, public accommodations or
2.22	public services, education, or housing; or
2.23	(3) that conduct or communication has the purpose or effect of substantially interfering
2.24	with an individual's employment, public accommodations or public services, education, or
2.25	housing, or creating an intimidating, or hostile, or offensive employment, public
2.26	accommodations, public services, educational, or housing environment.
2.27	(b) Harassing conduct or communication under paragraph (a), clause (3), must, under
2.28	the totality of the circumstances, be: (1) objectively and subjectively harassing; and (2)
2.29	sufficiently severe or pervasive to alter the terms or conditions of an individual's employment,
2.30	public accommodations, public services, education, or housing and create an abusive
2.31	environment. Severe or pervasive sexual harassment may arise from a single significant

instance of harassing conduct or communication, or a series of instances of harassing conduct 3.1 or communications. 3.2 **EFFECTIVE DATE.** This section is effective January 1, 2020, and applies to causes 3.3 of action arising on or after that date. 3.4 Sec. 2.
