- 2.3 <u>\$79,000 in fiscal year 2018 and \$68,000 in fiscal year 2019 are appropriated from the</u>

- 2.5 investigations of allegations of child maltreatment occurring in children's residential facilities
- 2.6 licensed by the Department of Corrections under Minnesota Statutes, section 241.021, and
