1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 Section 1. Minnesota Statutes 2018, section 62U.03, is amended to read:

1.13 **62U.03 PAYMENT RESTRUCTURING; CARE COORDINATION PAYMENTS.**

1.14 (a) By January 1, 2010, health plan companies shall include health care homes in their

1.15 provider networks and by July 1, 2010, shall pay a care coordination fee for their members

1.16 who choose to enroll in health care homes certified by the ~~commissioners of health and~~

1.17 ~~human services~~ commissioner under section 256B.0751. Health plan companies shall develop

1.18 payment conditions and terms for the care coordination fee for health care homes participating

1.19 in their network in a manner that is consistent with the system developed under section

1.20 256B.0753. Nothing in this section shall restrict the ability of health plan companies to

1.21 selectively contract with health care providers, including health care homes. Health plan

1.22 companies may reduce or reallocate payments to other providers to ensure that

1.23 implementation of care coordination payments is cost neutral.

1.24 (b) By July 1, 2010, the commissioner of management and budget shall implement the

1.25 care coordination payments for participants in the state employee group insurance program.

2.1 The commissioner of management and budget may reallocate payments within the health  
2.2 care system in order to ensure that the implementation of this section is cost neutral.

2.3 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.4 Sec. 2. Minnesota Statutes 2018, section 62U.04, subdivision 11, is amended to read:

2.5 Subd. 11. **Restricted uses of the all-payer claims data.** (a) Notwithstanding subdivision  
2.6 4, paragraph (b), and subdivision 5, paragraph (b), the commissioner or the commissioner's  
2.7 designee shall only use the data submitted under subdivisions 4 and 5 for the following  
2.8 purposes:

2.9 (1) to evaluate the performance of the health care home program as authorized under  
2.10 ~~sections~~ section 256B.0751, subdivision 6, ~~and 256B.0752, subdivision 2;~~

2.11 (2) to study, in collaboration with the reducing avoidable readmissions effectively  
2.12 (RARE) campaign, hospital readmission trends and rates;

2.13 (3) to analyze variations in health care costs, quality, utilization, and illness burden based  
2.14 on geographical areas or populations;

2.15 (4) to evaluate the state innovation model (SIM) testing grant received by the Departments  
2.16 of Health and Human Services, including the analysis of health care cost, quality, and  
2.17 utilization baseline and trend information for targeted populations and communities; and

2.18 (5) to compile one or more public use files of summary data or tables that must:

2.19 (i) be available to the public for no or minimal cost by March 1, 2016, and available by  
2.20 web-based electronic data download by June 30, 2019;

2.21 (ii) not identify individual patients, payers, or providers;

2.22 (iii) be updated by the commissioner, at least annually, with the most current data  
2.23 available;

2.24 (iv) contain clear and conspicuous explanations of the characteristics of the data, such  
2.25 as the dates of the data contained in the files, the absence of costs of care for uninsured  
2.26 patients or nonresidents, and other disclaimers that provide appropriate context; and

2.27 (v) not lead to the collection of additional data elements beyond what is authorized under  
2.28 this section as of June 30, 2015.

2.29 (b) The commissioner may publish the results of the authorized uses identified in  
2.30 paragraph (a) so long as the data released publicly do not contain information or descriptions  
2.31 in which the identity of individual hospitals, clinics, or other providers may be discerned.

3.1 (c) Nothing in this subdivision shall be construed to prohibit the commissioner from  
3.2 using the data collected under subdivision 4 to complete the state-based risk adjustment  
3.3 system assessment due to the legislature on October 1, 2015.

3.4 (d) The commissioner or the commissioner's designee may use the data submitted under  
3.5 subdivisions 4 and 5 for the purpose described in paragraph (a), clause (3), until July 1,  
3.6 2023.

3.7 (e) The commissioner shall consult with the all-payer claims database work group  
3.8 established under subdivision 12 regarding the technical considerations necessary to create  
3.9 the public use files of summary data described in paragraph (a), clause (5).

3.10 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.11 Sec. 3. Minnesota Statutes 2018, section 256.01, subdivision 29, is amended to read:

3.12 Subd. 29. **State medical review team.** (a) To ensure the timely processing of  
3.13 determinations of disability by the commissioner's state medical review team under sections  
3.14 256B.055, ~~subdivision~~ subdivisions 7, paragraph (b), and 12; and 256B.057, subdivision 9,  
3.15 ~~and 256B.055, subdivision 12,~~ the commissioner shall review all medical evidence ~~submitted~~  
3.16 ~~by county agencies with a referral~~ and seek ~~additional~~ information from providers, applicants,  
3.17 and enrollees to support the determination of disability where necessary. Disability shall  
3.18 be determined according to the rules of title XVI and title XIX of the Social Security Act  
3.19 and pertinent rules and policies of the Social Security Administration.

3.20 (b) Prior to a denial or withdrawal of a requested determination of disability due to  
3.21 insufficient evidence, the commissioner shall (1) ensure that the missing evidence is necessary  
3.22 and appropriate to a determination of disability, and (2) assist applicants and enrollees to  
3.23 obtain the evidence, including, but not limited to, medical examinations and electronic  
3.24 medical records.

3.25 (c) The commissioner shall provide the chairs of the legislative committees with  
3.26 jurisdiction over health and human services finance and budget the following information  
3.27 on the activities of the state medical review team by February 1 of each year:

3.28 (1) the number of applications to the state medical review team that were denied,  
3.29 approved, or withdrawn;

3.30 (2) the average length of time from receipt of the application to a decision;

3.31 (3) the number of appeals, appeal results, and the length of time taken from the date the  
3.32 person involved requested an appeal for a written decision to be made on each appeal;

4.1 (4) for applicants, their age, health coverage at the time of application, hospitalization  
4.2 history within three months of application, and whether an application for Social Security  
4.3 or Supplemental Security Income benefits is pending; and

4.4 (5) specific information on the medical certification, licensure, or other credentials of  
4.5 the person or persons performing the medical review determinations and length of time in  
4.6 that position.

4.7 (d) Any appeal made under section 256.045, subdivision 3, of a disability determination  
4.8 made by the state medical review team must be decided according to the timelines under  
4.9 section 256.0451, subdivision 22, paragraph (a). If a written decision is not issued within  
4.10 the timelines under section 256.0451, subdivision 22, paragraph (a), the appeal must be  
4.11 immediately reviewed by the chief human services judge.

4.12 **EFFECTIVE DATE.** This section is effective the day following final enactment.

4.13 Sec. 4. Minnesota Statutes 2018, section 256B.04, subdivision 21, is amended to read:

4.14 Subd. 21. **Provider enrollment.** (a) If the commissioner or the Centers for Medicare  
4.15 and Medicaid Services determines that a provider is designated "high-risk," the commissioner  
4.16 may withhold payment from providers within that category upon initial enrollment for a  
4.17 90-day period. The withholding for each provider must begin on the date of the first  
4.18 submission of a claim.

4.19 (b) An enrolled provider that is also licensed by the commissioner under chapter 245A,  
4.20 or is licensed as a home care provider by the Department of Health under chapter 144A and  
4.21 has a home and community-based services designation on the home care license under  
4.22 section 144A.484, must designate an individual as the entity's compliance officer. The  
4.23 compliance officer must:

4.24 (1) develop policies and procedures to assure adherence to medical assistance laws and  
4.25 regulations and to prevent inappropriate claims submissions;

4.26 (2) train the employees of the provider entity, and any agents or subcontractors of the  
4.27 provider entity including billers, on the policies and procedures under clause (1);

4.28 (3) respond to allegations of improper conduct related to the provision or billing of  
4.29 medical assistance services, and implement action to remediate any resulting problems;

4.30 (4) use evaluation techniques to monitor compliance with medical assistance laws and  
4.31 regulations;

5.1 (5) promptly report to the commissioner any identified violations of medical assistance  
5.2 laws or regulations; and

5.3 (6) within 60 days of discovery by the provider of a medical assistance reimbursement  
5.4 overpayment, report the overpayment to the commissioner and make arrangements with  
5.5 the commissioner for the commissioner's recovery of the overpayment.

5.6 The commissioner may require, as a condition of enrollment in medical assistance, that a  
5.7 provider within a particular industry sector or category establish a compliance program that  
5.8 contains the core elements established by the Centers for Medicare and Medicaid Services.

5.9 (c) The commissioner may revoke the enrollment of an ordering or rendering provider  
5.10 for a period of not more than one year, if the provider fails to maintain and, upon request  
5.11 from the commissioner, provide access to documentation relating to written orders or requests  
5.12 for payment for durable medical equipment, certifications for home health services, or  
5.13 referrals for other items or services written or ordered by such provider, when the  
5.14 commissioner has identified a pattern of a lack of documentation. A pattern means a failure  
5.15 to maintain documentation or provide access to documentation on more than one occasion.  
5.16 Nothing in this paragraph limits the authority of the commissioner to sanction a provider  
5.17 under the provisions of section 256B.064.

5.18 (d) The commissioner shall terminate or deny the enrollment of any individual or entity  
5.19 if the individual or entity has been terminated from participation in Medicare or under the  
5.20 Medicaid program or Children's Health Insurance Program of any other state. The  
5.21 commissioner may exempt a rehabilitation agency from termination or denial that would  
5.22 otherwise be required under this paragraph, if the rehabilitation agency:

5.23 (1) is unable to retain Medicare certification and enrollment solely due to a lack of billing  
5.24 to the Medicare program;

5.25 (2) meets all other applicable Medicare certification requirements based on an on-site  
5.26 review completed by the commissioner of health; and

5.27 (3) serves primarily a pediatric population.

5.28 (e) As a condition of enrollment in medical assistance, the commissioner shall require  
5.29 that a provider designated "moderate" or "high-risk" by the Centers for Medicare and  
5.30 Medicaid Services or the commissioner permit the Centers for Medicare and Medicaid  
5.31 Services, its agents, or its designated contractors and the state agency, its agents, or its  
5.32 designated contractors to conduct unannounced on-site inspections of any provider location.  
5.33 The commissioner shall publish in the Minnesota Health Care Program Provider Manual a

6.1 list of provider types designated "limited," "moderate," or "high-risk," based on the criteria  
6.2 and standards used to designate Medicare providers in Code of Federal Regulations, title  
6.3 42, section 424.518. The list and criteria are not subject to the requirements of chapter 14.  
6.4 The commissioner's designations are not subject to administrative appeal.

6.5 (f) As a condition of enrollment in medical assistance, the commissioner shall require  
6.6 that a high-risk provider, or a person with a direct or indirect ownership interest in the  
6.7 provider of five percent or higher, consent to criminal background checks, including  
6.8 fingerprinting, when required to do so under state law or by a determination by the  
6.9 commissioner or the Centers for Medicare and Medicaid Services that a provider is designated  
6.10 high-risk for fraud, waste, or abuse.

6.11 (g)(1) Upon initial enrollment, reenrollment, and notification of revalidation, all durable  
6.12 medical equipment, prosthetics, orthotics, and supplies (DMEPOS) medical suppliers  
6.13 meeting the durable medical equipment provider and supplier definition in clause (3),  
6.14 operating in Minnesota and receiving Medicaid funds must purchase a surety bond that is  
6.15 annually renewed and designates the Minnesota Department of Human Services as the  
6.16 obligee, and must be submitted in a form approved by the commissioner. For purposes of  
6.17 this clause, the following medical suppliers are not required to obtain a surety bond: a  
6.18 federally qualified health center, a home health agency, the Indian Health Service, a  
6.19 pharmacy, and a rural health clinic.

6.20 (2) At the time of initial enrollment or reenrollment, durable medical equipment providers  
6.21 and suppliers defined in clause (3) must purchase a surety bond of \$50,000. If a revalidating  
6.22 provider's Medicaid revenue in the previous calendar year is up to and including \$300,000,  
6.23 the provider agency must purchase a surety bond of \$50,000. If a revalidating provider's  
6.24 Medicaid revenue in the previous calendar year is over \$300,000, the provider agency must  
6.25 purchase a surety bond of \$100,000. The surety bond must allow for recovery of costs and  
6.26 fees in pursuing a claim on the bond.

6.27 (3) "Durable medical equipment provider or supplier" means a medical supplier that can  
6.28 purchase medical equipment or supplies for sale or rental to the general public and is able  
6.29 to perform or arrange for necessary repairs to and maintenance of equipment offered for  
6.30 sale or rental.

6.31 (h) The Department of Human Services may require a provider to purchase a surety  
6.32 bond as a condition of initial enrollment, reenrollment, reinstatement, or continued enrollment  
6.33 if: (1) the provider fails to demonstrate financial viability, (2) the department determines  
6.34 there is significant evidence of or potential for fraud and abuse by the provider, or (3) the

7.1 provider or category of providers is designated high-risk pursuant to paragraph (a) and as  
7.2 per Code of Federal Regulations, title 42, section 455.450. The surety bond must be in an  
7.3 amount of \$100,000 or ten percent of the provider's payments from Medicaid during the  
7.4 immediately preceding 12 months, whichever is greater. The surety bond must name the  
7.5 Department of Human Services as an obligee and must allow for recovery of costs and fees  
7.6 in pursuing a claim on the bond. This paragraph does not apply if the provider currently  
7.7 maintains a surety bond under the requirements in section 256B.0659 or 256B.85.

7.8 **EFFECTIVE DATE.** This section is effective the day following final enactment.

7.9 Sec. 5. Minnesota Statutes 2018, section 256B.043, subdivision 1, is amended to read:

7.10 Subdivision 1. **Alternative and complementary health care.** The commissioner of  
7.11 human services, through the medical director and in consultation with the Health Services  
7.12 ~~Policy Committee~~ Advisory Council established under section 256B.0625, subdivision 3c,  
7.13 as part of the commissioner's ongoing duties, shall consider the potential for improving  
7.14 quality and obtaining cost savings through greater use of alternative and complementary  
7.15 treatment methods and clinical practice; shall incorporate these methods into the medical  
7.16 assistance and MinnesotaCare programs; and shall make related legislative recommendations  
7.17 as appropriate. The commissioner shall post the recommendations required under this  
7.18 subdivision on agency websites.

7.19 Sec. 6. Minnesota Statutes 2018, section 256B.056, subdivision 1a, is amended to read:

7.20 Subd. 1a. **Income and assets generally.** (a)(1) Unless specifically required by state law  
7.21 or rule or federal law or regulation, the methodologies used in counting income and assets  
7.22 to determine eligibility for medical assistance for persons whose eligibility category is based  
7.23 on blindness, disability, or age of 65 or more years, the methodologies for the Supplemental  
7.24 Security Income program shall be used, except as provided under subdivision 3, paragraph  
7.25 (a), clause (6).

7.26 (2) Increases in benefits under title II of the Social Security Act shall not be counted as  
7.27 income for purposes of this subdivision until July 1 of each year. Effective upon federal  
7.28 approval, for children eligible under section 256B.055, subdivision 12, or for home and  
7.29 community-based waiver services whose eligibility for medical assistance is determined  
7.30 without regard to parental income, child support payments, including any payments made  
7.31 by an obligor in satisfaction of or in addition to a temporary or permanent order for child  
7.32 support, and Social Security payments are not counted as income.

8.1 (b)(1) The modified adjusted gross income methodology as defined in ~~the Affordable~~  
 8.2 ~~Care Act~~ United States Code, title 42, section 1396a(e)(14), shall be used for eligibility  
 8.3 categories based on:

8.4 (i) children under age 19 and their parents and relative caretakers as defined in section  
 8.5 256B.055, subdivision 3a;

8.6 (ii) children ages 19 to 20 as defined in section 256B.055, subdivision 16;

8.7 (iii) pregnant women as defined in section 256B.055, subdivision 6;

8.8 (iv) infants as defined in sections 256B.055, subdivision 10, and 256B.057, subdivision  
 8.9 § 1; and

8.10 (v) adults without children as defined in section 256B.055, subdivision 15.

8.11 For these purposes, a "methodology" does not include an asset or income standard, or  
 8.12 accounting method, or method of determining effective dates.

8.13 (2) For individuals whose income eligibility is determined using the modified adjusted  
 8.14 gross income methodology in clause (1);

8.15 (i) the commissioner shall subtract from the individual's modified adjusted gross income  
 8.16 an amount equivalent to five percent of the federal poverty guidelines; and

8.17 (ii) the individual's current monthly income and household size is used to determine  
 8.18 eligibility for the 12-month eligibility period. If an individual's income is expected to vary  
 8.19 month to month, eligibility is determined based on the income predicted for the 12-month  
 8.20 eligibility period.

8.21 **EFFECTIVE DATE.** This section is effective the day following final enactment.

8.22 Sec. 7. Minnesota Statutes 2018, section 256B.056, subdivision 4, is amended to read:

8.23 Subd. 4. **Income.** (a) To be eligible for medical assistance, a person eligible under section  
 8.24 256B.055, subdivisions 7, 7a, and 12, may have income up to 100 percent of the federal  
 8.25 poverty guidelines. Effective January 1, 2000, and each successive January, recipients of  
 8.26 Supplemental Security Income may have an income up to the Supplemental Security Income  
 8.27 standard in effect on that date.

8.28 (b) ~~Effective January 1, 2014,~~ To be eligible for medical assistance; under section  
 8.29 256B.055, subdivision 3a, a parent or caretaker relative may have an income up to 133  
 8.30 percent of the federal poverty guidelines for the household size.



9.1 (c) To be eligible for medical assistance under section 256B.055, subdivision 15, a  
 9.2 person may have an income up to 133 percent of federal poverty guidelines for the household  
 9.3 size.

9.4 (d) To be eligible for medical assistance under section 256B.055, subdivision 16, a child  
 9.5 age 19 to 20 may have an income up to 133 percent of the federal poverty guidelines for  
 9.6 the household size.

9.7 (e) To be eligible for medical assistance under section 256B.055, subdivision 3a, a child  
 9.8 under age 19 may have income up to 275 percent of the federal poverty guidelines for the  
 9.9 household size ~~or an equivalent standard when converted using modified adjusted gross~~  
 9.10 ~~income methodology as required under the Affordable Care Act. Children who are enrolled~~  
 9.11 ~~in medical assistance as of December 31, 2013, and are determined ineligible for medical~~  
 9.12 ~~assistance because of the elimination of income disregards under modified adjusted gross~~  
 9.13 ~~income methodology as defined in subdivision 1a remain eligible for medical assistance~~

9.17 (f) In computing income to determine eligibility of persons under paragraphs (a) to (e)  
 9.18 who are not residents of long-term care facilities, the commissioner shall disregard increases  
 9.19 in income as required by Public Laws 94-566, section 503; 99-272; and 99-509. For persons  
 9.20 eligible under paragraph (a), veteran aid and attendance benefits and Veterans Administration  
 9.21 unusual medical expense payments are considered income to the recipient.

9.22 **EFFECTIVE DATE.** This section is effective the day following final enactment.

9.23 Sec. 8. Minnesota Statutes 2018, section 256B.056, subdivision 7, is amended to read:

9.24 Subd. 7. **Period of eligibility.** (a) Eligibility is available for the month of application  
 9.25 and for three months prior to application if the person was eligible in those prior months.  
 9.26 A redetermination of eligibility must occur every 12 months.

9.27 (b) For a person eligible for an insurance affordability program who reports a change  
 9.28 that makes the person eligible for medical assistance, eligibility is available for the month  
 9.29 the change was reported and for three months prior to the month the change was reported,  
 9.30 if the person was eligible in those prior months.

9.31 **EFFECTIVE DATE.** This section is effective the day following final enactment.

10.1 Sec. 9. Minnesota Statutes 2018, section 256B.056, subdivision 7a, is amended to read:

10.2 Subd. 7a. **Periodic renewal of eligibility.** (a) The commissioner shall make an annual  
10.3 redetermination of eligibility based on information contained in the enrollee's case file and  
10.4 other information available to the agency, including but not limited to information accessed  
10.5 through an electronic database, without requiring the enrollee to submit any information  
10.6 when sufficient data is available for the agency to renew eligibility.

10.7 (b) If the commissioner cannot renew eligibility in accordance with paragraph (a), the  
10.8 commissioner must provide the enrollee with a prepopulated renewal form containing  
10.9 eligibility information available to the agency and permit the enrollee to submit the form  
10.10 with any corrections or additional information to the agency and sign the renewal form via

10.21 Subd. 10. **Eligibility verification.** (a) The commissioner shall require women who are  
10.22 applying for the continuation of medical assistance coverage following the end of the 60-day  
10.23 postpartum period to update their income and asset information and to submit any required  
10.24 income or asset verification.

10.25 (b) The commissioner shall determine the eligibility of private-sector health care coverage  
10.26 for infants less than one year of age eligible under section 256B.055, subdivision 10, or  
10.27 256B.057, subdivision 1, paragraph ~~(b)~~ (c), and shall pay for private-sector coverage if this  
10.28 is determined to be cost-effective.

10.29 (c) The commissioner shall verify assets and income for all applicants, and for all  
10.30 recipients upon renewal.

10.31 (d) The commissioner shall utilize information obtained through the electronic service

11.11 may determine that the applicant or recipient is ineligible for medical assistance. For purposes  
11.12 of this paragraph, an authorization to identify unreported accounts meets the requirements
