1.8	Subd. 51. Municipally owned wastewater treatment facility; city of Windom. (a)
1.9	Building materials and supplies used in and equipment incorporated into a wastewater
1.10	treatment facility owned and operated by the city of Windom are exempt. The tax must be
1.11	imposed and collected as if the rate under section 297A.62, subdivision 1, applied and then
1.12	refunded in the manner provided in section 297A.75.
1.13	(b) This section applies retroactively to sales and purchases made after September 1,
1.14	2018, and before January 1, 2021.
