1.5	Section 1. CONVEYANCE OF TAX-FORFEITED LAND; CASS COUNTY.
1.6	(a) Notwithstanding Minnesota Statutes, section 282.01, subdivision 1a, and the
1.7	public sale provisions of Minnesota Statutes, chapter 282, Cass County shall convey
1.8	to the city of Pillager for no consideration the tax-forfeited lands that are described in
1.9	paragraph (c).
1.10	(b) The city of Pillager shall initiate the conveyance by application to the Cass
1.11	County Board. The conveyance must be in a form approved by the attorney general. The
1.12	attorney general may make necessary changes to the legal descriptions to correct errors
1.13	and ensure accuracy.
1.14	(c) The lands to be conveyed are located in Cass County and are described as:
