1.9	Section 1. Minnesota Statutes 2014, section 256L.02, is amended by adding a

1.11	Subd. 7. Federal waivers. (a) The commissioner shall apply for an innovation
1.12	waiver under section 1332 of the Affordable Care Act, or any applicable federal waiver, to
1.13	allow the state to:
1.14	(1) expand the MinnesotaCare program as a basic health program to include persons
1.15	with incomes up to 275 percent of the federal poverty guidelines;
1.16	(2) modify MinnesotaCare premiums and cost-sharing; and
1.17	(3) receive for all MinnesotaCare enrollees, including but not limited to those with
1.18	incomes greater than 133 percent but not exceeding 275 percent of the federal poverty
1.19	guidelines, the full amount of advanced premium tax credits and cost-sharing reductions
1.20	that these individuals would have otherwise received if they obtained qualified health
1.21	plan coverage through MNsure.
1.22	(b) The commissioner shall apply for a federal waiver under section 1115 of the

Subd. 5. Cost-sharing. (a) Except as otherwise provided in this subdivision, the
MinnesotaCare benefit plan shall include the following cost-sharing requirements for all
enrollees:

(1) \$3 per prescription for adult enrollees;

(2) \$25 for eyeglasses for adult enrollees;

(3) \$3 per nonpreventive visit. For purposes of this subdivision, a "visit" means an
episode of service which is required because of a recipient's symptoms, diagnosis, or
established illness, and which is delivered in an ambulatory setting by a physician or
physician ancillary, chiropractor, podiatrist, nurse midwife, advanced practice nurse,
audiologist, optician, or optometrist;

- 2.14 (4) \$6 for nonemergency visits to a hospital-based emergency room for services
 2.15 provided through December 31, 2010, and \$3.50 effective January 1, 2011; and
- (5) a family deductible equal to \$2.75 per month per family and adjusted annually
 by the percentage increase in the medical care component of the CPI-U for the period
 of September to September of the preceding calendar year, rounded to the next-higher
 five cent increment.

(d) MinnesotaCare reimbursements to fee-for-service providers and payments to
managed care plans or county-based purchasing plans shall not be increased as a result of

(e) The commissioner, through the contracting process under section 256L.12,
may allow managed care plans and county-based purchasing plans to waive the family
deductible under paragraph (a), clause (5). The value of the family deductible shall not be
included in the capitation payment to managed care plans and county-based purchasing
plans. Managed care plans and county-based purchasing plans shall certify annually to the
commissioner the dollar value of the family deductible.

(f) The commissioner shall increase co-payments for covered services in a manner
sufficient to reduce the actuarial value of the benefit to 94 percent for recipients with
incomes not exceeding 200 percent of the federal poverty guidelines. The commissioner
shall increase co-payments for covered services in a manner sufficient to reduce the

actuarial value of the benefit to 87 percent for recipients with incomes greater than 3.1 200 percent but not exceeding 250 percent of the federal poverty guidelines. The 3.2 commissioner shall increase co-payments for covered services in a manner sufficient to 3.3 reduce the actuarial value of the benefit to 73 percent for recipients with incomes greater 3.4 than 250 percent but not exceeding 275 percent of the federal poverty guidelines.
