1.6	Section 1. [168.1283] MINNESOTA HOCKEY SPECIAL PLATES.
1.7	Subdivision 1. <b>Issuance of plates.</b> The commissioner must issue Minnesota hockey
1.8	special plates or a single motorcycle plate to an applicant who:

2.8	Subd. 5. Contributions; account; appropriation. Contributions collected under
2.9	subdivision 1, clause (5), must be deposited in the Minnesota youth hockey account, which
2.10	is established in the special revenue fund. Money in the account is appropriated to the
2.11	commissioner of public safety. This appropriation is first for the annual cost of administering
2.12	the account funds, and the remaining funds are for distribution to Minnesota Hockey to
2.13	support youth hockey throughout the state.
2.14	EFFECTIVE DATE. This section is effective January 1, 2023, for Minnesota hockey
2.15	special plates issued on or after that date.
