1.2 relating to public safety; modifying provisions related to certain juvenile
1.3 records; authorizing the expungement of certain juvenile records; authorizing
1.4 the commissioner of human services to grant set asides or variances for certain
1.5 individuals disqualified from licensure because of an offense committed as a
1.6 juvenile; requiring chemical use screen of juvenile offenders; changing penalties
1.7 and prohibitions related to using or brandishing replica firearms and BB guns on
1.8 school property; requiring the revisor of statutes to publish a table in Minnesota
1.9 Statutes containing cross-references to collateral sanctions imposed on juveniles
1.10 as a result of an adjudication of delinquency; clarifying detention placement
1.11 options for extended jurisdiction juveniles pending revocation hearings;
1.12 modifying certain provisions regarding juvenile delinquency to include stays of
1.13 adjudication of delinquency; extending the duration of the continuance period
1.14 allowed in a juvenile delinquency matter; amending Minnesota Statutes 2008,
1.15 sections 241.31, subdivision 1; 242.32, subdivision 2; 260B.125, subdivision
1.16 4; 260B.130, subdivision 5; 260B.157, subdivision 1; 260B.171, subdivision

1.22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.23 Section 1. Minnesota Statutes 2008, section 241.31, subdivision 1, is amended to read:

1.24 Subdivision 1. **Establishment of program.** Notwithstanding any provisions of
1.25 Minnesota Statutes to the contrary, any city, county or town, or any nonprofit corporation
1.26 approved by the commissioner of corrections, or any combination thereof may establish
1.27 and operate a community corrections program for the purpose of providing housing,
1.28 supervision, treatment, counseling or other correctional services;

1.29 (a) to persons convicted of crime in the courts of this state and placed on probation
1.30 by such courts pursuant to section 609.135;

2.1 (b) to persons not yet convicted of a crime but under criminal accusation who
2.2 voluntarily accept such treatment;

2.3 (c) to persons adjudicated a delinquent or who received a stay of adjudication of
2.4 delinquency under chapter 260 or chapter 260B;

2.5 (d) with the approval of the commissioner of corrections, to persons paroled under
2.6 chapter 242; and

2.7 (e) with the approval of the commissioner of corrections, to persons paroled under
2.8 section 243.05 or released under section 241.26.

2.9 Sec. 2. Minnesota Statutes 2008, section 242.32, subdivision 2, is amended to read:

2.10 Subd. 2. **Secure placement of juvenile offenders.** The commissioner shall license
2.11 several small regional facilities providing secure capacity programming for juveniles who
2.12 have been adjudicated delinquent, have received a stay of adjudication of delinquency,
2.13 or have been convicted as extended jurisdiction juveniles and require secure placement.
2.14 The programming shall be tailored to the types of juveniles being served, including their
2.15 offense history, age, gender, cultural and ethnic heritage, mental health and chemical
2.16 dependency problems, and other characteristics. Services offered shall include but not
2.17 be limited to:

2.18 (1) intensive general educational programs, with an individual educational plan for
2.19 each juvenile;

2.20 (2) specific educational components in the management of anger and nonviolent
2.21 conflict resolution;

2.22 (3) treatment for chemical dependency;

2.23 (4) mental health screening, assessment, and treatment; and

2.24 (5) programming to educate offenders about sexuality and address issues specific to
2.25 victims and perpetrators of sexual abuse.

2.26 The facilities shall collaborate with facilities providing nonsecure residential
2.27 programming and with community-based aftercare programs.

2.28 Sec. 3. Minnesota Statutes 2009 Supplement, section 245C.24, subdivision 2, is
2.29 amended to read:

2.30 Subd. 2. **Permanent bar to set aside a disqualification.** (a) Except as otherwise
2.31 provided in ~~paragraph (b)~~ this subdivision, the commissioner may not set aside the
2.32 disqualification of any individual disqualified pursuant to this chapter, regardless of how
2.33 much time has passed, if the individual was disqualified for a crime or conduct listed in
2.34 section 245C.15, subdivision 1.

3.1 (b) For an individual in the chemical dependency or corrections field who was
3.2 disqualified for a crime or conduct listed under section 245C.15, subdivision 1, and whose
3.3 disqualification was set aside prior to July 1, 2005, the commissioner must consider
3.4 granting a variance pursuant to section 245C.30 for the license holder for a program
3.5 dealing primarily with adults. A request for reconsideration evaluated under this paragraph
3.6 must include a letter of recommendation from the license holder that was subject to the
3.7 prior set-aside decision addressing the individual's quality of care to children or vulnerable
3.8 adults and the circumstances of the individual's departure from that service.

3.9 (c) When a licensed foster care provider adopts an individual who had received
3.10 foster care services from the provider for over six months, and the adopted individual is
3.11 required to receive a background study under section 245C.03, subdivision 1, paragraph
3.12 (a), clause (2) or (6), the commissioner may grant a variance to the license holder under
3.13 section 245C.30 to permit the adopted individual with a permanent disqualification
3.14 to remain affiliated with the license holder under the conditions of the variance when
3.15 the variance is recommended by the county of responsibility for each of the remaining
3.16 individuals in placement in the home and the licensing agency for the home.

3.17 (d) The commissioner shall consider granting a set aside under section 245C.22 or a
3.18 variance under section 245C.30 to an individual who is now 21 years of age or older and
3.19 who was disqualified for a crime or conduct listed under section 245C.15, subdivision 1,
3.20 occurring while the individual was under the age of 18. This paragraph does not apply to
3.21 individuals who were convicted of the disqualifying crime following certification under
3.22 section 260B.125.

3.23 Sec. 4. Minnesota Statutes 2008, section 260B.125, subdivision 4, is amended to read:

3.24 Subd. 4. **Public safety.** In determining whether the public safety is served by
3.25 certifying the matter, the court shall consider the following factors:

3.26 (1) the seriousness of the alleged offense in terms of community protection,
3.27 including the existence of any aggravating factors recognized by the Sentencing
3.28 Guidelines, the use of a firearm, and the impact on any victim;

3.29 (2) the culpability of the child in committing the alleged offense, including the level
3.30 of the child's participation in planning and carrying out the offense and the existence of
3.31 any mitigating factors recognized by the Sentencing Guidelines;

3.32 (3) the child's prior record of delinquency, including adjudications of delinquency
3.33 and delinquency petitions that resulted in stays of adjudication of delinquency;

3.34 (4) the child's programming history, including the child's past willingness to
3.35 participate meaningfully in available programming;

4.1 (5) the adequacy of the punishment or programming available in the juvenile justice
4.2 system; and

4.3 (6) the dispositional options available for the child.

4.4 In considering these factors, the court shall give greater weight to the seriousness of
4.5 the alleged offense and the child's prior record of delinquency, including adjudications
4.6 of delinquency and delinquency petitions that resulted in stays of adjudication of
4.7 delinquency, than to the other factors listed in this subdivision.

4.8 Sec. 5. Minnesota Statutes 2008, section 260B.130, subdivision 5, is amended to read:

4.9 Subd. 5. **Execution of adult sentence.** (a) When it appears that a person convicted
4.10 as an extended jurisdiction juvenile has violated the conditions of the stayed sentence,
4.11 or is alleged to have committed a new offense, the court may, without notice, revoke the
4.12 stay and probation and direct that the offender be taken into immediate custody. The court
4.13 shall notify the offender in writing of the reasons alleged to exist for revocation of the
4.14 stay of execution of the adult sentence. If the offender challenges the reasons, the court
4.15 shall hold a summary hearing on the issue at which the offender is entitled to be heard and
4.16 represented by counsel.

4.17 (b) If a person described in paragraph (a) is taken into custody, the person may be
4.18 detained in a secure juvenile detention facility. If there is no secure juvenile detention
4.19 facility or existing acceptable detention alternative available for juveniles within the
4.20 county, the child may be detained up to 24 hours, excluding Saturdays, Sundays, and
4.21 holidays, or for up to six hours in a standard metropolitan statistical area, in a jail, lockup,
4.22 or other facility used for the confinement of adults who have been charged with or
4.23 convicted of a crime. In this instance, the person must be confined in quarters separate
4.24 from any adult confined in the facility that allow for complete sight and sound separation
4.25 for all activities during the period of the detention, and the adult facility must be approved
4.26 for the detention of juveniles by the commissioner of corrections.

4.27 If the person is 18 years of age or older and is to be detained prior to the revocation
4.28 hearing, the person may be detained in a local adult correctional facility without the need
4.29 for sight and sound separation.

4.30 (c) After the hearing, if the court finds that reasons exist to revoke the stay of
4.31 execution of sentence, the court shall treat the offender as an adult and order any of the
4.32 adult sanctions authorized by section 609.14, subdivision 3, except that no credit shall
4.33 be given for time served in juvenile facility custody prior to a summary hearing. If the
4.34 offender was convicted of an offense described in subdivision 1, clause (2), and the court
4.35 finds that reasons exist to revoke the stay, the court must order execution of the previously

5.1 imposed sentence unless the court makes written findings regarding the mitigating factors
5.2 that justify continuing the stay.

5.3 (d) Upon revocation, the offender's extended jurisdiction status is terminated and
5.4 juvenile court jurisdiction is terminated. The ongoing jurisdiction for any adult sanction,
5.5 other than commitment to the commissioner of corrections, is with the adult court.

5.6 Sec. 6. Minnesota Statutes 2008, section 260B.157, subdivision 1, is amended to read:

5.7 Subdivision 1. **Investigation.** Upon request of the court the local social services
5.8 agency or probation officer shall investigate the personal and family history and
5.9 environment of any minor coming within the jurisdiction of the court under section
5.10 260B.101 and shall report its findings to the court. The court may order any minor coming
5.11 within its jurisdiction to be examined by a duly qualified physician, psychiatrist, or
5.12 psychologist appointed by the court.

5.13 The court shall order a chemical use assessment conducted when a child is (1) found
5.14 to be delinquent for violating a provision of chapter 152, or for committing a felony-level
5.15 violation of a provision of chapter 609 if the probation officer determines that alcohol or
5.16 drug use was a contributing factor in the commission of the offense, or (2) alleged to be
5.17 delinquent for violating a provision of chapter 152, if the child is being held in custody
5.18 under a detention order. The assessor's qualifications and the assessment criteria shall
5.19 comply with Minnesota Rules, parts 9530.6600 to 9530.6655. If funds under chapter
5.20 254B are to be used to pay for the recommended treatment, the assessment and placement
5.21 must comply with all provisions of Minnesota Rules, parts 9530.6600 to 9530.6655 and
5.22 9530.7000 to 9530.7030. The commissioner of human services shall reimburse the court
5.23 for the cost of the chemical use assessment, up to a maximum of \$100.

5.24 The court shall order a children's mental health screening and a chemical use
5.25 screening conducted when a child is found to be delinquent. The screening shall be
5.26 conducted with a screening instrument approved by the commissioner of human services
5.27 and shall be conducted by a mental health practitioner as defined in section 245.4871,
5.28 subdivision 26, or a probation officer who is trained in the use of the screening instrument.
5.29 If the screening indicates a need for a mental health assessment, the local social services
5.30 agency, in consultation with the child's family, shall have a diagnostic assessment
5.31 conducted, including a functional assessment, as defined in section 245.4871. If the
5.32 screening indicates a need for a chemical use assessment, the local social service agency,
5.33 in consultation with the child's family, shall have a chemical use assessment conducted, as
5.34 defined in section 254A.03, subdivision 3.

6.1 With the consent of the commissioner of corrections and agreement of the county to
6.2 pay the costs thereof, the court may, by order, place a minor coming within its jurisdiction
6.3 in an institution maintained by the commissioner for the detention, diagnosis, custody and
6.4 treatment of persons adjudicated to be delinquent or who received a stay of adjudication of
6.5 delinquency, in order that the condition of the minor be given due consideration in the
6.6 disposition of the case. Any funds received under the provisions of this subdivision shall
6.7 not cancel until the end of the fiscal year immediately following the fiscal year in which the
6.8 funds were received. The funds are available for use by the commissioner of corrections
6.9 during that period and are hereby appropriated annually to the commissioner of corrections
6.10 as reimbursement of the costs of providing these services to the juvenile courts.

6.11 Sec. 7. Minnesota Statutes 2008, section 260B.171, subdivision 5, is amended to read:

6.12 Subd. 5. **Peace officer records of children.** (a) Except for records relating to
6.13 an offense where proceedings are public under section 260B.163, subdivision 1, Peace
6.14 officers' records of children who are or may be delinquent or who may be engaged in
6.15 criminal acts shall be kept separate from records of persons 18 years of age or older
6.16 and are private data but shall be disseminated: (1) by order of the juvenile court, (2) as
6.17 required by section 121A.28, (3) as authorized under section 13.82, subdivision 2, (4) to
6.18 the child or the child's parent or guardian unless disclosure of a record would interfere
6.19 with an ongoing investigation, (5) to the Minnesota crime victims reparations board as
6.20 required by section 611A.56, subdivision 2, clause (6), for the purpose of processing
6.21 claims for crime victims reparations, or (6) as otherwise provided in this subdivision.
6.22 Except as provided in paragraph (c), no photographs of a child taken into custody may be
6.23 taken without the consent of the juvenile court unless the child is alleged to have violated
6.24 section 169A.20. Peace officers' records containing data about children who are victims
6.25 of crimes or witnesses to crimes must be administered consistent with section 13.82,
6.26 subdivisions 2, 3, 6, and 17. Any person violating any of the provisions of this subdivision
6.27 shall be guilty of a misdemeanor.

6.28 In the case of computerized records maintained about juveniles by peace officers,
6.29 the requirement of this subdivision that records about juveniles must be kept separate
6.30 from adult records does not mean that a law enforcement agency must keep its records
6.31 concerning juveniles on a separate computer system. Law enforcement agencies may keep
6.32 juvenile records on the same computer as adult records and may use a common index to
6.33 access both juvenile and adult records so long as the agency has in place procedures that
6.34 keep juvenile records in a separate place in computer storage and that comply with the
6.35 special data retention and other requirements associated with protecting data on juveniles.

7.1 (b) Nothing in this subdivision prohibits the exchange of information by law
7.2 enforcement agencies if the exchanged information is pertinent and necessary for law
7.3 enforcement purposes.

7.4 (c) A photograph may be taken of a child taken into custody pursuant to section
7.5 260B.175, subdivision 1, clause (b), provided that the photograph must be destroyed when
7.6 the child reaches the age of 19 years. The commissioner of corrections may photograph
7.7 juveniles whose legal custody is transferred to the commissioner. Photographs of juveniles
7.8 authorized by this paragraph may be used only for institution management purposes,
7.9 case supervision by parole agents, and to assist law enforcement agencies to apprehend
7.10 juvenile offenders. The commissioner shall maintain photographs of juveniles in the same
7.11 manner as juvenile court records and names under this section.

7.12 (d) Traffic investigation reports are open to inspection by a person who has sustained
7.13 physical harm or economic loss as a result of the traffic accident. Identifying information
7.14 on juveniles who are parties to traffic accidents may be disclosed as authorized under
7.15 section 13.82, subdivision 6, and accident reports required under section 169.09 may be
7.16 released under section 169.09, subdivision 13, unless the information would identify a
7.17 juvenile who was taken into custody or who is suspected of committing an offense that
7.18 would be a crime if committed by an adult, or would associate a juvenile with the offense,
7.19 and the offense is not an adult court traffic offense under section 260B.225.

7.20 (e) The head of a law enforcement agency or a person specifically given the duty
7.21 by the head of the law enforcement agency shall notify the superintendent or chief
7.22 administrative officer of a juvenile's school of an incident occurring within the agency's
7.23 jurisdiction if:

7.24 (1) the agency has probable cause to believe that the juvenile has committed an
7.25 offense that would be a crime if committed as an adult, that the victim of the offense is a
7.26 student or staff member of the school, and that notice to the school is reasonably necessary
7.27 for the protection of the victim; or

7.28 (2) the agency has probable cause to believe that the juvenile has committed an
7.29 offense described in subdivision 3, paragraph (a), clauses (1) to (3), that would be a crime
7.30 if committed by an adult, regardless of whether the victim is a student or staff member
7.31 of the school.

7.32 A law enforcement agency is not required to notify the school under this paragraph
7.33 if the agency determines that notice would jeopardize an ongoing investigation. For
7.34 purposes of this paragraph, "school" means a public or private elementary, middle,
7.35 secondary, or charter school.

8.1 (f) In any county in which the county attorney operates or authorizes the operation
8.2 of a juvenile prepetition or pretrial diversion program, a law enforcement agency or
8.3 county attorney's office may provide the juvenile diversion program with data concerning
8.4 a juvenile who is a participant in or is being considered for participation in the program.

8.5 (g) Upon request of a local social services agency, peace officer records of
8.6 children who are or may be delinquent or who may be engaged in criminal acts may be
8.7 disseminated to the agency to promote the best interests of the subject of the data.

8.8 (h) Upon written request, the prosecuting authority shall release investigative data
8.9 collected by a law enforcement agency to the victim of a criminal act or alleged criminal
8.10 act or to the victim's legal representative, except as otherwise provided by this paragraph.
8.11 Data shall not be released if:

8.12 (1) the release to the individual subject of the data would be prohibited under
8.13 section 13.821; or

8.14 (2) the prosecuting authority reasonably believes:

8.15 (i) that the release of that data will interfere with the investigation; or

8.16 (ii) that the request is prompted by a desire on the part of the requester to engage in
8.17 unlawful activities.

8.18 (i) A consent to the release of a peace officer record governed by this subdivision
8.19 from the individual who is the subject of the record is not effective and a law enforcement
8.20 agency must not release the record or release information in a manner that reveals the
8.21 existence of the record. This paragraph does not apply to the release of a record for
8.22 purposes of enlistment in military forces, as defined in section 190.05, subdivision 3.

8.23 Sec. 8. Minnesota Statutes 2008, section 260B.176, subdivision 2, is amended to read:

8.24 Subd. 2. **Reasons for detention.** (a) If the child is not released as provided in
8.25 subdivision 1, the person taking the child into custody shall notify the court as soon as
8.26 possible of the detention of the child and the reasons for detention.

8.27 (b) No child may be detained in a juvenile secure detention facility or shelter care
8.28 facility longer than 36 hours, excluding Saturdays, Sundays, and holidays, after being
8.29 taken into custody for a delinquent act as defined in section 260B.007, subdivision 6,
8.30 unless a petition has been filed and the judge or referee determines pursuant to section
8.31 260B.178 that the child shall remain in detention.

8.32 (c) No child may be detained in an adult jail or municipal lockup longer than 24
8.33 hours, excluding Saturdays, Sundays, and holidays, or longer than six hours in an adult
8.34 jail or municipal lockup in a standard metropolitan statistical area, after being taken into
8.35 custody for a delinquent act as defined in section 260B.007, subdivision 6, unless:

9.1 (1) a petition has been filed under section 260B.141; and

9.2 (2) a judge or referee has determined under section 260B.178 that the child shall
9.3 remain in detention.

9.4 After August 1, 1991, no child described in this paragraph may be detained in an
9.5 adult jail or municipal lockup longer than 24 hours, excluding Saturdays, Sundays, and
9.6 holidays, or longer than six hours in an adult jail or municipal lockup in a standard
9.7 metropolitan statistical area, unless the requirements of this paragraph have been met and,
9.8 in addition, a motion to refer the child for adult prosecution has been made under section
9.9 260B.125. Notwithstanding this paragraph, continued detention of a child in an adult
9.10 detention facility outside of a standard metropolitan statistical area county is permissible if:

9.11 (i) the facility in which the child is detained is located where conditions of distance
9.12 to be traveled or other ground transportation do not allow for court appearances within 24
9.13 hours. A delay not to exceed 48 hours may be made under this clause; or

9.14 (ii) the facility is located where conditions of safety exist. Time for an appearance
9.15 may be delayed until 24 hours after the time that conditions allow for reasonably safe
9.16 travel. "Conditions of safety" include adverse life-threatening weather conditions that do
9.17 not allow for reasonably safe travel.

9.18 The continued detention of a child under clause (i) or (ii) must be reported to the
9.19 commissioner of corrections.

9.20 (d) If a child described in paragraph (c) is to be detained in a jail beyond 24 hours,
9.21 excluding Saturdays, Sundays, and holidays, the judge or referee, in accordance with
9.22 rules and procedures established by the commissioner of corrections, shall notify the
9.23 commissioner of the place of the detention and the reasons therefor. The commissioner
9.24 shall thereupon assist the court in the relocation of the child in an appropriate juvenile
9.25 secure detention facility or approved jail within the county or elsewhere in the state, or in
9.26 determining suitable alternatives. The commissioner shall direct that a child detained in a
9.27 jail be detained after eight days from and including the date of the original detention order
9.28 in an approved juvenile secure detention facility with the approval of the administrative
9.29 authority of the facility. If the court refers the matter to the prosecuting authority pursuant
9.30 to section 260B.125, notice to the commissioner shall not be required.

9.31 (e) When a child is detained for an alleged delinquent act in a state licensed juvenile
9.32 facility or program, or when a child is detained in an adult jail or municipal lockup as
9.33 provided in paragraph (c), the supervisor of the facility shall, if the child's parent or legal
9.34 guardian consents, have a children's mental health screening conducted with a screening
9.35 instrument approved by the commissioner of human services, unless a screening has been
9.36 performed within the previous 180 days or the child is currently under the care of a mental

10.1 health professional. The screening shall be conducted by a mental health practitioner
10.2 as defined in section 245.4871, subdivision 26, or a probation officer who is trained in
10.3 the use of the screening instrument. The screening shall be conducted after the initial
10.4 detention hearing has been held and the court has ordered the child continued in detention.
10.5 The results of the screening may only be presented to the court at the dispositional phase
10.6 of the court proceedings on the matter unless the parent or legal guardian consents to
10.7 presentation at a different time. If the screening indicates a need for assessment, the
10.8 local social services agency or probation officer, with the approval of the child's parent
10.9 or legal guardian, shall have a diagnostic assessment conducted, including a functional
10.10 assessment, as defined in section 245.4871.

10.11 (f) When a child is detained for an alleged delinquent act in a state licensed juvenile
10.12 facility or program, or when a child is detained in an adult jail or municipal lockup as
10.13 provided in paragraph (c), the supervisor of the facility shall, if the child's parent or legal
10.14 guardian consents, have a chemical use screen conducted with a screening instrument
10.15 approved by the commissioner of human services, unless a screening has been performed
10.16 within the previous 180 days or the child is currently under the care of a licensed alcohol
10.17 and drug counselor. The screening shall be conducted by a mental health practitioner as
10.18 defined in section 245.4871, subdivision 26, or a probation officer who is trained in the use
10.19 of the screening instrument. The screening shall be conducted after the initial detention
10.20 hearing has been held and the court has ordered the child continued in detention.

10.21 Sec. 9. Minnesota Statutes 2008, section 260B.198, subdivision 7, is amended to read:

10.22 Subd. 7. **Continuance.** When it is in the best interests of the child and public safety
10.23 to do so and when the child has admitted the allegations contained in the petition before
10.24 the judge or referee, or when a hearing has been held as provided for in section 260B.163
10.25 and the allegations contained in the petition have been duly proven but, in either case,
10.26 before a finding of delinquency has been entered, the court may stay the adjudication of
10.27 delinquency and continue the case for a period not to exceed ~~90~~ 180 days on any one
10.28 order. With the consent of the prosecutor, such a continuance may be extended renewed
10.29 for one additional successive a period not to exceed 90 days extend beyond the child's
10.30 19th birthday and only after the court has reviewed the case and entered its order for an
10.31 additional continuance without a finding of delinquency. During ~~this~~ either continuance
10.32 the court may enter an order in accordance with the provisions of subdivision 1, ~~clause (1)~~
10.33 ~~or (2)~~; or enter an order to hold the child in detention for a period not to exceed 15 days on
10.34 any one order for the purpose of completing any consideration, or any investigation or
10.35 examination ordered in accordance with the provisions of section 260B.157. The court

11.1 shall not stay adjudication on any felony offense if the child has previously received a
11.2 stay of adjudication of delinquency by a court in any judicial district. This subdivision
11.3 does not apply to an extended jurisdiction juvenile proceeding. In calculating an adult
11.4 criminal history score, a stay of adjudication for a felony-level offense ordered by the

21.13 (b) When a person, including a person under the jurisdiction of the juvenile court, is
21.14 charged with committing a crime of violence and is placed in a pretrial diversion program
21.15 by the court before disposition, the court shall inform the defendant that: (1) the defendant
21.16 is prohibited from possessing a pistol or semiautomatic military-style assault weapon
21.17 until the person has completed the diversion program and the charge of committing a
21.18 crime of violence has been dismissed; (2) it is a gross misdemeanor offense to violate this
21.19 prohibition; and (3) if the defendant violates this condition of participation in the diversion
21.20 program, the charge of committing a crime of violence may be prosecuted. The failure of
21.21 the court to provide this information to a defendant does not affect the applicability of the
21.22 pistol or semiautomatic military-style assault weapon possession prohibition or the gross
21.23 misdemeanor penalty to that defendant.

21.24 Sec. 23. **REVISOR INSTRUCTION; TABLE OF JUVENILE COLLATERAL**
21.25 **SANCTIONS.**

21.26 (a) The revisor of statutes shall publish a table in Minnesota Statutes that contains
21.27 cross-references to state laws that are collateral sanctions imposed on a juvenile as a result
21.28 of an adjudication of delinquency. The revisor shall create a structure that categorizes
21.29 these laws in a useful way to users.

21.30 (b) The revisor shall include appropriate cautionary language with the table,
21.31 including, at a minimum, language that notifies users that:

21.32 (1) the list of collateral sanctions laws is intended to be comprehensive but is not
21.33 necessarily complete;

22.1 (2) the inclusion or exclusion of a collateral sanction is not intended to have any
22.2 substantive legal effect; and

22.3 (3) users must consult the language of each cross-referenced law to fully understand
22.4 the scope and effect of the collateral sanction it imposes.

22.5 (c) The revisor shall consult with legislative staff and the chairs of the senate and
22.6 house committees having jurisdiction over criminal justice to identify laws that impose
22.7 collateral sanctions on a juvenile who has been adjudicated delinquent.
