1.18	"Section 1. Minnesota Statutes 2016, section 3.8841, subdivision 9, is amended to read:
1.19	Subd. 9. Powers; duties; Metropolitan Council appointments oversight. The
1.20	commission must monitor appointments to the Metropolitan Council and may make
1.21	recommendations on appointments to the nominating committee under section 473.123,
1.22	subdivision 3, or to the governor before the governor makes the appointments to the
1.23	appropriate appointing authority as described in section 473.123. The commission may also
1.24	make recommendations to the senate before appointments are presented the governor's
1.25	appointment is presented to the senate for its advice and consent.

- Sec. 2. Minnesota Statutes 2017 Supplement, section 15A.0815, subdivision 3, is amended 2.1 to read: 2.2 Subd. 3. Group II salary limits. It shall be under the supervision and control of 17 a chair appointed as provided 2.23 in subdivision 4, and 28 members, all of whom shall be residents of the metropolitan area-2.24 2.25 and who shall be appointed as follows: (1) a county commissioner from each of Anoka, Carver, Dakota, Ramsey, Scott, and 2.26 2.27 Washington Counties, appointed by the respective county boards; (2) two county commissioners from Hennepin County appointed by the county board, 2.28 one of whom must represent a ward that is predominantly located within the city of 2.29

The governing body of each 4.16 home rule charter or statutory city and town in each Metropolitan Council district shall 4.17 appoint a member to serve on a municipal committee for the council district. If a city or 4.18 town is in more than one council district, the governing body must appoint a member to 4.19 serve on each council district's municipal committee. A member appointed to a council 4.20 district's municipal committee must reside in the council district. The municipal committee 4.21 must meet at least quarterly to discuss issues relating to the Metropolitan Council. Municipal 4.22 committee meetings are subject to the Minnesota Open Meeting Law, chapter 13D. 4.23

4.24 Subd. 3. Membership; appointment; qualifications <u>Compensation</u>. (a) Sixteen
4.25 members must be appointed by the governor from districts defined by this section. Each
4.26 council member must reside in the council district represented. Each council district must
4.27 be represented by one member of the council. In addition to any compensation as a local
4.28 elected official, the council shall pay each member of the council other than the chair at the
4.29 rate of \$55 a day spent on council activities authorized by the council.

4.30 (b) In addition to the notice required by section 15.0597, subdivision 4, notice of

(c) The governor shall create a nominating committee, composed of seven metropolitan 5.5 citizens appointed by the governor, to nominate persons for appointment to the council from 5.6 districts. Three of the committee members must be local elected officials. The governor is not 5.15 required to appoint from the list. 5.16 (d) Before making an appointment, the governor shall consult with all members of the 5.17

 5.18 legislature from the council district for which the member is to be appointed.

5.19 (e) Appointments to the council are subject to the advice and consent of the senate as
5.20 provided in section 15.066.

5.21 (f) Members of the council must be appointed to reflect fairly the various demographic,
5.22 political, and other interests in the metropolitan area and the districts.

5.23 (g) Members of the council must be persons knowledgeable about urban and metropolitan
5.24 affairs.

5.25 (h) Any vacancy in the office of a council member shall immediately be filled for the
5.26 unexpired term. In filling a vacancy, the governor may forgo the requirements of paragraph
5.27 (c) if the governor has made appointments in full compliance with the requirements of this
5.28 subdivision within the preceding 12 months.

Subd. 3a. Redistricting. The legislature shall redraw the boundaries of the council
districts after each decennial federal census so that each district has substantially equal
population. Redistricting is effective in the year ending in the numeral "3." Within 60 days
after a redistricting plan takes effect, the <u>governor municipal committees</u> shall appoint
members from the newly drawn districts to serve terms as provided under subdivision 2a.

6.1 Subd. 3e. District boundaries. Metropolitan Council plan MC2013-1A, on file with
6.2 the Geographical Information Systems Office of the Legislative Coordinating Commission
6.3 and published on its Web site on April 9, 2013, is adopted and constitutes the redistricting
6.4 plan required by subdivision 3a. The boundaries of each Metropolitan Council district are
6.5 as described in that plan.

Subd. 4. Chair; appointment, officers, selection; duties and compensation. (a) The
chair of the Metropolitan Council shall be appointed by the governor as the 17th 29th voting
member thereof by and with the advice and consent of the senate to serve at the pleasure
of the governor to represent the metropolitan area at large. Senate confirmation shall be as
