BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2018, section 222.49, is amended to read:

222.49 RAIL SERVICE IMPROVEMENT ACCOUNTS; APPROPRIATION TRANSFERS.

- (a) A rail service improvement account is created in the special revenue fund in the state treasury. The account consists of funds as provided by law, and any other money donated, allotted, transferred, or otherwise provided to the account, excluding bond proceeds as authorized by article XI, section 5, clause (i), of the Minnesota Constitution. All money so deposited is appropriated to the department for expenditure for rail service improvement in accordance with applicable state and federal law. This appropriation shall not lapse but shall be available until the purpose for which it was appropriated has been accomplished. Annually by June 30, the commissioner of transportation must transfer the entire unencumbered balance in the rail service improvement account in the special revenue fund to the rail infrastructure account in the special revenue fund.
- (b) A rail service improvement account is created in the bond proceeds fund. The account consists of state bond proceeds appropriated to the commissioner. Money in the account may only be expended for the purposes specified in section 222.50 that are permitted under the Minnesota Constitution, article XI, section 5, clause (a) or (i).

- Subd. 7. **Expenditures.** (a) The commissioner may expend money from the rail service improvement account for the following purposes:
- (1) to make transfers as provided under section 222.57 or to pay interest adjustments on loans guaranteed under the state rail user and rail carrier loan guarantee program;
- 2.7 (2) to pay a portion of the costs of capital improvement projects designed to improve rail service of a rail user or a rail carrier;
- 2.9 (3) to pay a portion of the costs of rehabilitation projects designed to improve rail service 2.10 of a rail user or a rail carrier;
- 2.11 (4) to acquire, maintain, manage, and dispose of railroad right-of-way pursuant to the state rail bank program;
- (5) to provide for aerial photography survey of proposed and abandoned railroad tracks
 for the purpose of recording and reestablishing by analytical triangulation the existing
 alignment of the inplace track;
 - (6) to pay a portion of the costs of acquiring a rail line by a regional railroad authority established pursuant to chapter 398A;
- 2.18 (7) to pay the state matching portion of federal grants for rail-highway grade crossing improvement projects;
- (8) for expenditures made before July 1, 2017, to pay the state matching portion of grants
 under the federal Transportation Investment Generating Economic Recovery (TIGER)
 program of the United States Department of Transportation;
- (9) (8) to fund rail planning studies; and
- 2.24 (10) (9) to pay a portion of the costs of capital improvement projects designed to improve capacity or safety at rail yards.
- 2.26 (b) All money derived by the commissioner from the disposition of railroad right-of-way
 2.27 or of any other property acquired pursuant to sections 222.46 to 222.62 shall be deposited
 2.28 in the rail service improvement account.

Subdivision 1. **Definition.** For purposes of this section, "program" means the rail infrastructure and economic development program established in this section.

- Subd. 2. **Program established.** The commissioners of transportation and employment and economic development must jointly establish a rail infrastructure and economic development program as provided in this section.
- Subd. 3. Rail infrastructure account; appropriation. (a) A rail infrastructure account is established in the special revenue fund. The account consists of funds as provided in paragraph (b) and in sections 222.49 and 222.63, subdivision 8, and any other money donated, allotted, transferred, or otherwise provided to the account. The account must not include any bond proceeds authorized by the Minnesota Constitution, article XI, section 5, clause (i).
- (b) All funds made available to the commissioner from the disposition of railroad right-of-way or of any other property acquired pursuant to sections 222.46 to 222.62 must be deposited in the rail infrastructure account.
- (c) Funds in the account are annually appropriated to the commissioner of transportation for financial assistance awards under this section. The commissioners of transportation and employment and economic development are prohibited from expending funds from the account for administrative costs.
- Subd. 4. **Program administration.** (a) The commissioners of transportation and employment and economic development must establish a project selection process for financial assistance under the program, in consultation with interested stakeholders who are eligible under subdivision 5 to receive financial assistance. The process must include public notice of available funds, procedures to submit applications, publicly available information on project evaluation and selection as provided in this section, and financial assistance awards. The commissioners must ensure that the process minimizes applicant burdens.
- (b) The commissioners must maintain on an ongoing basis a project requests list that identifies all eligible projects that have been evaluated for financial assistance under the program.
- (c) An applicant must apply for financial assistance in the manner and at the times determined by the commissioners.

Funds received by the commissioner of transportation from interest earnings, administrative payments, rentals, fees, or charges for the use of rail bank property, or received from rail line rehabilitation contracts shall be are credited to the rail bank maintenance account and used for the maintenance of that property and held as a reserve for maintenance expenses in an amount determined by the commissioner, and. Amounts received in the rail bank maintenance account in excess of the reserve requirements shall must be transferred to the rail service improvement infrastructure account under section 222.505, subdivision 3.
- (b) All proceeds of the sale of abandoned rail lines shall must be deposited in the rail service improvement infrastructure account.
- (c) All money to be deposited in this the rail service improvement bank maintenance account as provided in this subdivision is appropriated to the commissioner of transportation for the purposes of this section. The appropriations shall do not lapse but shall be and are available until the purposes for which the funds are appropriated are accomplished.
