- 1.12 (b) The study and analysis must address:
- 1.13 (1) current and projected economic, fiscal, and demographic effects and issues;
- 1.14 (2) direct and indirect costs and benefits;
- 1.15 (3) positive and negative effects; and
- 1.16 (4) economic challenges and opportunities for economic growth or diversification.
- 1.17 (c) The study must be objective, evidence-based, and designed to produce empirical
- 1.18 data. Study data must be utilized to formulate policy recommendations on how the state,
- 1.19 the northwestern region of the state, and border cities may respond to the challenges and
- 1.20 opportunities for economic growth and financial investment that may be derived from the
