STILLWATER SCHOOL DISTRICT ELECTION DISTRICTS. 1.5 Subdivision 1. Election. The school board of Independent School District No. 834, 1.6 Stillwater, must divide the school district into five single-member election districts, from 1.7 which one board member each must be elected. Two additional members must be elected 1.8 1.9 at large. Subd. 2. **Board elections.** The board must specify the election districts from which 1.10 vacancies shall be filled as they occur until five board members represent an election district. 1.11 A candidate for school board in a subsequent election must file an affidavit of candidacy 1.12 to be elected as a school board member for the election district in which the candidate 1.13 resides, unless the candidate is filing for one of the at-large seats. Each board member who 1 14 files for election from an election district must be a resident of that district but the creation 1.15 of an election district or a change in election district boundaries does not disqualify a board 1.16 member from serving for the remainder of a term. 1.17 Subd. 3.
